#### Planning and Environment Act 1987 FLINDERS PLANNING SCHEME Notice of Approval of Amendment Amendment L160

The Minister for Planning and Local Government has approved Amendment L160 to the Flinders Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment changes the planning provisions which apply for the Portsea Village Resort at 3765 Point Nepean Road, Portsea to:

- \* enable an application for planning permit to be made for a conference centre
- \* enable the recreation facilities to be used by those attending conferences
- \* increase the seating capacity of the restaurant to not more than 100 persons
- \* allow the general public to use the restaurant and lounge bar.
