Forests Act 1958 DECLARATION OF PROHIBITED PERIODS

In pursuance of the powers conferred by section 3 subsection (2) of the Forests Act 1958, I, Gary Morgan, delegated officer for Her Majesty's Minister for Conservation and Land Management in the State of Victoria, hereby declare the Prohibited Period in respect to the fire protected areas (other than State Forest, National Park and Protected Public Land) within the municipalities nominated for the period specified in the schedules hereunder:

SCHEDULE 1

The Prohibited Period shall commence at 0100 hours on Monday 17 November 1997 and end at 0100 hours on Wednesday 1 May 1998 (unless varied) in the following municipality:

Crown Land (Reserves) Act 1978 ORDER GIVING APPROVAL TO GRANT OF LEASE

Under sections 17D and 17DA of the Crown Land (Reserves) Act 1978 I, Marie Tehan, Minister for Conservation and Land Management, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the Crown Land (Reserves) Act 1978, approve the granting of a lease for the purpose of a restaurant and catered functions by the Heide Park and Art Gallery Company Limited Committee of Management to Leybourne Pty Ltd, over part of the Heide Park and Art Gallery Reserve described in the Schedule below and, in accordance with section 17D(3)(a) of the Crown Land (Reserves) Act 1978, state that—

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the Crown Land (Reserves) Act 1978.


