NOTICE OF DECISION

Wildlife (Amendment) Regulations 1997

I, Marie Tehan, Minister for Conservation and Land Management and Minister responsible for administering the **Wildlife Act 1975**, under section 12 of the **Subordinate Legislation Act 1994**, give notice as follows—

A Regulatory Impact Statement was prepared in relation to the proposed Wildlife (Amendment) Regulations 1997 and advertised inviting public comment as required by the **Subordinate Legislation Act**. The public comment period closed on 11 July 1997, by which time 59 submissions had been received. Following consideration of these submissions, I have decided that the proposed Regulations be made with the following minor amendments.

The Red-eyed Tree Frog, the Orange Thighed Tree Frog, the Roth's Tree Frog and the Northern Dwarf Tree Frog will be added to Schedule 3 (Part B) of the Wildlife Regulations 1992. Other very minor amendments have also been made to the Regulations to correct scientific names and to clarify the intention of some regulations.
