Crown Land (Reserves) Act 1978 AMENDMENT OF REGULATIONS Public Recreation Reserve, Township of Epping

Title

1. These regulations may be cited as the Public Recreation Reserve, Township of Epping (Amendment) Regulations 1997.

Principle Regulations

2. The Principle Regulations are the Public Recreation Reserve, Township of Epping Regulations made on 27 March 1984 and published in the Government Gazette on 4 April 1984, for and with respect to the Crown land in the Township of Epping, Parish of Wollert temporarily reserved for Cricket and Other Purposes of Public Recreation by Orders in Council of 25 June 1877, 30 October 1951 and 23 October 1962 (vide Government Gazettes of 29 June 1877, 7 November 1951 and 31 October 1962) together with the land in the said Township temporarily reserved for Public Recreation by Order in Council of 1 July 1980 (vide Government Gazette of 9 July 1980).

Authorising Provisions

3. These Regulations are made under Section 13 of the Crown Land (Reserves) Act 1978.

Commencement

4. These Regulations come into effect on the date they are published in the Government Gazette

Amendment to the Principle Regulations

5. The Principle Regulations are amended as follows:

For regulation 1 of the Principle Regulations, substitute—

1 (1) The Reserve shall be open to the public between the sunrise and sunset, free of charge, excepting on such days (not exceeding 75 in any one year) as the Reserve, or portions of the Reserve, may be set

- apart for special events such as cricket or football matches, fetes, concerts, sports or holiday amusements.
- (2) While a special event as provided for in sub regulation (1) is being held and is open to the public-
 - (i) the Committee; or
 - (ii) the persons or organisations responsible for mounting and holding the special event, with the consent of the Committee may determine, make and collect a daily charge for entry into the special event.
