Office of the Regulator-General Act 1994 NOTICE OF DETERMINATION UNDER SECTION 26 OF THE OFFICE OF THE REGULATOR-GENERAL ACT 1994

On 24 February 1997 the Office of the Regulator-General ("the Office") made a determination under section 26 of the **Office of the Regulator-General Act 1994**.

Office of the Regulator-General Act 1994 NOTICE OF AMENDMENT TO VICPOOL RULES

On 24 February 1997, the Office of the Regulator-General ("the Office") amended the pool rules known as the VicPool Rules that apply to Victoria's electricity industry to allow for the introduction of de-averaged distribution loss factors in respect of non-franchise customers which acquire electricity from a retailer other than the retail arm of their host distribution business.

The de-averaged distribution loss factors—

- * differentiate between (lower) short line and (higher) long line loss factors in a distribution business' distribution network;
- * represent a move to more accurate reflection of the cost in supplying individual customers; and

- * provide more efficient economic signals for investment and consumption decisions.

Doubt existed about the validity and effect of the determination made by the Office on 28 October 1996 and recorded in the "Notice of Determination" published in the Victoria Government Gazette on Friday 1 November 1996 and the The Age newspaper on 30 October 1996. This doubt led to the making of the amendment.

Planning and Environment Act 1987 FLINDERS PLANNING SCHEME Notice of Approval of Amendment Amendment L162

The Minister for Planning and Local Government has approved Amendment L162 to the Flinders Planning Scheme.

The amendment affects the extent of the planning controls which affect 'Ilyuka' 2-8 and 14-16 Port King Road Portsea by including both Ilyuka and the Lime Kiln as historic sites.
