Planning and Environment Act 1987 WERRIBEE PLANNING SCHEME Notice of Approval of Amendment Amendment L94

The Minister for Planning and Local Government has approved Amendment L94 to the Werribee Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment rezones approximately 13 hectares of land from Werribee Urban Development to the State Section Business 1 Zone with Local Section floor space limitations and applies to land on the south east corner of Leakes Road and Derrimut Road, Werribee. A local provision requires above 12,000 square metres of retail floor space, above 10,000 square metres of restricted retail premises (peripheral sales) and any office floor space to be subject to a planning permit.

A copy of the amendment can be inspected, free of charge, during office hours, at the Department of Infrastructure, Ground Floor, 477 Collins Street Melbourne and at the offices of the Wyndham City Council, Civic Centre, 45 Princess Highway, Werribee.

The Minister for Planning and Local Government has approved Amendment L93 to the Werribee Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment rezones approximately 13.6 hectares of land from Werribee Urban Development to the State Section Business 1 Zone with Local Section floor space limitations and applies to land on the south west side of Ballan Road, Werribee. The site is located at its northern point adjacent to the intersection of Ballan Road and Hobbs Road, Werribee. A local provision requires above 12,000 square metres of retail floor space, above 10,000 square metres of restricted retail premises (peripheral sales) and above 10,000 square metres of office floor space to be subject to a planning permit.

A copy of the amendment can be inspected, free of charge, during office hours, at the Department of Infrastructure, Ground Floor, 477 Collins Street Melbourne and at the offices of the Wyndham City Council, Civic Centre, 45 Princess Highway, Werribee.
