Wildlife (Game) Regulations 1990

NOTIFICATION OF LOCATIONS AND OPENING TIMES OF CHECKING STATIONS FOR HOG DEER

Under regulation 40(2) of the Wildlife (Game) Regulations 1990, the Secretary to the Department of Natural Resources and Environment gives notice that the places specified in the Schedule below have been nominated as checking stations for the purpose of recording biological, physical and other information about Hog Deer taken by hunters during the open season. The checking stations are located at the addresses specified in the Schedule.

At the checking stations, hunters will be required to provide the jawbone from each Hog Deer carcass for the purpose of examination for any disease or disorder.
