#### Melbourne City Link Act 1995 REVOCATION OF PARTS OF RESERVATION

The Governor in Council, on the recommendation of the Minister for Planning and Local Government (being the Minister administering the Melbourne City Link Act 1995), under section 29(2) of the Melbourne City Link Act 1995 revokes:

- (a) the Order in Council of 13 October 1873 (vide Government Gazette 14 2004) November 1873, page permanently reserving land Richmond as a Site for Public Park and Recreation; and
- (b) the Crown Grant Volume 1902 Folio 326,

in so far as the Order and Crown Grant relate to the land shown hatched on plans numbered LEGL./97-23 and LEGL./97-72 lodged in the Central Plan Office.
