The Minister for Planning and Local Government has approved Amendment L188 to the Melbourne Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment changes the provisions of the Melbourne Planning Scheme in relation to the site at Nos. 3-9 Riverside Quay, South Melbourne. The changes allow for a modified development of the site at 3-9 Riverside Quay, incorporating additional land along City Road and variations to the building form.
