Subordinate Legislation Act 1994 PROPOSED CO-OPERATIVES REGULATIONS 1997

Following extensive consultation with the Commonwealth Government and the governments of all States and Territories, the **Co-operatives Act 1996** ("the Act") was introduced and passed in the Victorian Parliament in November 1996. The Act is being used by most States and Territories as a basis for consistent co-operatives legislation throughout Australia. The proposed Co-operatives Regulations 1997 ("the proposed Regulations") are also intended to form part of the consistent co-operatives legislative scheme.

The objective of the proposed Regulations is to prescribe, for the purposes of the Act:

- * fees and maximum fines payable under the Act;
- * forms and procedures required by the Act;
- * accounting and audit requirements for co-operatives;
- * the form and content of registers required to be kept by co-operatives;
- * the procedure to be followed when conducting a postal ballot; and
- * other matters that are necessary or convenient for carrying out or giving effect to the Act.

A Regulatory Impact Statement (RIS) has been prepared for the proposed Regulations. It considers a draft of the proposed Regulations and alternatives to them. It concludes that the objectives of the legislative scheme are best met by the current form of the proposed Regulations.
