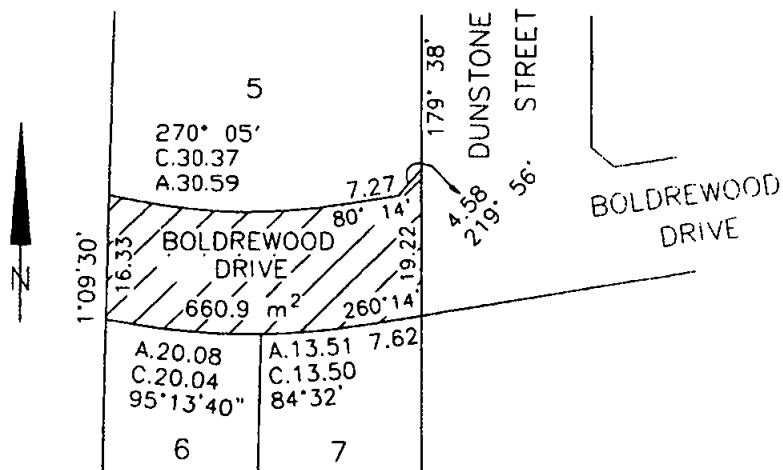

**Election of Mayor and Chairpersons of Committees**

The Local Law establishes procedures for election of the Mayor by the Councillors. A corresponding procedure is to apply for election of Chairpersons of Special Committees.

**Quorum**

The quorum for meetings of Council is to be the majority of the number of Councillors capable of being elected. The quorum for meetings of a Special Committee is to be a majority of members or as otherwise resolved by Council.

**Business of Meetings**

No business is to be conducted at meetings of Council or of a Special Committee unless notice has been given (in the agenda, a report accompanying the agenda or in a notice of motion) or it is considered to be urgent business.

**Adjournments and Lapsing of Meetings**

The Local Law sets out circumstances in which meetings are to be adjourned, temporarily or for a period of up to seven days, and deals with related issues (including the passing of a motion of adjournment and failure to maintain a quorum). If a meeting of Council lapses, the undisposed business is to be included on the agenda for the next ordinary meeting.

**Distribution of Agenda**

The Local Law provides for distribution of the agenda for meetings, ordinarily to be not less than four days before meetings.

**Order of Business**

An order of business is set out, to apply unless otherwise resolved.

**Minutes**

Minutes of meetings are to be confirmed, and once confirmed signed by the Chairperson.

**Procedures**

Except as otherwise provided, the conduct of meetings is at the discretion of the Council or the Special Committee respectively.

The Local Law provides in detail, for the procedure to apply for motions, amendments, conduct of debate, voting and points of order including:

- the procedure for moving, seconding and dealing with motions as well as the form of motions;
- the procedure for debate on motions and for amendments to be dealt with;



- the procedure for voting on motions—a Councillor is to be authorised to call a division. If this occurs, the names of the Councillors or members of the Special Committee, and whether they are voted for or against, are to be recorded;
- requirements about the form and giving of notices of motion. Notices of motion are to be entered in a Notice of Motion Book, and are to be moved in the order of entry in that book. Once lodged they cannot be withdrawn.

#### Declaration of Interest

Details relating to declarations of pecuniary interest are to be recorded.

#### Demand for Production of Documents

Any Councillor or member of a Special Committee is to be authorised to demand production of documents of the municipality applying to the matter under discussion.

#### Correspondence and Petitions

Copies of letters written at the direction of Council or a Special Committee are to be available for perusal by Councillors or members of the Committee. Restrictions apply to reading correspondence to the meeting. Except in cases of urgency, a motion relating to a petition (other than to receive it) must not be made until the next ordinary meeting after it has been presented.

#### Revocation or Alteration of Resolutions

A notice of motion to revoke or alter a previous resolution is to be signed by three Councillors or Special Committee members, must be given to the Chief Executive Officer in time for seven clear days' notice to be given, and will be deemed to be withdrawn if not moved at the next meeting. A restriction will apply to the moving of a second or subsequent revocation or alteration motion.

#### Offences

Offences are created relating to meetings, including:

- acting contrary to a provision of the proposed Local Law;
- misbehaviour by Councillors or members of a Special Committee;
- (for other persons) behaving in a manner considered by Council or the Special Committee to be improper or

disorderly and failing to leave the meeting when requested by the Chairperson to do so;

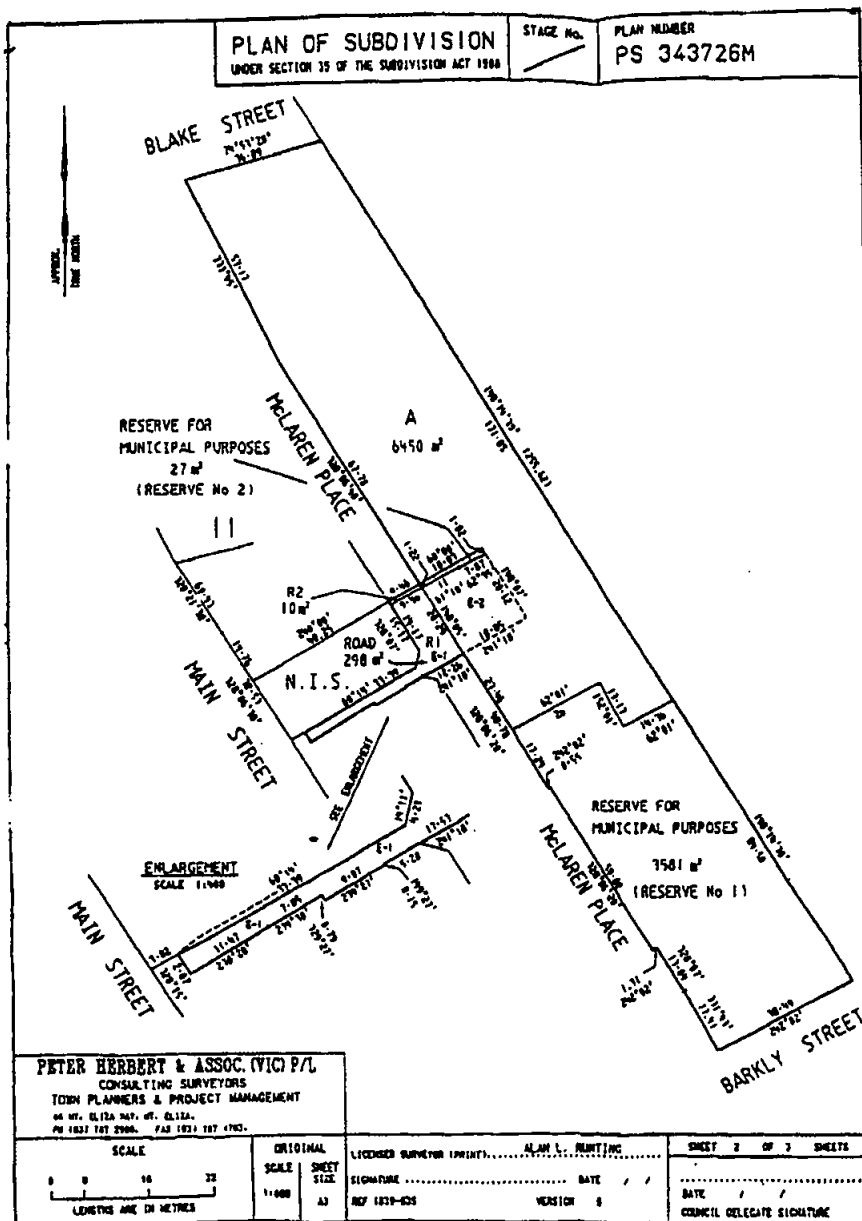

- The support needs of many women may not be met by a male worker, regardless of their competence.
- Young people do not trust easily and some of the young women FYHG support may have a greater reason not to trust men.

- Further, the cultural background of some young women may limit the support a male worker could provide.
