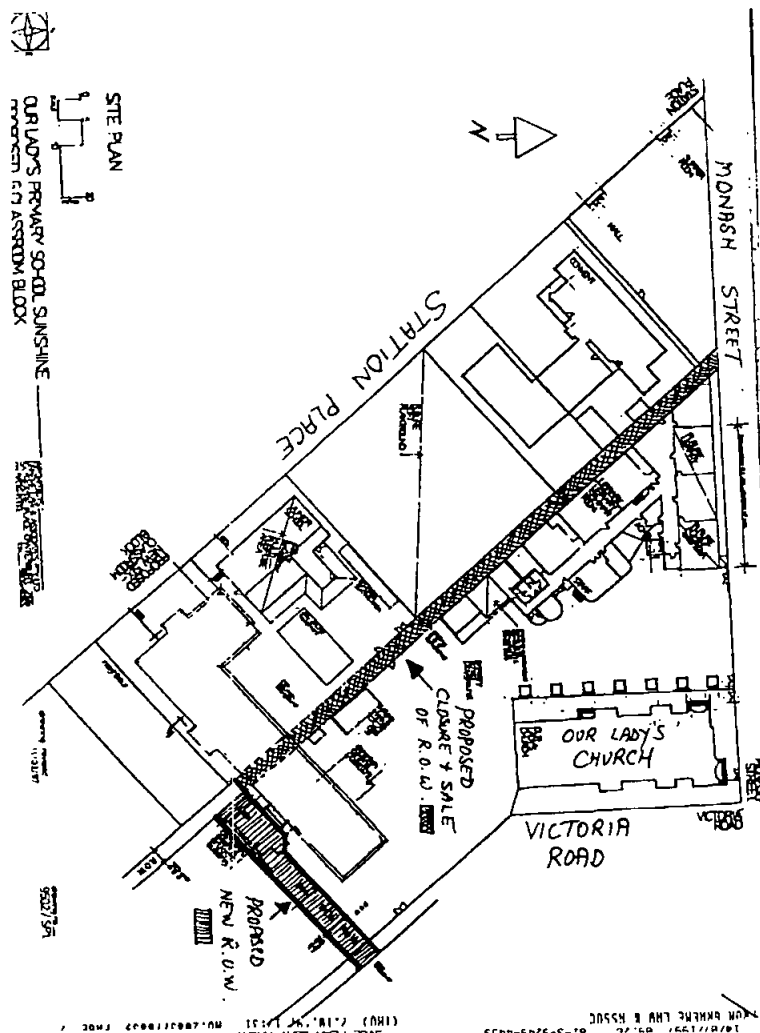

ROAD CLOSURE DIAGRAM

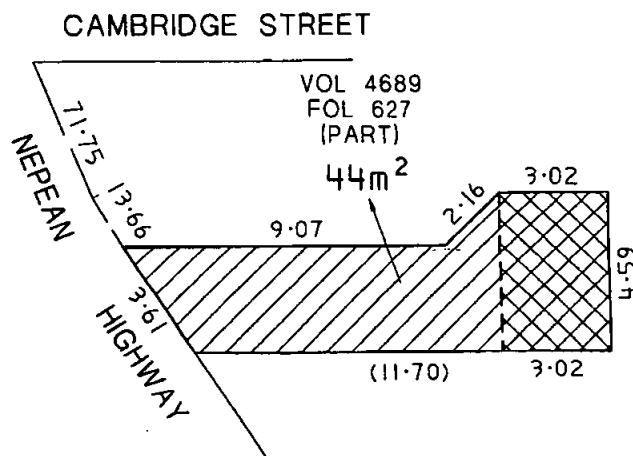

**TRARALGON WATER MANAGEMENT  
SCHEME**

I, Patrick John McNamara, Deputy Premier and Minister for Agriculture and Resources, have agreed that an investigation in relation to water management be carried out for Traralgon, and that a community-based committee be appointed under Section 214 of the **Water Act 1989**.

The town of Traralgon has a long history of flooding. Over the past 19 years extensive flood damage has occurred on three occasions in June 1978, September 1993 and November 1995. The La Trobe Shire Council has recently engaged consultants to carry out a floodplain management study, which is jointly funded by Commonwealth, State and Local Government.

The study area encompasses the Traralgon Creek floodplain through Traralgon extending from approximately 1 km upstream of Shakespeare Street down to the La Trobe River junction approximately 2 km downstream of Davidson Street.

The main study outcomes will include an assessment of flood behaviour, a flood damages assessment, a comprehensive floodplain management plan which will include both structural and non-structural measures, and a comprehensive set of flood inundation maps.

A community-based committee will coordinate the preparation of a floodplain management plan for Traralgon in accordance

with current floodplain management policy and practice guidelines, and will provide a forum for consultation throughout the study.

The committee will be made up of affected landowners in the study area and relevant public statutory bodies. All relevant interests (including environmental interests) will, as far as possible, be fairly represented on the committee. Expressions of interest for landowner representatives will be advertised in local newspapers and will be assessed by the La Trobe Shire Council.

When the investigation has been completed, the committee will prepare a water management scheme for public exhibition and comment under Section 215 of the **Water Act 1989**.

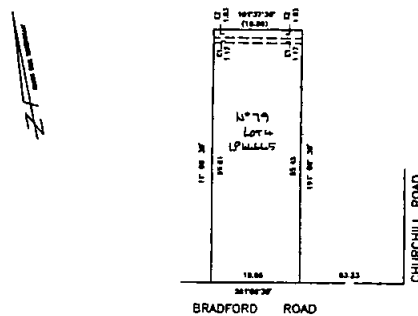

PROPOSED CHATTEL SECURITIES  
REGULATIONS 1997**

When money is borrowed, the borrower sometimes guarantees payment. This is done by giving the lender a right over something owned by the borrower. This right is called a "security interest" in the goods. If the loan is repaid, the lender's interest in the goods is cancelled. If it is not repaid, the lender usually takes the goods.

The **Chattel Securities Act 1987** covers certain goods, particularly motor vehicles, cycles and trailers. It allows lenders to register their security interest in relevant goods in a Vehicle Securities Register ("VSR") held by the Roads Corporation ("VicRoads"). The VSR is available for searching to see whether a lender has a security interest in a particular vehicle. In summary, it protects a person buying a vehicle against repossession because of someone else's debt. The proposed Chattel Securities Regulations 1997 are to—

- Increase the purchase price amount for goods to which the law applies;
- Specify what information must be provided to VicRoads for the VSR;
- Set fees for certificates about VSR entries;
- Prescribe a form for lenders to use in cancelling registration of a security interest.

A Regulatory Impact Statement (RIS) has been prepared for the proposed regulations. It considers the draft regulations and alternatives. It concludes that the objectives are best met by the proposed regulations. Legal Practice (Fees) Regulations 1997**

A Regulatory Impact Statement has been prepared in relation to the proposed fee structure for practising certificates.

The major objective of the proposed Regulations is to ensure that legal practitioners make an equitable contribution to the reasonable costs incurred by the recognised professional associations in regulating the legal profession.

The proposed Regulations replace the current fee structure which is set out in Clause 10 (7) of Schedule 2 to the **Legal Practice Act 1996**. The proposed fee structure is as follows:

- for a practising certificate authorising the receipt of trust money—\$320;
- for a practising certificate not authorising the receipt of trust money—
  - if the applicant is a current practitioner—\$200;
  - if the applicant is not a current practitioner—\$160.

The proposed fees represent a reduction on the fees imposed in 1997 under the Act.

**Regulations 1997**

Notice is given in accordance with Section 11 of the **Subordinate Legislation Act 1994**, that a Regulatory Impact Statement has been prepared in relation to the Credit (Administration) (Credit Tribunal) Regulations 1997.

The Credit (Administration) (Credit Tribunal) Regulations 1997 would introduce a new scale of fees for applications to the Credit Tribunal relating to specified sections of the **Credit Act 1984** and the **Consumer Credit (Victoria) Act 1995**. The proposed new rule would also introduce a fee for the issuing of a summons before the Tribunal and for the recognition of a civil penalty order determined in another jurisdiction under the corresponding provision in that State or Territory.

A comparable fee scale to that for NSW is proposed, for both applications relating to the **Credit Act 1984** and the **Consumer Credit (Victoria) Code**. The proposed fee scale has three steps or fee levels, with the fee payable depending upon the section of the legislation under which the application is made. A fee of \$25.00 is proposed for interlocutory process and for interstate orders.

A Regulatory Impact Statement (RIS) is required for Regulations 5, 6, 7 and 8 of the proposed Regulations.

The objective of proposed Regulations 5, 6, 7 and 8 is to determine an appropriate fee scale for the Credit Tribunal, to achieve an equitable allocation of public resources by ensuring that persons using the resources of the Credit Tribunal through the hearing of applications before the Tribunal or who seek the issuing of a summons or the recognition of an order make an equitable contribution to the cost of provision of this service.

The proposed fee scale is considered to have the benefit of being consistent with the recommendations made in 1984 by the Civil Justice Committee for the adoption of a middle course between a heavily subsidised system and a full user-pays system linked to the costs of administration of the system. The current fee scale by comparison appears to recover too little of the costs of the system. It

is considered that the advantages of access to justice from the more appropriate level of partial cost recovery in the fee scale proposed in the regulations outweighs the budgetary disadvantage of not requiring applicants to meet the full costs of matters before the Tribunal.

The proposed fee scale would also have the benefit of providing comparable fees to those prevailing in the other major State, NSW, thereby minimising incentives for forum-shopping in matters under the **Consumer Credit Code** which may be brought in other jurisdictions. Finally, the proposed fee scale would have the benefit of providing comparable fees for applications brought under both the **Credit Act 1984** and the **Consumer Credit (Victoria) Code**, thereby minimising inequities associated with the creation of two classes of applicant before the same Tribunal.

The RIS examined two alternatives to the fee structure proposed. The alternatives examined were a fee scale to reflect full cost recovery and establishing fees on a case by case basis that reflected all or a specified proportion of the individual levels of action required in respect of services provided in that particular case. The RIS concluded that the benefits of the fee structure as proposed are greater than those of the alternatives.

  - (a) revoke the Order about the Use of Agricultural Chemical Products by Authorised Personnel made under Sections 5 and 25A of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992** dated 30 July 1996 and published in the Government Gazette on 1 August 1996; and
  - (b) regulate the use of specified agricultural chemical products.

**AUTHORISING PROVISION**

2. This Order is made under Section 25A of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**.

**COMMENCEMENT**

3. This Order comes into operation on 1 August 1997.

**REVOCATION**

4. The Order about the Use of Agricultural Chemical Products by Authorised Personnel made under Sections 5 and 25A of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992** dated 30 July 1996 and published in the Government Gazette on 1 August 1996 (Page 2011) is revoked.



DEFINITION

5. In this Order—

“the Act” means the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**.

USE OF SPECIFIED AGRICULTURAL  
CHEMICAL PRODUCTS

6. A person must not use an agricultural chemical product (other than a home garden product) that contains a constituent referred to in the Table unless—

- (a) the use is specified in a permit issued under Section 25A (2) (b) of the Act; or
- (b) the use is specified in a permit issued under Part 7 of the Schedule to the **Agricultural and Veterinary Chemicals Code Act 1994** of the Commonwealth; or
- (c) the person is registered as a pest control operator under Division 2A of Part 5 of the **Health Act 1958** and is operating in accordance with the provisions of that Act and the **Health (Pest Control Operators) Regulations 1992**; or
- (d) the person holds and operates in accordance with a current agricultural chemical user permit issued under Section 25A (2) (b) of the Act, or is acting under the direct and immediate supervision of a person who holds such a permit; and
  - (i) the use is not other than in accordance with the directions contained on the label for the agricultural chemical product which has been approved by the National Registration Authority for Agricultural and Veterinary Chemicals; and
  - (ii) the use is not subject to any prohibitions made under the Act; or
- (e) the person holds a current Pilot (Chemical Rating) Licence issued under Schedule 1 to the Act and—
  - (i) the agricultural chemical product is used by aerial spraying; and
  - (ii) the use is not other than in accordance with the directions contained on the label for the agricultural chemical product which has been approved by the

National Registration Authority for Agricultural and Veterinary Chemicals; and

- (iii) the use is not subject to any prohibitions made under the Act; or
- (f) the person holds a current Commercial Operator Licence issued under Schedule 1 to the Act or is an employee of a person holding a current Commercial Operator Licence and—
  - (i) the use is not other than in accordance with the directions contained on the label of the agricultural chemical product which has been approved by the National Registration Authority for Agricultural and Veterinary Chemicals; and
  - (ii) the use is not subject to any prohibitions made under the Act; or
- (g) the person—
  - (i) has completed a course in farm chemical use that is listed on the State Register of Accredited Courses under Section 78A of the **Vocational Education and Training Act 1990** or any other course in farm chemical use accredited by the State Training Board under Section 74 of that Act or is under the direct and immediate supervision of a person who has completed such a course; and
  - (ii) is accredited under a quality assurance program that requires—
    - A that the use is not other than in accordance with the directions contained on the label for the agricultural chemical product which has been approved by the National Registration Authority for Agricultural and Veterinary Chemicals; and
    - B the person to be independently audited at regular intervals of less than 2 years.
