Levees along both sides of Seven Creeks are to commence on the south-west side of the creek, upstream of Boundary Road South, continuing downstream of the railway to Lydiard Road, and on the north side, commencing near the timber yard on Strathbogie Road, down to the railway. Castle Creek levee, on the township side, is to commence 200 metres downstream of the Freeway, and extend to the railway.

The Euroa Community Consultative Committee has also arranged an Open Day at the Shire of Strathbogie Municipal Office between 9.00 a.m. to 5.00 p.m. on Wednesday, 8 October, to allow members of the community the opportunity to discuss the Study with the Consultant, Sinclair, Knight Merz. Each person is requested to nominate the specific element of the study for discussion.

 The need for a male aide is because of the nature of the student and the reason the student receives funding is emotional and social difficulties that he has experienced over a long period of time.

- Whilst the student's general classroom behaviour has been good the need for an aide is especially important in the playground where most difficulties occur. The student often finds himself in physical conflict with other students and this often involves the necessity to actually separate them.
- The applicant has twice as many boys as girls. The position will also be seen as a role model for all the boys, most of whom lack consistent male figures in their lives.
- The student's last school provided a similar service which proved quite successful, providing socialisation activities, co-operative games and the like. The applicant will provide the same.
- Because of the physical strength of the student and some of his behaviour traits, the position would be best suited to a male, who may need at times to physically separate students.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the Equal Opportunity Act 1995, to enable the applicant to advertise for and employ a male SS01/integration aide, this exemption to remain in force until 10 September 2000.

The Anti-Discrimination Tribunal constituted by the President pursuant to Section 83 (5) (a) (ii) of the Equal Opportunity Act 1995 ("the Act") has considered an application pursuant to Section 83 of the Act by Ms Chris Binns trading as Chrysalis Style. The application for exemption is to enable the applicant to provide an image and weight management consultancy service for women only.

Upon reading the material tendered in support of this application the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 42, 100 and 195 of the Act to enable the applicant to provide an image and weight management consultancy service for women only.

In granting this exemption the Tribunal noted:

- The need for a different approach for women springs from the fact that emotional issues are the most common causes of weight management problems in women.
- The very nature of the problems facing women are extremely personal. To deal with these problems in a group environment an individual needs to feel completely safe and secure. It is easier for a woman to achieve this feeling in an all woman group. The empathy created in such a group is conducive to effectively facing the issues raised during an investigation into the root causes of weight management problems. Self disclosure is an integral part of the process, and unless a woman feels safe to reveal her true feelings about herself, her body and her sexuality her progress will be hampered.
- Research is showing that the incidence of breast and colon cancer is directly related to the amount of fat in the diet. As a nation we are becoming less fit as automation makes our lives less physical.
- Men require short bursts of intense exercise to burn fat whereas women require long periods of gentle exercise to achieve the same results (Dr Garry Eggar, Scientific Director of GutBusters).
- The applicant's service is not just aiming to provide information about nutrition but also it aims to address the emotional causes of obesity.
- Chrysalis Style conducts a 6 week group programme and individual consultation covering weight management strategies and how weight affects self and body image. It is largely an investigation into the emotional causes of weight management problems and as such is intensely private and personal in nature. Women are much more comfortable dealing with such issues in a single gender group.
- In the Doncaster Templestowe area, men have the opportunity to join Jenny Craig at Doncaster East or

Greensborough, Weight Watchers in Doncaster, Donvale and Lower Templestowe and GutBusters in Kew and Blackburn.

NOTICE OF INVESTIGATION VICTORIA'S MARINE, COASTAL AND ESTUARINE AREAS

The Environment Conservation Council(ECC) is required by the Minister for Conservation and Land Management to complete a Marine and Coastal Special Investigation by 30 June 1998 in accordance with Section 17 of the Environment Conservation Council Act 1997.

The investigation area extends from the Victorian offshore territorial limit (5.5 km) to a distance of approximately 1 km inland from the high-water mark; it includes the land (terrain, and overlying water) affected by marine, coastal and estuarine processes. On French Island the landward boundary of the area is approximately 1 km inland from the high-water mark.

The bed and associated waters of the Gippsland Lakes are excluded. Land within cities and rural cities may be included at the discretion of the Council.

The Council is to investigate this area and make recommendations on the protection of significant environmental values and the sustainable use of these areas with priority given to:

- a preferred approach and priorities for the progressive establishment of a representative system of marine parks in the State of Victoria;
- areas suitable for marine aquaculture which can be developed on an environmentally sustainable basis.

In making these recommendations the Council is to have regard to:

- the matters to be taken into account in investigations as provided in Section 20 of the Environment Conservation Council Act 1997;
- the work undertaken by the Land Conservation Council and the Victorian Coastal Council; and
- the Prime Minister's announcement on 3 March 1997 of the development of an Australian Oceans Policy.

The Council is to provide an interim report by 30 November 1997 recommending options for the early establishment of at least one marine park and at least one area suitable for the priority development of marine aquaculture
