**LIGHT AT FALSE POINT, BAY OF BENGAL.  
 NOTICE.**

**R**EFERRING to the Notice published from this Office under date 21st January last, communicating the abandonment of the Light at Point Palmyras—Notice is now given, that on the 1st day of March, 1837, a Light will be exhibited at False Point on a building to be there erected.

The Light House will stand in Latitude  $20^{\circ} 19' 25''$  N., and Longitude  $86^{\circ} 48' 8''$  E. During the S. W. Monsoon of the year 1837, the Light will be exhibited from an elevation of about 65 feet above high water mark, and be visible in clear weather at a distance of about 13 miles from an elevation of 15 feet above the surface of the sea.

The Light will be continued at this height until the end of November, after which it will be discontinued, in order to the removal of the Lantern to the top of the building. It will subsequently, viz. on and after the 1st March, 1838, be again exhibited at an elevation of 120 feet above high water mark, and be then visible from 18 to 20 miles in clear weather from the height of 15 feet from the surface of the sea.

The Pilot's Station will be continued as heretofore off Point Palmyras during the S. W. Monsoon, that is, from the 15th of March to the 15th September, during which period the Pilot Vessels Cruise during the day off the Point, anchoring during the night in a line East and West in Latitude  $20^{\circ} 42'$  to  $20^{\circ} 48'$  N., with the Point bearing W. to W. by S., the Vessel, on board of

which the next turn Pilot may be, will burn a Blue Light and fire a Maroon alternately every half hour, commencing with the former at eight o'clock and continuing till daylight.

Commanders on making the Light on False Point are recommended after bringing it to bear West in from 13 to 14 fathoms to steer to the N. E., keeping in from 13 to 18 fathoms as the wind may hang to the Westward or Eastward—on no account coming under the former depth. In this track the Blue Light and Maroon above-mentioned will be seen long before the Light on False Point is lost sight of. If, however, about the beginning of September the wind comes from the Eastward or the weather assumes a threatening appearance, the Pilot Vessels necessarily haul off to the Eastward, and will then be found in a Line between Point Palmyras and the Floating Light at the entrance of the Eastern Channel. Vessels therefore, about that period if the wind hangs to the Eastward, or has a threatening appearance, are recommended, after leaving False Point, on no account to approach Point Palmyras, but rather to endeavour to make for the Floating Light at the entrance of the Eastern Channel; and it is further notified, that from the 15th September no Pilot Vessel will be found to the Westward of the Western Sea Reef.

From the 15th September to the 15th March, the Pilot Vessels Cruise during the day between Saugor Sand and the Western Sea Reef, anchoring in the night East and West of each other in Latitude  $21^{\circ}$  to  $21^{\circ} 10'$  North.

Vessels approaching either Station, during the day, are requested to make for that Vessel on board of which they will see a large Red Flag flying at the main, whenever they can do so without great inconvenience or delay. In the night, during the N. E. Monsoon, that is, from 15th September to 15th March, at the Floating Light Station at the entrance of the Eastern Channel, the Vessel having the next turn Pilot on board will burn a Maroon every hour, and in thick weather every half hour; and as before stated, at the Point Palmyras Station during the S. W. Monsoon, or

between 15th March and 15th September, such Vessel will alternately burn a Blue Light and Maroon every half hour. Commanders are in like manner requested, during the night, to seek their Pilot from such Vessel; it being, however understood that any Pilot Vessel which may be first seen is bound immediately to use every exertion to put a Pilot on board, night or day, without reference to turn or rotation; and that this latter is only allowed when no delay is occasioned thereby.

The Contract for Liverpool to include the Male Orphan School.

The remaining Services may be tendered for separately ; but it is to be observed that the Contractor for any Surveying Party or Parties is to furnish both Provisions and Forage to such Party or Parties.

**CONDITIONS.**

All the Articles required by this Notice are to be of the best quality of their several kinds.

The Flour or Bread must be the produce of clear, sound Colonial Wheat, Barley, and Maize, from which, on the Ration to Emigrants, Orphan Schools, Men in Surveying Parties, and the Water Police, 20 per cent., and on the Convict Ration, 10 per cent. has been extracted in bran and waste. The Wheaton Bread to be made in loaves of 3 lbs., and the mixed Bread in 3½ lbs. each, and baked twenty-four hours before being issued.

Beef is to be supplied to Orphan Schools on five days, and Mutton on two days of the week.

The fresh Meat for the Emigrants to be in the proportion of 3½ lbs. of Beef and 1½ lb. of Mutton weekly ; deliverable alternately in fore and hind quarters, when the quantity admits of it, and for the Convict Ration the Beef is required in the same way.

The Maize meal to be similar in quality to the Wheaton meal, and to be twice ground.

Hospital Bread is to be supplied to the Children of the Female Orphan School, when required by the Surgeon, in lieu of the ordinary Ration.

Vegetables to be supplied in reasonable proportions of Potatoes, Greens, Pumpkins, Onions, &c.

The supplies for Road Parties and Surveying Parties, are to be delivered at the nearest fixed stations to the places where the party may be employed, on the requisition of the officer in charge ; and in case the whole Ration of Forage be not required or delivered, each of the species to be reckoned as the portion of the Ration undermentioned :—

The Maize or Barley.....4-12

The Hay.....5-12

The Bran .....2-12

The Straw .....1-12

The supplies (not specified in the preceding paragraph), are to be delivered direct to the Parties, or Establishments entitled thereto, on the written order of the Person duly authorised for the purpose.

Provisions and Forage being required by Rations, according to the scales under their respective heads, the Tenders are required to express the price per ration only.

The price of the extra articles for the Orphan Schools, &c., and Fuel and Light to be separately stated.

In the event of a difference of opinion between the Contractor and the Party receiving the supplies, as to its quality, the same is to be decided in the following manner :—

The Party objecting will name one person as arbitrator, the Contractor or his agent another, and these two will (previously to any other proceeding on their part), concur in naming a third as Umpire, who, in the event of the arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final.

If the article is not found to be of proper quality, it must be immediately replaced by the Contractor, failing of which it will be procured by the Department requiring it, and the expense charged to the Contractor.

In the event of any unnecessary delay, or failure of the Contractor to supply the articles when required, they will be otherwise procured in like manner ; and on a repetition of the inconvenience it will be in the power of the Governor to terminate the Contract.

It will be in the power of either party to limit the duration of the Contract, by giving in writing a notice of three full calendar months, to the opposite Party, and to end the Contract at the expiration of that period.

The Contractor will be required to prepare his own account monthly, in the prescribed form ; and on the production thereof, with the requisite vouchers, in a complete state, to the officer receiving the supplies, the same will be forwarded by the latter to the Auditor-General, in order that a warrant may be prepared and payment made from the Colonial Treasury.

The value of all packages to be included in the prices demanded.

Printed forms of Tender may be obtained at this office, and from the Police Magistrates of the several Districts, and as adequate security will be required for the due fulfilment of the Contract, no Tender can be attended to, unless accompanied

by a certificate from the Parties proposed as such, stating that they are willing to become bound as securities for the Contractor accordingly, and the Bonds must be executed within ten days from the day of the acceptance of the Tender being notified, failing of which the Contracts will be again advertised, or another Tender accepted.

The Tenders to contain the names of the Tenderers and their sureties, and places of residence, at length.

All Tenders to be enclosed in a separate envelope, and marked "*Tender of Provisions, &c.*"
