" A Bill to Regulate the Practice of Medicine."

A Dut to Regulate the Fractice of Medicale.

An Act having passed the Legislative Council during this present Session, intituled "An Act "to provide for the attendance of Medical Wit-"nesses at Coroners' Inquests, and Inquiries held before Justices of the Peace;" It is proposed that from and after the 1st of January next, no person shall either for the purposes of that Act, or for any other nursose whatever, he deemed a or for any other purpose whatever, be deemed a legally qualified Medical Practitioner unless he shall prove to the satisfaction of the President and one other Member of the Medical Board to be hereafter appointed by the Governor, that he is a Doctor of Medicine of some University, or a Physician, or Surgeon, licensed or admitted as such by some College of Physicians, or Surgeons; or unless he shall have obtained, after an examination publicly held before at least three Members of such Medical Board, Letters Testimonial, to Practise as a Physician or Surgeon.

It is proposed that from and after the said 1st of January next, no Person, (except Officers of Her Majesty's Land or Sea Service,) shall Practice any branch of the Medical Profession unless Licensed by the Governor, after having duly submitted his Diploma or other Certificate for examination of the Board.

It is proposed that from and after the 1st of January, 1840, the powers of the Medical Board shall cease and determine as to the granting Letters Testimonial; and that thenceforth no candidate for such Letters Testimonial shall be admitted unless the applicant shall have conformed to the course of Education to be hereafter prescribed by the Board, and shall produce a Certificate from at least two Members of such Board that previously to his apprenticeship he had passed such examina-tion in the Greek and Latin Languages as the Medical Board shall, by a Bye Law for such purpose to be made, declared sufficient, together with Apprenticeship, and also such Certificates of attendance at Hospitals as the Board by Bye Laws which they from time to time may make, shall require. These Bye-Laws, however, to be E. DEAS THOMSON. subject to the approbation of the Governor.

Legally qualified Medical Practitioners and 1. "A Bill to regulate the Distillation of Spirits censed Apothecaries may receive apprentices, "in the Colony of New South Wales." Licensed Apothecaries may receive apprentices, provided they be not under the age of sixteen.

No person shall, from and after the said 1st of January next, practise any branch of the Medical Profession, without having previously obtained the License aforesaid, except as above excepted, under a Penalty of not less than Ten nor more than Fifty pounds.

No Drugs or Medicine imported into the Colony to be sold without a certificate of their good quality being first obtained from the said Board, under a

Penalty of Fifty pounds.

All Venders of Medicines having Medicines of a powerful or poisonous nature, shall label all vessels or packages containing the same with the word "Poison." No Vender of Medicines shall dispose of any such powerful or Poisonous Medicine in large or dangerous quantities except on written permission from a Magistrate or prescription from legally qualified Medical Practitioner, under Penalty of not less than Five nor more than Ten nounds.

Apothecaries to prepare all Medicines according to the Phormacapia Londinensis, unless otherwise directed by the prescription of some legally qualified Medical Practitioner.

All proceeds to be had under the Act of the Governor and Council, 5 Wm. 4, No. 22.

Amount of 'Pees to be paid by Candidates for Letters Testimonial, &c., to be determined by the Board, subject to the approbation of the Governor.

'Act'not to apply to persons in practice for two years prior to the passing thereof, except as to the attendance of such persons at 'Coroners' Inquests,

Secretary to Medical Board to enfer in a Book the names of all legally qualified 'Medical Practitioners; such names to be published in the Government Gazette, for public information, on or about the 1st of January, in each year.

'Pees to be applied towards the establishment of Atlatomical Museum, or other Institution for the advancement of the medical science.

It is proposed to make the distillation of spirits unlawful in any part of the Colony except in the towns of Sydney and Melbourne, or in such other towns or places as the Governor may appoint, under a penalty.

Distillers to be licensed.

Persons desirous of obtaining licenses to apply by memorial, accompanied by a description and drawing of the still, and place where it is to be situated.

No still to contain less than forty gallons. Distiller, with two sureties, shall enter into recognizance.

Duty on license to be fifty pounds.

Licenses to be renewable annually, unless Distiller convicted of offences against the Act. Distillers shall not also brew on the same

premises, or within one hundred yards thereof. nor sell spirits in less quantities than sixty gallons, under a penalty.

Owners, part-owners, or shareholders in a licensed distillery, shall not hold a license to retail spiritous or fermented liquors.

Still-house to be not less than one hundred yards distant from any other house, and the premises to be enclosed by a wall not less than ten feet in height, and not less than forty-eight feet distant from the still-house.

Spirit store to be within the enclosed premises, and to be at all times open to the inspection of the Inspector of Distilleries, under penalty.

Stills shall be set in stone and morter.

Coolers to be securely fixed, and must contain full, charge of the still.

Only one worm for each still to be allowed.

Inspector of Distilleries shall register de-scription and return of stills, and distillery utensils, and to have power to enter premises at all times.

Notice of intention to distil must be given to Inspector, at least six days, previous, under a

penalt y.

Duty on spirits to the 7s 6d. per gallon, hydrometer proof, to be charged for so many gallons as each still can produce, from the greatest number of charges that can be worked off in-twenty-eight days.
-Duty to be paid to Colonial Treasurer.

No spirits to be removed without Permit from the Inspector; spirits otherwise removed to be forfeited.

Illicit spirits may be seized.

Officers of Customs, and Inspector, may enter premises to search for illicit spirits, and seize the

Spirits' seized to be sold by auction within one month.

Foreign and Colonial spirits must be kept in separate cellars.

Sellers and purchasers of illicit spirits subject to penalty.

Penalties recoverable before two or more Justices, or in the Supreme Court, or in the Court of Vice Admiralty.

If penalties not paid, offending parties may be imprisoned for not less than three months, E. DEAS THOMSON. nor exceeding six months.

Governor may remit penalties.

Notice of action to be given to Officers of Customs, or Inspector, and actions against them unst be brought within three months, and if probable cause of seizure be certified by the Judge, they shall not be liable to damages exceeding two-pence, without costs, nor to a fine exceeding one shilling.

2. "A Bill to amend an Act intituled 'An Act
"for preventing the mischiefs arising from
"the printing and publishing Newspapers,
"and papers of a like nature, by persons not
"known, and for regulating the printing and
"publication of such papers in other respects;
"and also for restraining the abuses arising
"from the publication of blasphemous and
"seditious libels."

It is proposed that affidavits, affirmations, and recognizances, heretofore required to be made and entered into, by Editors, Printers, and Publishers of Newspapers, before the Colonial Scretary and a Judge of the Supreme Court, respectively, shall henceforth be made by the Editors, Printers, and Publishers of Newspapers, published in the Country Towns or Districts, before the respective Police Magistrates, they being required forthwith to transmit the same to Sydney to be recorded.

"A Bill to indemnify the Officers of Customs
"and others, for having permitted the Impor"tation of Liqueurs, Cordials, and Spirituous
"Syrups, on payment of less than the accus"tomed Duty."

It is proposed to indemnify the officers of Her Majesty's Customs, and others concerned, for having, since February, 1837, demanded and received a lower rate of duty than legally chargeable on Liqueurs, Cordials, and Spirituous Syrups, acting upon a view of the subject which has not been approved by the Home Authorities.

A. "A Bill to amend an Act intituled 'An Act for "regulating Buildings and Party Walls, and "for preventing mischiefs by Firein the Town ... of Sydney."

It is proposed in estimating the several rates of building, that each rate shall be increased one

That every dwelling-house, warehouse, stable, and other building (except such buildings not being dwelling-houses as in the Building Act are declared to be first rate buildings) which is at the distance of eight feet from any public road, and is detached from any other property not in the same possession, at least twenty feet, or connected with any other building only by a fence or fence wall, shall be deemed a sixth rate building, and may be built of any dimensions and of any materials whatever.

That the thickness of walls built of stone shall be increased in the proportion of six inches above the dimensions required by the Act, unless such wall be built of thorough stones, wrought or hammered square on beds and faces.

That footings shall be dispensed with when walls are built upon rock foundations.

That Venitian blinds or window shutters be to furnish the requisite particulars after reasonable allowed, provided they do not project from the notice, or if the nature of his claim be such as to

upright line of the building to which they belong more than the distance prescribed by the Building Act for the cornice or covering of shop windows, but not allowed on the ground floor to project over the footing in the operation of opening or otherwise.

That verandals and balconies be allowed, if wholly constructed of hard-wood the growth of the Colony, provided they do not approach nearer the angle of the house to which they belong than the distance of two feet, or separated from adjoining premises by a nine inch thick party wall; and provided also, that they do not project into any street beyond the distance permitted by the Building Act.

That every flat, gutter, and roof of every first secend, third, fourth, and fifth rate building already built, and every turret, dormer and lanthorn light, or other erection in the flat or roof of any such building, and every external part of any flat, gutter, roof, dormer, and lanthorn in any building of the first, second, third, fourth and fifth rate building now built, or which shall at any time hereafter be ripped or uncovered, shall be covered with glass, copper, lead, tin, zinc, or other metal, slate, tile, artificial stone, or hard wood, the growth of the Colony; except the doors, door-frames, windows, and window-frames thereof.

Nothing in the Building Act contained to prevent the use of Colonial hard wood shingles.

That nothing in the Building Act contained shall be construed to prevent the use of Colonial hard-wood for external enclosures to first, second, third, fourth and fifth rate buildings, provided they do not project into any street beyond the distance allowed by the said Building Act.

That no separate fee shall be charged upon detached offices to first, second, third, or fourth rate buildings, if they be built at the same time as the main building, or completed within six months after it has been covered in; provided, however, that no stable, warehouse, store, or workshop shall be deemed an office, so as to exempt the owner or proprietor from payment of any fee chargeable thereon under the provisions of the Bulding Act.

That no alteration or addition to any building which does not interfere with the dimensions or materials prescribed by the Building Act shall authorise or require the payment of any fee.

with greater dispatch, His Excellency the Governor directs it to be notified, for general information, that the following modes of procedure will be observed in issuing such Deeds for Grants of Land, for Town Allotments, and for Purchases respectively.

The principle of the several arrangements is, that each person shall have an opportunity of stating his claim, and obtaining his Deed, with as little delay as is consistent with the necessary correctness; and that, if practicable, this shall be effected without expense; but that, if he neglect to furnish the requisite particulars after reasonable notice, or if the nature of his claim be such as to

render it either impossible or improper for the Government to decide on its validity, it shall be referred to the Commissioners of Claims, and the expense of that measure be defrayed, (as directed by the Act of Council,) partly by the Government, and partly by the individual interested.

GRANTS OF LAND.

1. The Deeds will be prepared either by Parishes, or in such other order as may be found

more practically convenient.

Unless otherwise applied for, they will be advertised in the name of the Original Promisee, who will be required to furnish the following particulars within Three Months, viz:—
Surname and all Christian Names of the person

in whose favor the Deed is to be prepared, written at full length; his residence; and the

intended name of the property.

3. If these be duly furnished, and the Deed be required in the name of the Original Promisee, and be not disputed or otherwise objectionable, it will be prepared accordingly, as soon as possible after the expiration of the stated period of Three

4. If the Deed be required in any name but that of the original Promisee, the application must specify the grounds of claim, and be accompanied by a letter from the said Promisee, if living, and from all intermediate Assigns, if any, giving his and their consent and sanction thereto, and witnessed either by a Magistrate, or by a Solicitor of the Supreme Court. Upon this being done, the name of the new Claimant will be advertised for the further period of One Month; and if no objection be interposed, or other cause of uncertainty appear, the Deed will be afterwards prepared in his favor, as requested.

5. But if the particulars mentioned in paragraph 2 be not furnished within Three Months, or if a Caveat be lodged, or if any other cause of uncertainty arise, which cannot otherwise be satisfactorily determined by the Government, the case will be referred for investigation to the Commissioners of Claims, appointed under the Act of Council, 5th WILLIAM IV., No. 21, and after receipt and approval of their Report, the Deed

will be issued in conformity therewith.

A Schedule is annexed (A) of the Fees charged to individuals upon all cases referred to the said Commissioners.

6. If a Deed be urgently required, out of the prescribed order, it will also be prepared, after the usual advertisement for Three Months, upon an application being addressed to the Colonial Secretary, specifying the following particulars, viz: Surname and all Christian Names of the person

in whose favor the Deed is to be prepared, written at full length; his residence; all Names of the Original Promisee, written at full length; date of original Order or Promise; number of Acres; County or District; and intended Name of the Property.

7. If it be required in any name but that of the original Promisee, the application must also (as stated in paragraph 4,) specify the grounds of claim, and be accompanied by a letter from the said Promisee, if living, and from all intermediate Assigns, if any, giving his and their consent and sanction thereto, and witnessed either by a Magistrate, or by a Solicitor of the Supreme Court.

8. If not so accompanied, or if a Caveat belodged, or if any other cause of uncertainty appear, it will be either prepared in the name of the Original Promisee, or referred to the Commissioners above-mentioned.

9. No Sub-division of any Grant of Land-

can be recognised by the Government.

TOWN ALLOTMENTS, IN SYDNEY.
The Survey of the Town having been completed, and Plans deposited for public inspection in the Office of the Surveyor General, descriptions of the Allotments in each Section will be prepared in accordance therewith, as quickly as practicable; and, with the Names of the Proprietors, so far as they can be ascertained, will be severally advertised for Three Months, as heretofore.

11. Within that period, each Claimant or Reputed Proprietor will be required to state the fol-

lowing particulars, viz :-Surname and all Christian Names of the person in whose favor the Deed is to be prepared, written at full length; his residence; all Names of previous Proprietors, written at full length; and the Grounds of the Claimant's Right, or Title.

12. If these be duly furnished and satisfactory, and if the Deed be required in favor of the reputed Proprietor, and not disputed or otherwise objectionable, it will be prepared accordingly as soon as possible after the expiration of the Three

Months.

13. If the Deed be required in favor of a person not mentioned as the Proprietor in the original Advertisement, the application must not only state the particulars above-mentioned, but must also either be accompanied by a letter to the same effect from such Proprietor, if living, signed in the presence either of a Magistrate or of a Solicitor of the Supreme Court; or proof must be adduced that his name was so published in error.

Upon this being done, and satisfactory particulars furnished, as mentioned in paragraph 11, the Name of the New Claimant will be advertised for the further period of One Month; and if no objection be interposed, or other cause of uncertainty appear, the Deed will be afterwards pre-

pared in his favor, as requested.

14. But if the particulars mentioned in paragraph 11 be not furnished within Three Months, or if a Caveat be lodged, or other cause of uncertainty appear, the case will be referred to the Commissioners.

15. The same course will be pursued with regard to Title Deeds of Sydney Allotments, the descriptions of which have been advertised already.

- 16. The Deeds will be prepared in conformity with the conditions of the Proclamation of the Sth June, 1829, a copy of which is subjoined (B). But the indulgence therein alluded to, of paying the arrears of Quit-rent by annual instalments, will not be extended to any arrears which have accrued since the 1st July of that
- 17. After the description of an Allotment has been once advertised, no Sub-division can be recognised in the preparation of the Title Deeds.

TOWN ALLOTMENTS, OUT OF SYDNEY.

18. Title Deeds for Allotments in Country Towns and Villages, held under promises of Grants, will be issued with as much dispatch as practicable, in such order as may be most convenient for the preparation of the descriptions.

The Parties will be required to produce, within Three Months, the usual particulars and vouchers, as enumerated in paragraphs 11 and 13; and failing any of these, the cases will be referred to the Commissioners.

19. Deeds will also be prepared for Country Town Allotments, upon special applications addressed to the Colonial Secretary.

In making these, it will be necessary to have reference to the Regulations of 25th August, 1834, a copy of which is annexed (C); and in accordance therewith to specify, not only particulars similar to those enumerated in paragraph 11, viz:—

Surname and all Christian Names of the person in whose favor the Deed is to be prepared, written in full length; his residence; all Names of previous Proprietors, written at full length; and the Grounds of the Claimant's Right, or Title;—but also the following, viz:—

The Town, Parish, and (if possible) the Section, Number, and contents of the Allotment claimed; Whether the Allotment is held under a Lease containing Covenants to convert the same into a Grant; or under a Lease without such Covenants; or under an order for a Grant; or in any other manner; together with the date of any such Lease or Order:

If under a Lease with Covenants of Conversion—whether the Grant is desired upon condition of paying twenty-one years Quit-rent, or in consideration of having erected buildings to the value of £1000; and, if the latter, proof of such erection and value:

If required in any Name but that of the Original
Lessee or Promisee, (as the case may be,) a
letter from that party, if living, signed in the
presence either of a Magistrate or of a Solicitor
of the Supreme Court, must also be transmitted,
requesting the preparation of the Deed in the

name of the new Applicant.

. 20. Upon these being furnished, such steps will be taken forthwith, as may be requisite in each case. Previous to the preparation of any Deed, the name of the applicant will, as usual, be advertised for Three Months; and, if his claim be disputed or uncertain, the case will be referred to the Commissioners.

21. No Sub-division can be recognised of any such Allotment.

PURCHASES.

22. Title Deeds of Lands upon which a Remission has been granted to Retired Officers, cannot be prepared until two years have elapsed from the date of final payment, and then only upon application being specially made.

23. With this exception, Title Deeds of all Lands and Allotments purchased from the Crown, under the Regulations of 1st July, 1831, will be prepared immediately, as heretofore, upon receipt of the Report of the Colonial Treasurer, that the Purchase Money has been paid up in full.

24. They will be invariably executed, without Sub-division, in the name of the original Purchaser.

PROCLAMATION.

By His Excellency Lieutenant General "RALPH DARLING, Commanding His Ma"jesty's Forces, Captain General and Go"vernor in Chief of the Territory of New "South Wales and its Dependencies, and "Vice Admiral of the same. &c. &c. &c."

WHEREAS much inconvenience hath been occasioned by the want of suffi-cient Titles for Allotments of Land in the Town of Sydney; And whereas such Titles have not been issued by the Government, except in a few instances, since the Thirtieth day of June, Eighteen hundred and twentythree: Now, therefore, in order to remedy this inconvenience, and give the necessary security to private property, I, the GOVERNOR by virtue of the authority in me vested, do hereby Ordain and Proclaim, that on application being made, a Grant in Fee Simple shall be issued under the conditions hereinafter specified, to every Person (or his lawful representative) who, on or before the said Thirtieth day of June Eighteen hundred and twentythree, was bona fide in possession, by Lease from the Government, (whether such Lease be now expired or not,) or by mere right of occu-pancy, of any Allotment of Land in the said Town of Sydney, not hitherto alienated by the Crown, and not specified in a certain order of the Government bearing even date herewith, Number Thirty, or otherwise notified heretofore as being required for Public Purposes; Reserving, however, and keeping harmless, all Rights of other Private Individuals, which may be lawfully established at any time thereafter.

And in order that all Parties interested may have an opportunity of proving such, their respective rights, a description of each Allotment, with Notice of the intention to complete a Grant thereof, shall be published Three Months previously, for general information.

AND WHEREAS, considerable sums of money are due to the Crown, as Quit-rents upon the said Allotments, the immediate exaction of which, as hath been represented to Me, would be exceedingly oppressive to the Parties concerned; but the total remission of which, would be equally unjust to such other Parties as have regularly paid the same; Now, therefore, in order to render the payment of the said sums as little burthensome as possible, I do further Proclaim, that the Grants herein intended, shall be issued under the following conditions: namely, that no arrears of Quit-rent shall be demanded for the said Allotments beyond the aforesaid date of Thirtieth June Eighteen hundred and twentythree; and that such arrears as have accrued since that date, shall be calculated at the rate of sixpence sterling per square rod per annum, instead of ninepence as heretofore; and also, that they shall be liquidated by instalments payable annually, in addition, and equal to the regular yearly Quit-rent, until the whole be satisfied

AND I no further order, that in all other respects, the Grants to be made out in pursuance of this my Proclamation, shall be in the same form, and subject to the same Quit-rent, and other conditions of every kind, as are laid down for general adoption in the Order of the Government, number Twenty-nine, dated the Twenty-ninth day of May, in the present year, (D), or such modifications of the same, as may be in force at the time of issuing each of the said Grants respectively.

COUNTRY TOWNS.

His Excellency the Governor directs it to be notified, that the following arrangement has been approved with regard to Allotments held under Lease, or otherwise, in the several Towns throughout the Colony, except Sydney; viz: I. Under Leases, with covenants to convert the same into Grants, either upon payment of twenty-one year's Quit-rent, or upon erection of buildings to the value of £1000;

(1.) That every such Lease shall be allowed to run out, unless a grant be previously claimed under either covenant.

(2.) That if no Grant be claimed under either covenant, the Land shall be put up to sale at the expiration of the Lease, the Government paying the Lessee for any buildings erected thereon, under the value of one thousand pounds.

(3.) That if the Land be taken by the Lessee under the covenant of paying twentyone years Quit-rent, at the rate stipulated in the Lease, no further Quit-rent shall be demanded.

(4.) That if a Grant be obtained, on proof of one thousand pounds expended, Quitrent shall be charged at the rates fixed by the Government Order of the 29th May, 1829, No. 29.

II. Under Leases without covenants of conversion into Grants;

(5) That Leases executed prior to the administration of Sir Thomas Brisbane, which do not contain the foregoing covenants, shall be allowed to run out, and the Lands be then put up to sale.
