HER MAJESTY THE QUEEN having been pleased to command that

CHARLES JOSEPH LA TROBE, Esquire, shall be appointed Superintendent of the Settlement and District of Port Phillip, His Excellency the Governor directs it to be notified that a Commission containing such Appointment has been issued accordingly, under the Great Seal of the Territory, and the prescribed Oaths have been this day administered to his Honor in the presence of the Governor and the Executive Council.

The District of Port Phillip will comprise that portion of the Territory of New South Wales which lies to the south of the thirty-sixth degree of south latitude, and between the one hundred and forty-first and one hundred and forty-sixth degree of east longitude; within those limits his Honor the Superintendent will exercise the powers of a Lieutenant Governor, and all Officers of the Government and others are hereby required to render him obedience and respect accordingly.

His Excellency cannot allow Captain Lonsdale to be relieved from the duties with which he has been hitherto charged, as the chief organ of the Government at Port Phillip, without availing himself of the opportunity to express publicly the sense he entertains of the ability, zeal, and success with which that Officer has performed those duties, and labored to develope the resources of that important Settlement, under the peculiar difficulties attending its first formation and very rapid progress.

The services of Captain Lonsdale, however, will still be retained to the Government and the Public in his capacity of Police Magistrate for the Town and District of Melbourne.

IS Excellency the Governor is pleased to direct, that the general objects of the following Bills, now under consideration of the Legislative Council, be published for general informa-

> By His Excellency's Command, E. DEAS THOMSON

1. " A Bill further to amend an Act passed in the " eighth year of the reign of His late Majesty King William IV., intituled, "An Act for regu-" lating Buildings and Party Walls, and for " preventing Mischiefs by Fire in the Town of " Sydney.

Whereas, it is expedient further to amend the said recited Act, and to confine the operation of the same to certain parts of the town of Sydney;

It is proposed...

That from and after the 1st day of October next, the said Act, as amended by the Act, 2 VICTORIA, No. 25, shall be in force and have effect only within that part of the town of Sydney, which is comprised within certain limits by the Bill prescribed.

That the Surveyor or Surveyors duly appointed under the said first recited Act shall recover any fees which either now are, or hereafter may be due to him or them, by plaint in the usual manner in the Court of Requests in the said town; provided, that no fees shall be so recovered, due, or claimed to be due, in respect of any buildings situate beyond and outside the boundary by the Bill prescribed as aforesaid.

2. "A Bill to amend an Act, intituled, An Act " for consolidating and amending the laws re-" lating to the Licensing of Public-houses, and " for further regulating the Sale and Consumption of Fermented and Spirituous
Liquors in New South Wales."

Whereas, it is expedient to authorise the Governor to extend the operation of certain provisions of the said recited Act to such places as the Governor shall, from time to time declare, by notice in the Government Gazette; and whereas, in seasons of drought and scarcity of grain, it is deemed expedient to extend certain other provisions of the said Act to Beer made from sugar by any proprietor or occupier of any lands for the use of his own establishment; It is proposed-That from and after the passing of the proposed Act, nothing in the said recited Act contained shall be construed to apply to any person within such places in the Colony of New South Wales, as the Governor, by notice to be published in the Government Gazette shall declare to come under the operation of the second section of the said recited Act; nor to any person who, in seasons of drought and scarcity, shall brew Beer from sugar for the use of his own establishment, and who may give the same in part payment of wages to laborers on lands owned or rented by him, any law to the contrary in anywise notwithstanding.

3. " A Bill to allow the Aboriginal Natives of a New South Wales to be received as competent "Witnessess in Criminal Cases."

evidence of the aboriginal natives of the Colony should be receivable in all Courts of Criminal

That every aboriginal native of the Colony shall be permitted to make an affirmation or declaration instead of taking an oath in any criminal proceedings that shall be instituted in said Colony, and that the evidence so given shall be of so much weight only as corroborating circumstances may entitle it to.
