PROCLAMATION.

By His Excellency SIR GEORGE GIPPS, Knight, Captain General and Governor in Chief of the Territory of New South Wales and its Dependencies, and Vice Admiral of the same, &c. &c. &c.

HEREAS, by an Act of the Governor and Council of New South Wales, passed in the fourth year of the Reign of Her present Majesty, intituled "An Act for the Regulation of Gaols, Prisons, and Houses of Correction in the Colony of New South Wales and its Dependencies, and for other purposes relating thereto," it is enacted, That all Buildings, Erections, Houses, and Premises, which should hereafter be erected, built, purchased, enlarged, or maintained at the public expense, as and for public Gaols, Prisons, and Houses of Correction within the said Colony and its Dependencies, and which should, by Proclamation, to be from time to time published in the New South Wales Government Gazette, by order of the Governor for the time being of the said Colony, be declared and notified as such public Gaols, Prisons, or Houses of Correction, should, from and after the publication of such notification, be severally deemed and taken to be the public Gaol, Prison, or House of Correction, of the place or District where the same was or should be situated within the said Colony or its Dependencies, respectively, and should be subject to the several provisions thereinafter made for the regulation, management, care, and discipline of the public Gaols, Prisons, and Houses of Correction belonging to the said Colony and its Dependencies, and of the Prisoners confined within the

Now, therefore, I, the Governor, by virtue of the said recited Act, and in furtherance of the power and authority thereby in me vested, do hereby proclaim, declare, and notify the building, known as the Eastern Watch House, at the angle of Stephen-street and Collins-lane, in the Town of Melbourne, in the District of Port Phillip, to be a public Gaol, Prison, and House of

Mr. Thomas Cowper, in charge of a Ticket of | of public monies will pay over to the Colonial Trea-Leave holder, named Edmund Ireland, and an Aboriginal Native, and the other a Horse Dray belonging to Mr. Samuel Bawtree, in charge of two free men, named William Fraser, senior and junior, are supposed to have been Robbed near Bargo, and some of these persons Murdered;-His Excellency the GOVERNOR directs it to be notified, that a Reward of Twenty-five Pounds will be paid to any Free Person or Persons who may give such information as shall lead to the conviction of the Party or Parties by whom the Drays may have been Robbed, and any of the persons in charge of them, Murdered; and that if the party giving such information be a Prisoner of the Crown, application will be made to Her Majesty for the allowance of a Conditional Pardon to such Prisoner of the Crown.

The Drays were last seen at an encampment between Lupton's lan and the Lock-up House, on the 8th November last, where one of them has since been found secreted in the Bush; and it is stated that Mr. Cowper's Dray was seen in possession of a man named John Snelling, per Lady Feversham, in 1830, a description of whose person is appexed.
