By His Excellency SIR GEORGE GIPPS, Knight,
Captain-General and Governor-in-Chief of
the Territory of New South Wales and its
Dependencies, and Vice-Admiral of the same,
with the advice of the Legislative Council.

*"An Act to prohibit Shooting for sport, pleasure,
or profit, on Sunday."*

WHEREAS the practice of Shooting, on
the Lord's Day, at Pigeon Matches,
Preamble. and for pleasure or profit, greatly
prevails in some parts of the Colony, to the
manifest dishonour of Religion; and whereas it is
expedient to prohibit so scandalous and indecent
a practice, and to punish persons who may be
guilty of so offending: Be it therefore
Penalty for enacted, by His Excellency the Go-
Shooting on verner of New South Wales, with
Sunday. the advice of the Legislative Council
thereof, That from and after the passing and
publication of this Act, any person who shall be
found engaged in Shooting, at any Pigeon Match,
or for pleasure, sport, or profit of any kind what-
ever, on Sunday, or who shall be found carrying
Fire Arms on that day, except as hereinafter
provided, shall be deemed guilty of a Misdemeanor,
and on conviction before any Justice of the Peace,
shall forfeit and pay a penalty or sum of not more
than Five Pounds, nor less than Forty Shillings;
and it shall be lawful for any
Persons offend- Constable, without any Warrant or
ing may be other authority than this Act, to
arrested. arrest any person who shall be
found Shooting, or carrying Fire Arms, contrary
to the provisions hereof, and such person to convey,

with all convenient dispatch, before a Justice of
the Peace, to be dealt with according to Law.

*(Not to extend to Travellers or Constables carrying
Fire Arms for protection.)*

II. Provided always, and be it enacted, That
nothing in this Act contained shall be deemed to
extend to Travellers, *bona fide* carrying Fire Arms
for the protection of their lives and property, or
the property of their employers, on the public
roads of the Colony, or to Constables and other
persons carrying Fire Arms for lawful purposes.

(Limitation of Prosecutions)

III. And be it enacted, That no person shall
be prosecuted for any offence under this Act, unless
the prosecution shall be commenced within ten
days next after the time the offence shall have
been committed.

(Recovery and application of Penalties.)

IV. And be it enacted, That the Penalties
imposed by this Act shall be recovered and applied,
and may be appealed against, in the manner
directed in an Act of the Governor and Legis-
lative Council of New South Wales, passed in the
fifth year of the Reign of His late Majesty King
William the Fourth, intituled "*An*

By His Excellency SIR GEORGE GIPPS, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales, and its Dependencies, and Vice-Admiral of the same, with the Advice of the Legislative Council.

“ *An Act for applying certain Sums arising from the Revenue receivable in New South Wales, to the Service thereof, for the year one thousand eight hundred and forty-two, and for further Appropriating the said Revenue.* ”

WHEREAS, by a certain Act of Parliament Preamble, passed in the ninth Year of the Reign of His late Majesty King George the 4th, intituled, “ *An Act to provide for the Administration of Justice in New South Wales and Van Diemen’s Land, and for the more effectual Government thereof, and for other purposes relating thereto* ” it was among other things enacted, that all and every the powers and authorities vested by certain other Acts of Parliament therein referred to, or either of them, in the Governor of New South Wales, or the person administering the Government thereof, should thenceforth be vested in and exercised by the said Governor, acting with the advice and consent of the Legislative Council of the said Colony; and that the produce of the several Duties imposed and made payable under and by virtue of the said recited Acts therein referred to, and also under and by virtue of that Act, should be applied in such manner and to such purposes as the said Governor and Council should from time to time by any Law or Ordinance appoint: Be it therefore enacted, by His Excellency the Governor of New South Wales, with the advice and consent of the Legislative Council thereof, That out of the sum of sixty-eight thousand and fifty-six pounds, and eight shillings, being the excess of the amount appropriated for the service of the year One thousand eight hundred and forty, (after deduction of two thousand five hundred and thirty-six pounds voted towards indemnifying the late Thomas Moore, Esq., for the loss he sustained by the sale of the Burwood Estate, under a Commission from Governor Macquarie, which has been applied for by, and

paid to his Executors,) there shall and may be issued and applied, any sum or sums of money not exceeding twenty-two thousand three hundred and ninety-nine pounds, one shilling, and nine-pence, to supply deficiencies in the amount appropriated for certain Departments and Services for the said year; and any sum or sums of money not exceeding two thousand three hundred and ten pounds, and thirteen shillings, to meet deficiencies in the amount appropriated for the District of Port Phillip, for the said year.

(*There shall and may be issued and applied £12935 8s. 11d. for the Supplementary Expenditure of the Establishments at Port Phillip, for the year 1841, viz:—*)

II. And be it enacted, That out of the produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not

exceeding twelve thousand nine hundred and thirty-five pounds, eight shillings, and eleven pence, to defray the Supplementary charge on the Colonial Treasury, for the year One thousand eight hundred and forty-one, of the undermentioned Establishments at Port Phillip, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding eight pounds, nine shillings and four pence, to defray the supplementary expence of the Establishment of His Honor the Superintendent; and any sum or sums of money not exceeding two hundred and twelve pounds, and ten shillings, to defray the supplementary expence of the Post Office Department; and any sum or sums of money not exceeding forty pounds, to defray the supplementary expence of the Department of the Harbour Master; and any sum or sums of money not exceeding eight hundred and twenty-two pounds, eleven shillings and eight pence, to defray the supplementary expence of the Surveyor General’s Department; and any sum or sums of money not exceeding fifty-nine pounds, six shillings, and three pence, to defray the supplementary expence of the Department of Public Works; and any sum or sums of money not exceeding eight thousand pounds, as a supplementary aid towards the erection of a Gaol, at Melbourne; and any sum or sums of money not exceeding one thousand nine hundred and seventy-five pounds, eight shillings, and four pence, to defray the supplementary expence of the Supreme Court; and any sum or sums of money not exceeding three hundred and seventy-eight pounds, sixteen shillings and eight pence, to defray the supplementary expence of the Sheriff’s Department; and any sum or sums of money not exceeding three hundred and thirty pounds, sixteen shillings and eight pence, to defray the supplementary expence of the Court of Requests; and any sum or sums of money not exceeding ninety-five pounds, five shillings, to defray the supplementary expence of the Police, at Geelong; and any sum or sums of money not exceeding three hundred and fifty pounds, seven shillings, and six pence, to defray the supplementary expence of the Police at the Grange; and any sum or sums of money not exceeding four hundred and eleven pounds, seventeen shillings and six pence, to defray the supplementary expence of the Water Police; and any sum or sums of money not exceeding two hundred and fifty pounds, to defray the supplementary expence of the Ecclesiastical Establishments.

(*There shall and may be issued and applied £53,101 15s. 8d. for the Civil Establishment for the year 1842, viz:—*)

III. And be it enacted, that out of the produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not exceeding fifty-three thousand one hundred and one pounds, fifteen shillings, and eight pence, for defraying the charge of the Civil Establishment of New South Wales, for the year One thousand eight hundred and forty-two, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding five hundred and eighty pounds, one shilling, and three pence, to defray the expence of the establishment of His Excellency the Governor; and any sum or sums of money not exceeding one thousand four hundred and sixty-five pounds, eighteen shillings,

(There shall and may be issued and applied £17,951 0s. 10d. for the Surveyor General's Department, for the year 1842;—)

IV. And be it enacted, That out of the produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not exceeding seventeen thousand nine hundred and fifty-one pounds, and ten-pence, for defraying the charge of the Surveyor General's Department, in the said Colony, for the year One thousand eight hundred and forty-two.

(There shall and may be issued and applied £58,574 2s. 4d. for the Department of Public Works and Buildings for the year 1842, viz:—)

V. And be it enacted, That out of the produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not exceeding fifty-eight thousand five hundred and seventy-four pounds, two shillings, and four-pence, for defraying the charge of the Department of Public Works and Buildings, in the said Colony, for the year One thousand eight hundred and forty-two, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding sixteen thousand eight hundred and eighty-three pounds, twelve shillings, and four-pence, to defray the expence of the Department of the Colonial Engineer; and any sum or sums of money not exceeding seventeen thousand four hundred pounds, to defray the expence of Public Works; and any sum or sums of money not exceeding one thousand seven hundred and forty pounds, and ten shillings, to defray the expence of the Department of the Colonial Architect and Surveyor of Buildings; and any sum or sums of money not exceeding five thousand pounds, towards defraying the expence of erecting the New Government House, Sydney; and any sum or sums of money not exceeding four thousand pounds, towards defraying the expence of building the New Gaol and Court House, at Darlinghurst, Sydney; and any sum or sums of money not exceeding three thousand pounds, towards defraying the expence of building the New Gaol, Parramatta; and any sum or sums of money not exceeding two thousand pounds, towards building a Water Police Office, and an Office for the Harbour Master, Sydney; and any sum or sums of money not exceeding four hundred and fifty pounds, towards building a Court and Lock-up House, at Ailsa; and any sum or sums of money not exceeding seven hundred pounds, towards building Lock-up Houses at Kiama and Dungog, being three hundred and fifty pounds for each; and any sum or sums of money not exceeding three hundred and fifty pounds, to-

wards building Solitary Cells, at Scone; and any sum or sums of money not exceeding two hundred and fifty pounds, towards completing and fitting up the Court and Watch-house, at Newcastle; and any sum or sums of money not exceeding two hundred and fifty pounds, towards building a Court and Watch House, at Murrurundi; and any sum or sums of money not exceeding two thousand four hundred pounds, towards building Barracks and Stables for the Mounted Police, at Emu Ferry, Hartley, Berrima, Yalbret, Murrurundi, and Ailsa, being four hundred pounds for each; and any sum or sums of money not exceeding seven hundred pounds, towards building a Barrack and Stables for the Mounted Police, at Goulburn; and any sum or sums of money not exceeding three hundred and fifty pounds, towards building Solitary Cells, at Newcastle Gaol; and any sum or sums of money not exceeding seven hundred and fifty pounds, towards increasing the accommodation at the Lunatic Asylum, Tarban Creek; and any sum or sums of money not exceeding two thousand pounds, towards defraying the expence of casual repairs to Government Houses, Courts of Justice, and other Public Buildings; and any sum or sums of money not exceeding three hundred and fifty pounds, to defray the Salary of the District Surveyor of Buildings, Sydney.

(There shall and may be issued and applied £26,023 16s. 8d. for the Judicial Establishment for the year 1842, viz:—)

VI. And be it enacted, That out of the produce of the said Duties there shall and may be issued and applied, any sum or sums of money not exceeding twenty-six thousand and twenty-three pounds, sixteen shillings, and eight pence, for defraying the charge of the Judicial Establishment of the said Colony, for the year One thousand eight hundred and forty-two, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding six thousand eight hundred and eighty-nine pounds, one shilling and eight pence, to defray the expence of the Supreme Court; and any sum or sums of money not exceeding five thousand nine hundred and eighty-four pounds, and ten shillings, to defray the expence of the Law Officers of the Crown; and any sum or sums of money not exceeding four thousand seven hundred and seventy-eight pounds, to defray the expence of Courts of Quarter Sessions; and any sum or sums of money not exceeding one thousand nine hundred and sixteen pounds, eighteen shillings, and nine pence, to defray the expence of Courts of Requests, for the County of Cumberland, and District of Wollongong; and any sum or sums of money not exceeding one thousand two hundred and twenty pounds, to defray the expence of Courts of Requests for other Counties and Districts; and any sum or sums of money not exceeding three thousand three hundred and forty-six pounds, eight shillings, and nine-pence, to defray the expence of the Sheriff's Department; and any sum or sums of money not exceeding one thousand eight hundred and eighty-eight pounds, seventeen shillings, and six-pence, to defray the Salaries of Coroners, and the expence of Inquests.

VII. And be it enacted, That out of the produce

(There shall and may be issued and applied £4,520 10s. 3d. for the Colonial Medical Establishment for the Year 1842, viz:—)

X. And be it enacted, That out of the produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not exceeding four thousand five hundred and twenty pounds, ten shillings, and three pence, for defraying the charge of the Colonial Medical Establishment of the said Colony, for the year One thousand eight hundred and forty-two, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding three hundred and thirty-five pounds, to defray the Salaries and contingent expences of the Health Officer, and Clerk to the Medical Board; and any sum or sums of money not exceeding one thousand six hundred and eighty-five pounds, ten shillings, and three pence, towards the support of the Lunatic Asylum; and any sum or sums of money not exceeding two thousand five hundred pounds, to defray the expence of the support of Free Paupers, in the Colonial Hospitals.

And be it enacted, That out of the produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not exceeding thirteen thousand three hundred and five pounds, for defraying the charge of Miscellaneous Services of the said Colony, for the year One thousand eight hundred and forty-two, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding one thousand pounds, to defray the expence of the Commission for hearing and determining on Claims to Grants of Land; and any sum or sums of money not exceeding one thousand pounds, to defray the expence of the Management of the Clergy and School Estates; and any sum or sums of money not exceeding two hundred pounds, towards the support of the Sydney School of Arts; and any sum or sums of money not exceeding two thousand pounds, to defray the expence of Stationery, Bookbinding, Gazettes, and Almanacks for the several Colonial Departments; and any sum or sums of money not exceeding three thousand pounds, for providing Furniture for the New Government House, Sydney; and any sum or sums of money not exceeding six hundred pounds, to defray the expence of Furniture for Government Houses, and Public Offices; and any sum or sums of money not exceeding six hundred pounds, to defray the expence of Fuel and Light for the several Colonial Departments; and any sum or sums of money not exceeding three hundred pounds, to defray the expence of conveying Stores to the several Public Departments; and any sum or sums of money not exceeding three hundred pounds, to defray the expence of Lighting the Government Lamps in the town of Sydney; and any sum or sums of money not exceeding one hundred and five pounds, to defray the expence of Firemen, to work the Engines in Sydney when required; and any sum or sums of money not exceeding two hundred pounds, to defray the expence of the Passage of Convicts transported to Van Diemen's Land; and any sum or sums of money not exceeding four thousand pounds, to meet Unforeseen expences, on occasions of emergency, and to be hereafter accounted for.

XIII. And be it enacted, That out of the

produce of the said Duties, there shall and may be issued and applied, any sum or sums of money not exceeding eighty-seven thousand one hundred and twelve pounds, fourteen shillings, and eight-pence, for defraying the charge of the undermentioned Establishments and Public Works and Buildings at Port Phillip, for the year One thousand eight hundred and forty-two, as hereinafter more particularly expressed; that is to say, any sum or sums of money not exceeding one thousand five hundred and thirty-one pounds, eight shillings, and nine-pence, to defray the expence of the Establishment of His Honor the Superintendent of the District of Port Phillip; and any sum or sums of money not exceeding one thousand and fifty-two pounds, and five shillings, to defray the expence of the Establishment of the Sub-Treasurer; and any sum or sums of money not exceeding four thousand two hundred and sixty-nine pounds, sixteen shillings, and three pence, to defray the expence of the Establishment of Customs, at Melbourne, William's Town, and Geelong; and any sum or sums of money not exceeding seven hundred and thirty-two pounds, and five shillings, to defray the expence of the Customs Establishment, at Portland Bay; and any sum or sums of money not exceeding two thousand, two hundred, and nine-pence, to defray the expence of the Post Master General's Establishment; and any sum or sums of money not exceeding one thousand, one hundred, and eighty-four pounds, twelve shillings, and six-pence, to defray the expence of the Establishment of the Harbour Master; and any sum or sums of money not exceeding seven hundred and thirty pounds, eleven shillings, and eight-pence, to defray the expence of Light-Houses; and any sum or sums of money not exceeding eleven thousand, six hundred, and ninety-three pounds, to defray the expence of the Surveyor-General's Establishment; and any sum or sums of money not exceeding five thousand, one hundred and ninety-two pounds, one shilling, and eight pence, to defray the expence of Public Works; and any sum or sums of money not exceeding two thousand pounds, towards defraying the expence of forming a Public Quay or Wharf, at Melbourne; and any sum or sums of money not exceeding one thousand pounds, towards defraying the expence of forming a Wharf at Portland Bay; and any sum or sums of money not exceeding five hundred pounds, towards defraying the expence of forming a Wharf, at Geelong; and any sum or sums of money not exceeding five hundred pounds, towards defraying the expence of constructing a Dam across the Yarra Yarra; and any sum or sums of money not exceeding five thousand pounds, towards defraying the expence of erecting a Gaol, at Melbourne; and any sum or sums of money not exceeding six thousand, five hundred pounds, towards defraying the expence of erecting a Court House, at Melbourne; and any sum or sums of money not exceeding two thousand pounds, towards defraying the expence of building a Police Office, at Melbourne; and any sum or sums of money not exceeding four thousand pounds, towards defraying the expence of building Offices, for His Honor the Superintendent, and for the Sub-Treasurer; and any sum or sums of money not exceeding two thousand pounds, towards defraying the expence of building an Office for the Survey Department and any sum or sums of

money not exceeding one thousand, five hundred pounds, towards defraying the expence of erecting a Police Office, at Geelong; and any sum or sums of money not exceeding one thousand pounds, towards defraying the expence of erecting a Custom House, at Geelong; and any sum or sums of money not exceeding one thousand pounds, towards defraying the expence of erecting a Watch House, at Portland Bay; and any sum or sums of money not exceeding three thousand pounds, towards defraying the expence of erecting Light Houses; and any sum or sums of money not exceeding one thousand seven hundred and seventy-five pounds, to defray the expence of the Supreme Court Establishment; and any sum or sums of money not exceeding six hundred and thirty-five pounds, to defray the expence of the Sheriff's Establishment; and any sum or sums of money not exceeding four hundred and sixty-five pounds, to defray the expence of Courts of Requests, at Melbourne and Geelong; and any sum or sums of money not exceeding one hundred and eighty pounds, to defray the Salary of a Coroner, and the expence of Inquests; and any sum or sums of money not exceeding two thousand seven hundred and fifty-nine pounds, four shillings, and three pence, to defray the expence of Police at Melbourne, Newtown, and William's Town; and any sum or sums of money not exceeding one thousand one hundred and twenty-four pounds, eighteen shillings, and nine pence, to defray the expence of the Police at Geelong; and any sum or sums of money not exceeding one thousand and forty-nine pounds, eighteen shillings, and nine pence, to defray the expence of the Police at Portland Bay; and any sum or sums of money not exceeding three hundred and fifty pounds, seven shillings, and six pence, to defray the expence of the Police at the Grange; and any sum or sums of money not exceeding one thousand and fifty-five pounds, two shillings, and six-pence, to defray the expence of the Water Police; and any sum or sums of money not exceeding five thousand five hundred and forty pounds, one shilling, and eight pence, to defray the expence of the Mounted Police; and any sum or sums of money not exceeding four thousand two hundred and seventy-three pounds, two shillings, and six-pence, to defray the expence of the Border Police; and any sum or sums of money not exceeding one thousand three hundred and seventy-three pounds, twelve shillings, and one penny, to defray the expence of the Gaol at Melbourne; and any sum or sums of money not exceeding four thousand six hundred pounds, (including three thousand pounds, towards the erection of Churches and Ministers' Dwellings, on condition of sums to an equal amount being raised by private contributions,) to defray the expence of the Ecclesiastical Establishments; and any sum or sums of money not exceeding seven hundred and fifty pounds, in aid of the establishment of Schools, and towards their support; and any sum or sums of money not exceeding five hundred pounds, five shillings, and ten pence, to defray the expence of the Medical Establishment; and any sum or sums of money not exceeding two thousand pounds, to defray the expence of stationery, Printing, and Bookbinding, for the several Public Departments, and of Furniture, Fuel, and Light, for the several Public Offices.

(Treasurer to pay the above at such times as the Governor by Warrant shall order.)

XIV. And be it enacted, That the Treasurer of the said Colony shall issue and pay the said several sums, to such persons, for the purposes hereinbefore mentioned, upon such days, and in such proportions, as the governor for the time being, by any Warrant or order in writing, to be signed by him, shall from time to time order and direct; and that the payments so to be made, shall be charged upon, and payable out of, the Revenues of the said Colony.

(And to receive credit in his Accounts for payments made in pursuance thereof.)

XV. And be it enacted, That the said Treasurer shall, in his Accounts, from time to time, be allowed credit for any sum or sums of money paid by him in pursuance of such Warrant or Order in writing as aforesaid; and that the receipt or re-

ceipts of the respective persons to whom the same shall be so paid, shall be a full and valid discharge to the said Treasurer, in passing his said Accounts, for any such sum or sums as shall be therein mentioned; and that he shall and do receive credit for the same accordingly.
