No.1.—" A Bill to declare that an Act, passed in the present Session of the Governor and Legislative Council of New South Wales, to Incorporate the City of Sydney, may at any time be altered, amended, or repealed."

It being expedient to remove any doubt as to the power of the Council at any time to alter or repeal the Sydney Corporation Act, 6 Victoria, No. 3:-

It is proposed to declare, that nothing contained in that Act shall at any time be held to prevent the alteration or repeal of the whole or any part of

No. 2 .- "A Bill to amend Schedule C of an Act intituled 'An Act for appointing and empowering Commissioners to examine and report upon claims to grants of land, under the Great Seal of the Colony of New South Wales."

It being expedient to amend so much of Schedule C of 5 William IV., No. 21, as relates to the fee on final Reports, payable to the Secretary of the Commissioners:

It is proposed that the fee to be received by the said Secretary for every final Report shall be Four Pounds Three Shillings, instead of Two Pounds.
