CHURCH GRANTS.

THE following descriptions of Town Allotments which have, from time to time, been appropriated to the purposes of the Presbyterian Church, as hereunder more particularly mentioned, are published for general information, in order that all parties concerned may have an opportunity of correcting any errors or omissions that may have been made inadvertently—being in addition to the allotments advertised on 1st October, 1842, and 1st March, 1843.
