PROCLAMATION.

By His Excellency SIR GEORGE GIPPS, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

HEREAS by my Proclamation, bearing date the tenth day of April last, a Sale by Auction of certain Town Allotments of Land, numbered from 1 to 52 inclusive, was advertised to be held at Eleven o'clock of Thursday, the 15th day of June instant, at the Colonial Treasury, in Sydney; and whereas it is expedient to postpone the Sale until the Election of Members for the Legislative Council for the City of Sydney shall have been completed:—Now I, Sir George Gipps, the Governor aforesaid, in pursuance of the powers in me vested, do hereby proclaim, that the several Town Allotments of Land, enumerated in the above-mentioned Proclamation, shall be offered for sale on Friday, the 16th instant, at the hour and place before stated.

PROCLAMATION.

By His Excellency SIR GEORGE GIFFS, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

HEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the sixth year of the reign of Her present Majesty Queen Victoria, intituled, "An Act to consolidate and "amend the Laws relating to Courts of Requests," and extend the jurisdiction of such Courts in the "county of Cumberland," it was amongst other things

enacted, that from and after the first day of January, One thousand eight hundred and forty-three, Courts of Requests should be holden in and for such counties and districts, or other portions of this Colony and its Dependencies, and at such places respectively, as the Governor should, by Proclamation for that purpose, from time to time appoint:—Now I, Sir George Gipps, the Governor aforesaid, in pursuance of the power and authority so vested in me by the said recited Act, do hereby direct and appoint, that Courts of Requests shall be holden, in future, for the county of Bourke, at the town of Melbourne, on the first Mondays, and following days of each Month, in the present and every succeeding year.

NOTICE TO MARINERS.

LITTLE ROSS ISLAND LIGHT HOUSE.

Edinburgh, 16th November, 1842.

THE Commissioners of Northern Light Houses hereby give notice, that a Light House has been erected upon the summit of the Little Ross Island, in the stewartry of Kirkcudbright, the light of which will be exhibited on the night of the 1st day of January, 1843, and every night thereafter from sun-set till sun-rise.

The following is a specification of the position of the Light House, and the appearance of the Light,

by Mr. Stevenson, Engineer:

The Little Ross Island lies off the entrance of Kirkcudbright Bay and Harbour, in lat. 54 ° 46' North, and long. 4 ° 5' West.

By compass the Light House bears from Burrow Head, in Wigtonshire, E., distant 12 miles; from the point of Ayre Light House, in the Isle of Man, N. E. 3 E., distant 23 miles; from St. Bee's Head Light House, in Cumberland, N. N. W. 1 N., distant 23 miles; from Abbey Head, Kirkcudbrightshire, W. N. W., distant 3½ miles.

The Little Ross Light will be known to Mari-36. Durham, 640, Six hundred and forty acres, I ners as a revolving light, producing a bright flash of light, of the natural appearance, once in every 5 seconds of time, or 12 flashes a minute.

The lantern, which is open from N. b. E. round to N. W. b. W. southerly, is elevated 175 feet above the level of the sea. In clear weather the flashes will be seen at the distance of 6 leagues, and at lesser distances according to the state of the atmosphere; and, in favourable circumstances, the light will not wholly disappear between the flashes at lesser distances.

And the Commissioners hereby further give notice, that by virtúe of a warrant from the Queen in Council, of date the 2d day of November instant, the following tolls will be levied, in respect of this light, from all vessels navigating the Solway Frith to or from ports or places to the Eastward of St. Bee's Head and the Mull of Galloway, viz., for every vessel belonging to the United Kingdom of Great Britain and Ireland (the same not belonging to Her Majesty or being navigated wholly in ballast), and for every Foreign vessel privileged as British the same not being navigated wholly in ballast, the toll of one halfpenny per ton of the burden of every such vessel, and for every Foreign vessel, not so privileged, the toll of one penny per ton.
