HIS Excellency the GOVERNOR directs the republication of the following Notice from the London Gazette Extraordinary, of the 25th April last:—

" Buchingham Palace, 25th April, 1843.

"This morning, at five minutes past four, the Queen was happily delivered of a Princess;—His Royal Highness Prince Albert, several Lords of Her Majesty's most Honorable Privy Council, and the Ladies of Her Majesty's Bed-Chamber, being present.

"This great and important news was immediately made known to the Town by the firing of the Park and Tower Guns; and the Privy Council being assembled as soon as possible thereupon, at the Council Chamber, Whitehall, it was ordered, that a Form of Thanksgiving for the Queen's safe delivery of a Princess be prepared by His Grace the Archbishop of Canterbury, to be used in all churches and chapels throughout England and Wales, and the Town of Berwick-upon-Tweed, on Sunday the 30th of April, or the Sunday after the respective Ministers shall receive the same.

"Her Majesty and the Infant Princess, are, God

be praised, both doing well."

In consequence of the receipt of this important and gratifying intelligence, the Royal Standard will be hoisted at Dawes' Battery at sunrise to-morrow, and at noon a Royal Salute will be fired from Fort Macquarie.

Executive Council Chamber, Sydney, 21st August, 1843. SYDNEY STREETS.

HEREAS, by an Act of the GOVERNOR, with the advice of the Legislative Council, passed in the fifth year of the reign of His late

Majesty King William the Fourth, intituled, "An "Act for better regulating the alignment of Streets "in the Town of Sydney," it is amongst other things enacted, that before the Surveyor General shall set out the footway in any street, or part of a street, or public place in the said Town, after the passing of the said Act, he shall lay before the Governor and Executive Council a plan of the same, setting forth the proposed breadth of the carriage and footways; and thereupon it shall and may be lawful for the said Governor and Council, by notice in the New South Wales Government Gazette, to fix and declare the distance from the curb stone or exterior edge of the said footway in any such street, part of a street, or public place, within which it shall not be lawful to erect any building.

And whereas the said Surveyor General has this day laid before the Governor and Executive Council, a plan of the proposed breadth of the carriage and footways in the undermentioned street, and the Governor and Council have been pleased to approve the same:—Notice is hereby given, that the breadth of each of the footways in the said street shall be, and is hereby declared to be five feet, and that it shall not be lawful for any person to erect any building within five feet of the curb stone, or exterior edge of either of the said footways in the said street.
