PROCLAMATION.

By His Excellency SIR GEORGE GIPPS, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

N pursuance of the authority in me vested, by a certain Act of the Imperial Parliament of Great Britain and Ireland, passed in the 5th and 6th year of Her Majesty's Reign, intituled "An "Act for regulating the sale of Waste Land be "longing to the Crown in the Australian Colonies; I do hereby notify and proclaim, that at 11 o'clock of Wednesday, the 10th day of December next, the following Portions of Land will be offered for Sale by Public Auction, at the Colonial Treasury, in Sydney, at the upset price affixed to each lot respectively, on the terms and conditions, and under the provisions of the above recited Act. WRIT OF ELECTION.

ITH reference to the Notice from this Office, dated the 19th day of September last, in which it was intimated that a Writ had been returned to His Excellency the GOVERNOR certifying the return of Patrick Grant, Esquire, to serve in the Legislative Council, for the Electoral District of the

Northumberland Boroughs, in the room of D'Arcy Wentworth, Esquire, resigned; His Excellency directs it to be notified, for general information, that a question having arisen, whether the seat vacated by the resignation of D'Arcy Wentworth, Esquire, was still vacant, such question was referred for the determination of the Legislative Council, in accordance with the 18th section of Act of the Imperial Parliament of Great Britain and Ireland, passed in the 5th and 6th year of Her Majesty's reign, intituled, " An Act for the Government of New South Wales "and Van Diemen's Land," and the Legislative Council, by a Message dated the 29th instant, has conveyed to His Excellency the following Resolution adopted by the Council on the same day, viz. :--

"That the seat which was vacated by the resigna-"tion of D'Arcy Wentworth, Esquire, whose resig-"nation was notified for general information in the " Government Gazette of the 19th August, 1845, "and on the occasion of which vacancy, a Writ for "the holding of a new Election was addressed, on "the 18th August, 1845, to Edward Denny Day, "Esquire, the Returning Officer of the Electoral " District of the Northumberland Boroughs, is still " vacant."

WITH reference to an advertisement, dated the 15th July last, His Excellency the GOVERNOR has been pleased to direct it to be notified, that the Government House and Domain, at Parramatta, will be let in two lots, as described hereunder; and that Tenders from persons disposed to rent the same, will be received at this Office, at any time not later than Twelve o'clock, on Saturday, the 15th November

The first lot will comprise the entrance lodge, dwelling house, offices, stabling, garden, dairy. men's huts, and farm buildings, with the whole of the land formerly attached thereto, and charted on the map in the Surveyor General's Office, as the Government Domain, containing about one thousand

From this lot the following buildings will be excluded, being reserved for the use of the persons at present occupying them, viz. :--

In the event of a difference of opinion between the Contractor and the party receiving the supplies, as to the quality, the same is to be decided, in cases where the article is not of a perishable nature, by a Board of Survey, composed by persons named by the Government, according to the practice of the service. But in country districts, where such a Board of Survey cannot be conveniently assembled, the party objecting will name one person as arbitrator, the Contractor or his agent another, and these two will (previously to any other proceeding on their part,) concur in naming a third as umpire, who, in the event of the arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final.

If the board, arbitrators, or umpire, shall decide that the article is not of proper quality, it must be immediately replaced by the Contractor, failing of which, it will be procured by the Department requiring it, and the expense charged to the Contractor.

In the event of any unnecessary delay, or

failure of the Contractor to supply the articles when required, they will be otherwise pro-

cured, and charged in like manner.

In cases where the article is of a perishable nature, or from some other cause injury would be sustained, either by the parties to whom the Rations are due, or to the Contractor, by waiting for a Board of Survey, the head of the Department, or Officer in charge of the party or parties for whom the Rations are to be received, shall have power to reject such article or articles as are obviously of inferior quality; it being distinctly understood, that he will be responsible to the Government for so doing; and that the Contractor will have a right to appeal to the Governor, although, in the mean time, he must take back the rejected article, and supply good in its stead, failing of which, it will be obtained by the Officer or party requiring it, and the expense charged to the Contractor.

A repetition of irregularity in the quality or quantity of the supplies, or of any delay in delivering or replacing them when required, will also subject the Contractor, upon the Report of the Officer in charge of the parties or establishment, to such mulct, not exceeding one-fourth the amount of his monthly account, as the Governor may direct. It will also be in the power of the Governor, upon such repetition, to terminate the Contract

orthwith.

A repetition of irregularity in the quality or quantity of the supplies, or of any delay in delivering or replacing them when required, will also subject the Contractor, upon the Report of the Officer in charge of the parties, to such mulct, not exceeding onefourth the amount of his monthly account, as the Governor may direct. It will also be in the power of the Governor, upon such repetition, to terminate the Contract forthwith.
