CLAIMS TO LEASES OF CROWN LANDS,

BEYOND THE SETTLED DISTRICTS.

LIVERPOOL PLAINS DISTRICT.

Its Excellency the GOVERNOR directs it to be riotified, for the information of all persons interested, that in pursuance of Her Majesty's Order in Council, of 9th March, 1847, the undermentioned persons have demanded Leases of the several Runs of Crown Land, particularised in connexion with their respective names.

Persons who object to any of these claims, either wholly or in part, should lodge caveats at this Office within two months from the present date, specifying the Lands to which their objections extend, and the grounds on which their objections are based.

It is to be distinctly understood, that the Government does not pledge itself to the issue of a Lease in any case until due enquiry has been made into the validity of the claim, and whether or not it may be necessary to reserve any portion of the Land claimed, for any of the public purposes contemplated in the Order in Council.

Armitage J. T., & Co.

Name of Run—Barraba.

Estimated Area-45 square miles.

Estimated Grazing Capabilities—1,300 Cattle.

Bounded on the northern side by Iron bark Creek, commencing at its junction with the Manilla River to about 5 miles, when that creek divides into two branches; by a range of hills on the east, running northerly about 7 miles, which divides the waters of Iron bark Creek and those of Conner's Creek, which last runs through the station and falls into the Manilla River near the public house on the opposite side; by a range of hills running north-west about 7 miles to the public road, these hills divide the waters of Cobrada Creek with those of part of Conner's Creek and another unnamed creek which also runs through the station and also falls into the Manilla River, from the last mentioned range of hills by the public road about 41 miles to beyond the public house paddock crossing the river to a pond on the opposite bank at the junction of Conner's Creek with the river, and from that point by the river Manilla about 5 miles to its junction with Iron bark Creek. The Manilla River generally consists only of a few shallow standing pools of water and the creeks herein mentioned as running through the station being only channels for water in wet weather, or during rain, with the exception of one hole and the spring.

Name of Run—Bando Plains.

Estimated Area—50,000 Acres.

Estimated Grazing Capabilities—500 Cattle,
7,000 Sheep.

Commencing at the north end of Bando lagoon, bearing westerly about 1 a mile to the Bando Creek, from thence westerly across the plain by Bingle mountain about 3 miles, from thence by a range of hills bearing southerly to Tilibra mountains about 10 miles, separating this run from Mr. George Cox's run of Nomby, from Tilibra mountains along a ridge bearing easterly about 11 miles south of Tambour springs, and that line continued easterly to Bomera Creek, about 5 miles, dividing this run from Mr. Hale's run of Bomera; from thence on the east partly by Bomera Creek, and partly by Bando Creek, bearing northerly about 6 miles to within 11 miles of Wittytorundi; from thence by a line crossing between Tommy and Billy ridges, bearing about east 30 degrees, north about 4 miles, dividing this run from the late Sir John Jamieson's run of Merigalaw; from thence by a line down the plain bearing northerly about 3 miles, from thence by a line bearing westerly to Bando Lagoon Creek 4 miles, from thence by Bando Lagoon Creek, to the commencing point bearing northerly, separating this run from the bald hill run belonging to W. Allison.

Name of Run—Bald Hill.

Estimated Area—32,000 Acres.

Estimated Grazing Capabilities—4,000 Sheep.

Commencing at a point midway between the Lagoon Well and Bando Well on the Bando Lagoon Creek, and bounded on the west by that creek and the Bando Lagoon, separating this run from Bando plain run, then by a line from the north end of the lagoon, bearing westerly about 1 of a mile to Bando Creek; from thence on the west by the Bando Creek bearing northerly to the Milley ridges, separating this run from Mr. George Cox's run of Nomby, being a distance of about 6 miles; from thence on the north by the said Milley ridges, separating this run from Melville Plains' run held by Mr. Alfred Dennison, bearing easterly about 5 miles; from thence on the east by the western boundary of Mr. Ed. Sumner's run of Woondoobarr, bearing south-easterly to and through an impenetrable scrub about 25 miles on the north-east side of the Bald Hill being a distance of about 8 miles, from thence by a line across the plain separating this run from Trinkey run, held by Mr. Thomas Wiseman, bearing southwesterly about 5 miles, from thence by a line bearing north-westerly to a point midway on a line extending from the starting point at the Bando Lagoon to the Bald Hill, being a distance of about 4 miles, and from thence by the said line to the starting point at the Bando Lagoon, bearing westerly about 4 miles, separating this run from Bando run.

Name of Run—Black Creek.
Estimated Area—15,000 Acres.
Estimated Grazing Capabilities—4,000 Sheep.

Bounded on the north by a range of hills dividing it from Fitzgeralds run; on the west by the Liverpool Range; on the south and east by a range of hills, marked trees, and Surveyors' pass, dividing it from Hamilton's run.

No. 5.

Adams James Smith.

Name of Run—Yarraldool.

Estimated Area—30,000 Acres.

Estimated Grazing Capabilities—1,000 Cattle or
4,000 Sheep.

On the east by a line running north 5 miles, joining Messrs. Brown and Selwin's run, Bucklebone; on the north by a line 10 miles in extent running parallel with the Namoi River, as far as the western line; on the south by the Namoi River 10 miles in extent; on the west by a north and south line 5 miles in extent, parting it from Mr. Purcell's station.

No. 6.

Beattie and Taylor, (per John Taylor.)
Name of Run—Bundinbarrina.
Estimated Area—90,000 Acres.
Estimated Grazing Capabilities—2,000 Cattle.

Bundinbarrina is bounded on the north by a line commencing at a marked tree opposite the Pokataroo hut, and running back from the River Barwin in a westerly direction 6 miles, which line forms the south boundary of the Wirrabilla run; on the west by a line commencing at the extreme of the above line, and running in a southerly direction 26 miles; on the south by a line running in an easterly direction from the extreme of the western boundary to a marked tree at the Brothers' waterhole, which line forms the northern boundary of Mr. Hungerford's run; on the east by the River Barwin.

No. 7.

Blaxland Edward J., and Arthur, (now John Dobie and John Blaxland.) Name of Run—Kickerbell. Estimated Area—38,400 Acres. Estimated Grazing Capabilities—10,000 Sheep.

Bounded on the south and east by the boundary lines of the Australian Company; on the north by an east and west line dividing it from Mr. Holmes' run, commencing from the Darling holes, and crossing a gap in the mountains extending to the Spring Ridge; and on the west by a north and south line dividing it from Mr. Wyndham's station

Estimated Grazing Capabilities-5,000 Sheep.

Bounded on the east by a north and south line dividing it from Mr. Hamilton's station at Yaramemba; on the west by a north and south line dividing it from Mr. Hamilton's Black Creek station; on the north by the Australian Company's south side line; and on the south by the apex of the dividing range between Liverpool and Gammon

N.B.—This run has been transferred, with the sanction of the Government, to Messrs. John Dobie and John Blaxland, in whose favor the lease will accordingly be prepared.

No. 9.

Brodie Peter. Name of Run-Swamp Oak Creek. Estimated Area-51,200 Acres. Estimated Grazing Capabilities - 1,000 Cattle, 8,000 Sheep.

The valley of the Swamp Oak Creek, (one of the tributaries of the Peel) from its source in the great dividing range to the eastern boundary line of Mr. Henry Dangar, Moombi Creek, bounded on the north and south by mountain ranges, through which the Swamp Oak Creek with its tributaries run.

No. 10.

Browne John. Name of Run-Pullaming. Estimated Area-102,400 Acres. Estimated Grazing Capabilities-7,000 Sheep.

Bounded by Johnstone on the north and west, and by a marked tree line on the west dividing it from Mr. John Howe, senior, station, known as Carroll; on the south by Eales' Long Point station to a marked tree, from thence bearing southwest; and on the west by Sumner station and Melville Plains to a dry creek on the plains.

Brown and Selwyn. Name of Run-Ulah. Estimated Area-32,000 Acres. Estimated Grazing Capabilities-1,000 Cattle.

This Run is situated on the north bank of the Barwin river, about 18 miles below the confluence of the Namoi; it is a perfectly level country and bounded on the north by unoccupied Crown Lands; on the south by the river Barwin; on the east by a line north and south being the boundary line of Mr. Lawson's Run "Comboderryderry"; on the west by a line north and south being the boundary line of Mr. Abercrombie's run Miloray.

No. 12.

Brown and Selwyn. Name of Run-Bugilbone. Estimated Area-32,000 Acres. Estimated Grazing Capabilities-750 Cattle.

with the Barwin. It is a perfectly level country a Lagoon called Dungan or Ulled hole, indicated

and bounded on the north by unoccupied Crown Lands; on the south by the river Namoi; on the east by a line running north and south being the boundary line of Mr. Druitt's run Mille or Coega; on the west by a line running north and south being the boundary line of Messrs. Brown and Selwyn's run Berryabar; the water on this run is very uncertain, generally drying up between each flood in the river; in which case it becomes necessary to shift the cattle to the adjoining run Berryabar, which we likewise hold under License.

Brown and Selwyn. Name of Run-Berryabar. Estimated Area-32,000 Acres. Estimated Grazing Capabilities—950 Cattle.

This run is situated 5 miles on the north, and 5 miles on the south bank of the Namoi River; about 50 miles above its junction with the Barwin. It is a perfectly level country and bounded (the northern side) on the north by unoccupied Crown Lands; on the south by the river Namoi; on the east by a line north and south; being the boundary line of Messrs. Brown and Selwyn's run Bugilbone; on the west by a line north and south being the boundary line of Mr. Adam's run Yarraldool. The southern side; on the south by Mr. Capp's run on the Milchamie creek; on the north by the River Namoi; on the east by a line north and south, being the boundary line of Messrs. Patch and Glennie's run Pilica; on the west by a line north and south, being the boundary line of Mr. Evan's run Bunglegully; the water on this run will not last longer than 12 months, and depends upon floods in the river which are extremely uncertain.

No. 14.

Brown John and James. Name of Run-Waterloo Creek or Milley. Estimated Area—64,000 Acres. Estimated Grazing Capabilities—2,400 Cattle.

On the Waterloo Creek, bounded by the run of John Eckford on the east, and it is believed by Government Lands otherwise.

No. 15.

Button Charles. Name of Run-Burran. Estimated Area—38,400 Acres. Estimated Grazing Capabilities-1,000 Cattle.

Bounded on the west by a water hole called Buley, on Burran Creek and Gorion station; on the east by 10 miles frontage on each side of Burran Creek, from the commencing water hole Buley; on the south by Pine Creek, 3 miles; on the north 3 miles by unoccupied country and the station of Mr. Button. The water in Burran creek is not permanent.

Button John, Estate of, per H. and W. Dangar. Name of Run—Cubbaroo. Estimated Area-26,880 Acres. Estimated Grazing Capabilities-1,500 Cattle.

Bounded on the west by White's Drildool sta-This Run is situated on the north bank of the tion, on a line bearing north 6 miles, commencing Namoi river, about 60 miles above its junction from the Namoi River, and including a portion of by a marked tree on the bank of that Lagoon; on the north by unoccupied land on a line bearing east 7 miles; on the east by Messrs. Loader's Murrah station, bearing south 6 miles to the Namoi River; and on the south by that river to the commencing corner, having a frontage of 7 miles on the river, and including the Pine Creek in the back part of the run; the water in such creek not being permanent.

No. 17.

Button John, Estate of, per H. and W. Dangar. Name of Run—South Oreel. Estimated Area—30,720 Acres.

Estimated Grazing Capabilities—1200 Cattle.

Bounded on the east by a part of Henry Dangar's Bullerewi station, commencing from Thalaba creek at a marked tree on that creek, near the old hut, on a line south 4 miles; on the south by unoccupied country, on a line bearing west 12 miles; on the west by Gordon's Merruoinboon station, on a line north 4 miles to Thalaba creek; such line to include one half of a water in the creek called the Nine mile water hole; and on the north by Thalaba Creek, to the commencing corner.

Button John, Estate of, per H. and W. Dangar. Name of Run—Bullerawa.

Estimated Area—17,920 Acres.

Estimated Grazing Capabilities-600 Cattle.

Bounded on the east by Capps Bulgarry station, commencing from the River Namoi opposite to the Cabaroo station, bearing south 4 miles; on the south by a line bearing west through Briggaloo scrub 7 miles; on the west by John and William Dangar's Talaba station, bearing north 4 miles to the Namoi River, falling opposite the said Cabaroo station; and on the north by the Namoi River to the commencing corner including a frontage of 7 miles.

Name of Run—Attunga.
Estimated Area—40,960 Acres.

Estimated Grazing Capabilities—2,000 Cattle.

Bounded on the north by R. Pringle's boundary, commencing at a cattle camp at the lower end of Brady's Plain; bounded on the east by high stony ranges; bounded on the south by Jenkins line, Moonar Creek; bounded on the west by Peel's River 8 miles, containing an area of about 8 miles square.

No. 20.

Name of Run—Diniwarindi
Estimated Area—30,720 Acres

Estimated Grazing Capabilities--2,500 Cattle.

A frontage of 6 miles on the north side of the Namoi River, commencing at the junction of the Manilla and Namoi Rivers, to a point marked on the Myall Ridge, and a back run of 5 miles; on the south side a frontage of 8 miles from Mr. Hall's boundary line to Rushes Creek, with a back run of 7 miles.

Bell William Sims. Name of Run—Keepit. Estimated Area—16,000 Acres.

Estimated Grazing Capabilities—1000 Cattle.

Bounded on the east by the Namoi River; on

Bounded on the east by the Namoi Kiver; on the west and south by Mr. Larnach; and on the north by Mr. Baldwin.

No. 22

Bell William Sims. Name of Run-Keepit. Estimated Area-15,000 Acres.

Estimated Grazing Capabilities-5,000 Sheep.

Bounded on the west by the Namoi River; on the east by Mr. Cobcroft; on the north by Mr. Baldwin; on the south by Mr. Larnach; separated from Baldwin's by a range running to the Namoi.

No. 23.

Bettington J. B.
Name of Run—Boovadil.
Estimated Area—15,680 Acres.

Estimated Grazing Capabilities-4,000 Sheep.

This run comprises three small creeks usually dry, known as Miller's, M'Donald's, and Taylor's Creeks; bounded on the west by a range dividing Taylor's Creek from Currygong Creek; on the east by a range dividing Miller's Creek from Jack's Creek; on the south by the Liverpool Range; and on the north by the Australian Agricultural Company's marked tree line, being from east to west about 7 miles, and from north to south averaging about 3½ miles; there is usually no surface water, and the stock are supplied from wells.

No. 24.

Blaxland William. Name of Run—East Bowen. Estimated Area—20,000 Acres.

Bounded on the east by a mountain range dividing the waters of the Bandalah and Bowen Creek; west by Bowen Creek, the creek dividing this run from Mr. Nelson Lawson's; south by the Liverpool Range; north by a line which extends from the extreme point of the Bandalah Range to Bowen Creek, which line divides east Bowen run from Mr. Henry Bayley's run known as the Bandalah Creek run; east Bowen is badly

Estimated Area—25,600 Acres.
Estimated Grazing Capabilities — 600 Cattle,
4,000 Sheep.

Bounded on the south by the River Namoi; on the east by a marked tree line of Sir John Jamieson's; on the west by Mr. Munro's station, by a line running north-east to the top of a pine ridge and afterwards by a line running north to a ridge dividing the waters from Ulla Creek and Ironbark Gully; on the south by five miles of the River Namoi; and on the north bearing 8 miles back by the main range of mountains.

No. 26.

Bagot and Bailey.
Name of Run—Yowenda.
Estimated Area—108 Square Miles.
Estimated Grazing Capabilities—1,000 Cattle.

Bounded on the north by the Barwin; on the east by a marked line running 9 miles south from a marked tree on the river at a place called by the natives Youen; on the west by a line running south from a tree on the river marked by F. Allman, Esq., Commissioner, in 1845; on the south by other vacant Crown Land.

No. 27.

Bagot and Bailey, per Walter Bagot.
Name of Run—Cambo Cambo.
Estimated Area—60 Square Miles.
Estimated Grazing Capabilities—1,050 Cattle.

Running along the creek for 12 miles, including a breadth of $3\frac{1}{2}$ miles on the western, $1\frac{1}{2}$ miles on the eastern side, commencing at Winum; on the south to the junction of the Bolodoob, and Mooney on the north.

No. 28.

Campbell and Smith.
Name of Run—Milrea.
Estimated Area—51,200 Acres.
Estimated Grazing Capabilities—500 Cattle.

Bounded on the east by a marked tree line dividing it from Messrs. Brown and Selwyn's run; south by the River Barwin; west by a marked tree line dividing it from the run of the Executors of the Estate of the late Mr. White of Edinglassie; north by a supposed line 5 miles back from the Barwin (originally granted to Mr. Payne as 10 miles.)

No. 29.

Campbell and Smith.

Name of Run—Walgett.

Estimated Area—32,000 Acres.

Estimated Grazing Capabilities—300 Cattle.

Bounded on the east by a marked tree line dividing it from Mr. Parnell's run; north-east by Mr. R. Rouse's run Urie Urie: north by the Barwin; south and west by the Namoi.

No. 30.

Clift Samuel.
Name of Run—Mooki River, Doono.
Estimated Area—Not stated.
Estimated Grazing Capabilities—600 Cattle, 4,000
Sheep.

Between 4 and 5 miles frontage on the Mooki River, and on the eastern side with the back run to the Breeza Road; on the western side the back run is undefined, being no back water, but the boundary line between Mr. Clift and Mr. Eales should run from the junction of the Dry Creek in a direction as nearly rectangular with the course of the river as possible, running back to Mr. Wyndham's station Cooliba Mountain, joining Mr. Lang's station at the oak tree Breeza Point, agreeably with Roderick Mitchell, Esqr's, Certificate.

Cobcroft John, junior.

Name of Run—Menedebrie.

Estimated Area—19,000 Acres.

Estimated Grazing Capabilities—4,000 Sheep.

Bounded on the north by the River Peel; on the south by a chain of Mountains; on the east by Robert Pringle's run; and on the west by that of Samuel Dight. The run has eight miles frontage to the river, and 6 miles in depth.

No. 32.

Cobcroft John, senior.

Name of Run—Menedebrie.
Estimated Area—22,000 Acres.
Estimated Grazing Capabilities—1,000 Cattle.

Open forest and mountain land, bounded in the front by the Peel River, at the back by leased land to Mr. William Bell; on the upper side by Robert Pringle's leased land: and on the lower side by Larnach's leased land. The run has about 7 miles frontage on the Peel River, and extends to the junction of that river to the Namoi, and has about 5 miles back run to its boundary with Mr. Bell's land.

No. 33.

Cook Saml. Wellington.
Name of Run—Neminga.
Estimated Area—13,440 Acres.
Estimated Grazing Capabilities—700 Cattle or
4,000 Sheep.

Divided from the Estate of the Australian Agricultural Company by Peel's River, commencing at its junction with the Cockburn or Moonbi Creek, and extending 8 miles upwards to a hut called Piallamone; thence on the east by a line running north from this hut, and crossing a broken country, extending about 5 miles to a point on the Cockburn or Moonbi Creek called the Fishholes; and thence by this river downwards to its junction with Peel's River beforementioned, a distance estimated at 10 miles, the run being triangular.

No. 34.

Cox William, junior.

Name of Run—Burindi, Manilla River.

Estimated Area—20,000 Acres.

Estimated Grazing Capabilities—400 Cattle
6,000 Sheep.

The run has a tributary of the Namoi, running through part of it, which is frequently dry. It is bounded on the northern side by W. Ogilvie, junior; and on the southern side by John Larnach, being about 7 miles long by 3 wide, and is principally ridgy, with one small plain about 1 mile in length, about the middle of the run, it is called Table Land.

Name of Run—Quantambone.
Estimated Area—64,000 Acres.

Estimated Grazing Capabilities—1,000 Cattle.
Frontage on the Barwin River of 10 miles, from east to west; bounded on the east by Richards' station, called Collearoy; and on west by Messrs. Druitt's station, called Noonoo or Brewana.

No. 36.

Cox Henry. Name of Run-Navena. Estimated Area-64,000 Acres. Estimated Grazing Capabilities-1,000 Cattle.

Frontage on the Barwin River of 10 miles, from east to west; bounded on the east by Mr. Campbell's station, called Marraman. No licensed station below Nelcomby to the west.

No. 37.

Cox George. Name of Run-Nomeby. Estimated Area-60,000 Acres. Estimated Grazing Capabilities-1,200 Cattle 2,000 Sheep.

This station being on the verge of the plains to secure a spring of water, comprises about one fourth part of inaccessible hills of stony ridges and high conical mountains, besides which the springs named are its only permanent waters, and they are comprised in a few rods in dry weather, and during the summer month of each year the other waters a Lagoon and creeks are frequently dry, and then the stock now on it are compelled to ramble to find water where they can; and bounded as follows, on the north by Belumbela ridges; south by Buballa range, east by Bowen or Cox's creek; west by rocky ridge.

Cox Edward, (now Alfred Denison.) Name of Run-Namoi Hut. Estimated Area-19,200 Acres. Estimated Grazing Capabilities-800 Cattle.

Situate on the southern side of the Namoi River, commencing at its junction with Gunandaddy creek, and extending down the said river to Cocoliendi rock, a point below the hut occupied by a Doctor Adams. In a south westerly direction to Thura Mullen waterhole; south to within half a mile of Walla Walla ridge, on the east to the west side of Bonela.

N.B .- This Run has been transferred, with the sanction of Government, to Mr. Alfred Donison, in whose name the Lease will accordingly be prepared.

No. 39.

Campbell and Ryan. Name of Runs-Gundemaine and Gurley. Estimated Area-70,000 Acres. Estimated Grazing Capabilities-2,000 Cattle.

Bounded on the south by the River Namoi, about 12 or 13 miles, which divides it from Charles Ezzy's run, Molly and Wee Waa run; on the east by a line dividing it from B. Doyle's run, and running from the junction of the Bricklow and Doyle's creeks with the river, a mile above Gundemaine hut, due north about 9 miles, till it Setersects Galather creek; on the north by a line from that point of intersection, running down the south side of Galather creek, and for the last mile or more of Galather creek, crossing and taking in both sides of the said creek, and continuing from the adjacent land occupied by Mr. M Farlane; on that in a north-westerly direction, till it meets the W. C. Wentworth's run Galather. The Mestern being the boundary line between this run and

boundary divides the run from Wee Waa, commencing on the Namoi, about 2 miles below Gurley Lagoon, and runs due north.

No. 40.

Campbell and Ryan. Name of Run-Wee Waa. Estimated Area-80,000 Acres. Estimated Grazing Capabilities-2,000 Cattle, 10,000 Sheep.

Wee Waa on the south side of the Namoi, bounded on the north by the River Namoi, for about 15 miles, dividing it from Gundemaine and Tooydenna; on the east by a line from a marked tree at Gommell Gommell, running south and dividing it from Charles Ezzy's run Nolly; on the south by Bricklow scrub; on the west by a line from a marked tree, a mile below Weeta Waa water hole, and running south. Wee Waa on the north side of the Namoi, bounded on the north by Galather plains; on the south by the Namoi River, about 5 miles, dividing it from Wee Waa on the south side; on the east by a line commencing on the Namoi, about 2 miles below Gurley Lagoon, running north, and on the west by a line from a marked tree at Harper's old station Coondrai Creek, and running north.

No. 41.

Campbell Robert Tertius. Name of Run-Bora. Estimated Area-16,000 Acres. Estimated Grazing Capabilities-4,000 Sheep.
