CLAIMS TO LEASES OF CROWN LAND

BEYOND THE SETTLED DISTRICTS.

LACHLAN DISTRICT.

HIS Excellency the GOVERNOR directs it to be notified, for the information of all persons interested, that in pursuance of Her Majesty's Order in Council, of 9th March, 1847, the undermentioned persons have demanded Leases of the several runs of Crown Land, particularized in connexion with their respective names.

Persons who object to any of these claims, either wholly or in part, should lodge caveats at this Office within two months from the present date, specifying the Lands to which their objections extend, and the grounds on which their objections are based.

It is to be distinctly understood, that the Government does not pledge itself to the issue of a Lease in any case until due enquiry has been made into the validity of the claim, and whether or not it may be necessary to reserve any portion of the Land claimed, for any of the public purposes contemplated in the Order in Council.

Andrews Joseph.
Name of Run—Kymo.
Estimated Area—8,000 Acres.
Estimated Grazing Capabilities—250 Cattle,
4,000 Sheep.

On the east by Gundagai run; west by J. and W. Macarthur's run Nangus; south, Murrumbidgee River; north, scrub between it and F. Taaf's runs.

No. 2.

Andrews Joseph.

Name of Run—Gundagai.

Estimated Area—1,800 Acres.

Estimated Grazing Capabilities—100 Cattle, 800

Sheep.

Bounded on the east by Edward O'Brien's run; on the west by Kymo, in my possession, being contiguous; on the north by a dense scrub intervening between it and F. Taaf's run; on the south by the Murrumbidgee River.

N. B.—The Township of Gundagai having been formed on this run has reduced it from twice its present size to its present limited extent.

No. 3.

Atkins William.

Name of Run—Cowal.

Estimated Area—16,000 Acres.

Estimated Grazing Capabilities—800 Cattle.

Rounded on the cast by a marked tree line r

Bounded on the east by a marked tree line running north from a corner of the paddock which

divides it from Sonestreet's run; west by a line running north from the Billibong Creek 5 miles west of the hut; north by a line running east and west 5 miles back from the creek; south by Billibong Creek.

No. 4.

Barry Lawrence. Name of Run-Bangalal. Estimated Area—12,800 Acres.

Estimated Grazing Capabilities-400 Cattle.

Bounded on the east by Kiley's ranges to Murray's road, which divides it from William Manning's run and Mathew Conway's run; west by the Bobbera ranges, which divides it from James Manning's run and William Manning's run; north by a stony creek running from Mrs. Russell's, and then by Bobbera Creek to the range which divides it from Mathew Conway's run and Edward Ryan's run; south by the store and police paddocks.

No. 5.

Barber George, per Isabella Barber. Name of Run-Nimby. Estimated Area—31,360 Acres.

Estimated Grazing Capabilities-900 Cattle.

Bounded on the east by a line running northeast by south-west 7 miles along the Nimby range to the Buggin Buggin range, dividing it from Valentine's run; on the south by the Buggin Buggin range and a marked line 7 miles, dividing it from Salting's run; on the west by a marked line running north-east basouth-west 7 miles, dividing it ; on the north by the Confrom Mackay's r naught Man Cre

No. 6.

Barber Samuel. Name of Run-Bogolaro. Estimated Area—30,000 Acres.

Estimated Grazing Capabilities-1,000 Cattle.

Bounded on the east by the Black range which divides it from Captain MacCullin's run; on the north by a line to the Back Creek range, and by a line to the spring gully which divides it from the runs of James Garry, Michael Burns, and William Dale; west by the spring gully which divides it from Patrick Kiley's run; south by the Murrumbidgee River and Oak Creek, and then by a line to the black range which divides it from Edward Flood's run.

No. 7.

Barber Samuel and Thomas Williams. Name of Run-Benduck. Estimated Area—32,000 Acres.

Estimated Grazing Capabilities-1,000 Cattle.

Bounded on the east by a line running north from the river 12 mile above the hut which divides it from John Tooth's station; west by a line running north from the river half a mile east of Coonoon point station; north by a line running east and west 5 miles back from the river; south by the Murrumbidgeo River.

Barber Samuel and Thomas Williams. Name of Run-Coonen Point.

Estimated Area—32,000 Acres. Estimated Grazing Capabilities-1,000 Cattle.

divides it from Barber and Williams' station Benduck, east by a line running north 5 miles back from the river, I mile east of the hut which divides it from Phelps and Chadwick's run, Pimpampa; north by a line running east and west 5 miles back from the river; south by the Murrumbidgee River.

Balfour John. Name of Run-Island. Estimated Area-25,000 Acres. Estimated Grazing Capabilities—800 Cattle.

Bounded on the north by the River Lachlan, commencing at a point from Mr. Collitt's station, and extending 7 miles to Mr. Kite's station along the river; on the west by a line 5 miles back to the Bogandillan lagoon; on the south by a portion of that lagoon and a line 7 miles to Mr. Collitt's boundary; and on the east by a line 5 miles to the starting point.

No. 10.

Blackett James. Name of Run-Cota. Estimated Area-12,000 Acres. Estimated Grazing Capabilities-400 Cattle, 4,000 Sheep.

The station was marked by Mr. Beckham, the Commissioner for the District, it is bounded on the east side by Mr. George Wentworth's station; on the north by the River Lachlan; on west by Mr. Henry Fulton's station; and on the south by mountains.

No. 11.

Boyd Benjamin. Name of Run—Jemelong. Estimated Area—60,000 Acres. Estimated Grazing Capabilities-600 Cattle.

Frontage-two small plains about a mile in circumference each, the remainder of the run, box forest, thickly intersected with wattle, yarring, and pine scrubs, which of late years getting nearly impassable, and destroying the pasturage; bounded on the north by the River Lachlan; on east by the top of the Jemelong range, running due south 20 miles; on the west by a marked tree line running due south from the first point of the River Lachlan; east side of Mr. Joseph Collet's station, Towell. No back water on the run.

No. 12.

Boyd Benjamin. Name of Run-Walla Walla, and Carringatel. Estimated Area-60,000 Acres. Estimated Grazing Capabilities-1,500 Cattle.

Description-large plains interspersed with open box forest; in the centre, flooded-gum swamps, at the back, open myall and box ridges. Boundary -north by the River Lachlan; east by a line running south from the junction of a small creek with the river to Bundubburra Creek, then follows the Bundubburra Creek south-westerly about 3 miles; then running south to Carringatel Lagoon, thence a dividing range running southerly 20 miles; Bounded on the east by a line running north west by the top of the Jemalong range, running No. 13.

Booth Charles. Name of Run-Wongajong. Estimated Area—19,200 Acres. Estimated Grazing Capabilities—600 Cattle.

Bounded on the west by a marked line about three quarters of a mile east from Goodwyn's hut, about 81 miles in length; on the north by the River Lachlan; on the east by a marked line dividing it from Mr. Boswell's run, half a mile from Wongajong hut, from the River Lachlan to Omer Creek in a line south; on the south by Mr. G. Rankin's run at Boyd.

No. 14.

Boswell Patrick. Name of Run-Enocks. Estimated Area—25,000 Acres. Estimated Grazing Capabilities-1,200 Cattle

East boundary, a line commencing half a mile above the hut running south from the river separating it from Willadon, Mr. Watt's run; north, River Lachlan; west, a marked tree line commencing at the River Lachlan and running south, separating it from Wangagon, Mr. Booth's run; south, Omer Creek, separating it from Tanungal, Mr. Tait's run.

No. 15.

Bryant George. Name of Run-Boolooree. Estimated Area—23,040 Acres. Estimated Grazing Capabilities-600 Cattle.

Bounded on the east by a line running south half a mile east of the hut 5 miles back from the river, which divides it from Guegonga; west by a line running south from the river, half a mile east of Miller's station, Uabalong; north, the Lachlan River; south by a line running east and west 6 miles back from the river.

No. 16.

Bray Thomas. Name of Run-Narraba. Estimated Area—24,000 Acres. Estimated Grazing Capabilities-920 Cattle, or 6,000 Sheep.

Bounded on the west by Narraba Creek; on the north by Graham and Landre's runs; on the east by Lovett's station; and on the south by Mackay's, Taylor, and others stations, to the commencing point on Narraba Creek aforesaid.

Broughton William. Name of Run-Burroowa. Estimated Area_13,400 Acres. Estimated Grazing Capabilities-600 Cattle, or 4,500 Sheep.

Bounded on the east by the Burroowa River 7 miles; west by a marked tree line south by west, until it meets the dividing range at Harris's road, which parts the waters running into the Murrumbider and the Burroowa, and which parts it from Edward Ryan's run, called Jalong, along the dividing rango aforesaid, dividing it from William the east by the Borowa, to where Gobur Creek Manning's run, called Carriong, until it meets a runs into it, 7 miles.

gully on the south, (this line is 7 miles long); on the south by aforesaid Gully, emptying into the Burroowa, $2\frac{1}{2}$ miles long, dividing it from Messrs. Grant and Trevelyan's run; on the north by a marked tree line, commencing from the Burrowa River, and plough track 4 miles long dividing it from Thomas Preston and Roger Corcoran's runs.

No. 18.

Brady James. Name of Run-Duggin's station. Estimated Area - 3,840 Acres. Estimated Grazing Capabilities-500 Cattle.

Bounded on the east, commencing at the northeast corner of the said Duggin's station by Sheen's run, called Gullagong, in a line running south 5 miles; on the south by Mullyantra Creek, in a line running west 5 miles; on the west by Blackman's run, called Nanima, in a line running north 5 miles; and on the north by the Lachlan River, in a line running east 5 miles to Sheen's run aforesaid, and to the north-east corner of the said Duggin's run aforesaid.

No. 19.

Burke Abel. Name of Run-Back Creek. Estimated Area—28,400 Acres. Estimated Grazing Capabilities-1,200 Cattle.

Bounded on the east by a portion of Bland Creek; west by a sandy desert; north by a line running east and west 3 miles north of the hut; south by a line running east and west 2 miles south of the hut.

No. 20.

Boland Thomas. Name of Run-Bald Hill. Estimated Area-40,320 Acres. Estimated Grazing Capabilities - 200 Cattle, 6,000 Sheep.

Bounded on the east by the Warraderry Main Range, which divides it from William Cummin's run; west by a line running from the Warraderry Range to the north side of the Jump-up Rock Creek; thence to its junction with Oma Creek, which divides it from Mrs. Gibson's run; north by the east side of Oma Creek, as far as a marked tree above Oma stockyard, which divides it from John Tait's run, Oma, and H. Hamilton's run, Tomanbil; south by an ironbark range, about 3 miles south of the Bald Hill, which divides it from

Thomas Hadley's run.

Campbell Robert Mackay. Name of Run-Ann's Vale or Cungera. Estimated Area—26,880 Acres. Estimated Grazing Capabilities - 600 Cattle, 2,500 Sheep.

Bounded on the north by Gobur Creek, running westerly 6 miles; on the west by a line running southerly 7 miles; on the south by a line running easterly to the Salt Water Creek, and by that creek to its junction with the Borowa 6 miles (not to include Mrs. Campbell's 960 acres, at Cungera, in the estimated No. of acres); and on No. 22.

Chisholm James. Name of Run-Gegullalong. Estimated Area—22,400 Acres.

Estimated Grazing Capabilities-4,000 Sheep. Bounded on the east by Gegullalong Creek, and Mr. Scarr's sheep station, and the road lead-

ing from Gobur Creek to Borowa; on the north by the dividing range which separates the waters that flow into Gobur Creek and from Gegullalong Creek, and is the boundary between Gegullalong Mrs. Campbell's, and Mr. M'Dermott's stations; on the south by a marked line on the west side of the creek, running due west, marked by the Commissioner, which is the boundary between Mr. Ryan's station and Gegullalong; and another line on the east side of the creek, commencing at the Old Burial Ground, near the main road to Castle's station, about 1½ miles long, which is the boundary between Mr. Scarr's sheep station and Gegullalong on the east side of the creek; and on the west by part of my Narra Allen station, and Mr. M'Dermott's station, called Calabash. I estimate the Gegullalong station to be 5 miles wide from east to west, and 7 miles long, from north to south.

No. 23.

Chisholm James. Name of Run-Narra Allen. Estimated Area—15,360 Acres.

Estimated Grazing Capabilities-4,000 Sheep. Bounded on the east by a part of my Gegulla-

long station, and a spur of the main Gegullalong Range, to Stony Creek, which separates Mr. M'Dermott's station from Nara Allen and Gegullalong, and Thomas Antoney's station; on the north by part of my Kenn station, and the dividing range, which separates the waters that flow into Nara Allen Creek from Breakfast Creek and the Lachlan, and is the boundary between Trott's station and part of Mr. O'Sullivan's; on the west by the head of Reedy Creek and the dividing range, which separates the waters that flow into the Borowa River from the Lachlan; and on the south by my Gegullalong station. estimate this station to be 4 miles wide, from north to south, and 6 miles long from east to west.

No. 24.

Clune James and J. Quinn. Name of Run-Goburralong. Estimated Area -- 7,680 Acres.

Estimated Grazing Capabilities-100 Cattle.

Bounded on the east by M'Farlane's old station, which divides it from William Cullinan's Run; west by a range running south towards the Port Phillip Road, which divides it from James Crowe's run; north the Port Phillip Road; south the Murrumbidgee River.

No. 25.

Conroy John. Name of Run-Stony Creek. Estimated Area—3,840 Acres.

Estimated Grazing Capabilities—400 Cattle.

Bounded on the cast by the Gap Range on the Port Phillip Road, which divides it from Matthew M'Namara's run; west by a stony gully, running from the Black Range to Fitzgerald's Range, as aforesaid.

which divides it from John Lambs run; south by the Black Range; north by Fitzgerald's Hills, which divide it from John Fitzgerald's run.

No. 26.

Collits Joseph. Name of Run-Towyel. Estimated Area—32,000 Acres. Estimated Grazing Capabilities-1,200 Cattle, or 4,000 Sheep.

All that squatting station situate on the southern bank of the River Lachlan, known as Towvel: bounded on the north by the River Lachlan, from a point 20 chains to the westward of a large sand hill, on the western portion of Towyel to Cookabulbigal hut, on the north bank of the said River; on the east by a line from Cookabulbigal hut, passing to the eastward of Yulundy Plain, and running southward 10 miles; on the south by a line west 5 miles; and on the west by a line north 10 miles to the commencing point on the Lachlan River.

No. 27.

Collits James. Name of Run-Cadow. Estimated Area—19,480 Acres. Estimated Grazing Capabilities-800 Cattle.

Bounded on the north by the Lachlan River 4 miles; on the west by Mr. Belfer's run and a line bearing south 8 miles; on the south by a line bearing east 4 miles to the south-west corner pin of Joseph Miller's run; and on the east by Joseph Miller's run, and a line bearing north 8 miles to the Lachlan River as aforesaid.

No. 28.

Collits James. Name of Run-Weelong. Estimated Area—25,600 Acres. Estimated Grazing Capabilities-1,000 Cattle.

Bounded on the north by the Bundaburra Creek 13 miles and 10 chains, thence by a line bearing west 3 miles and 10 chains and Benjamin Boyd, Esq., run; on the west by the Jemalong Range and a line bearing south 8 miles; and on the south by a line bearing east 5 miles; on the east by a line bearing north 8 miles to the Bundaburra Creek as aforesaid and the Bundaburra Run.

No. 29.

Collits James. Name of Run-Bundaburra. Estimated Area-23,400 Acres. Estimated Grazing Capabilities—1,000 Cattle.

Bounded on the north Bundaburra Creek 5 miles; on the east by a line bearing south 7 miles to the Boyd Creek, and on the south by the Boyd Creek 21 miles; then by a line bearing west I mile to II. Ambleton north-west corner pin; and on the east by II. Ambleton's run I mile; and on the south by a line bearing west $1\frac{1}{2}$ mile to the south-east corner pin of Weelong run; and on the west by the Weeleng run to the Bundaburra Creek No. 30.

Conway Matthew. Name of Run-Bungalal. Estimated Area-16,000 Acres.

Estimated Grazing Capabilities-300 Cattle.

Bounded on the east by the Kuriong ranges which divide it from William Manning's run; west by Harris' old road; north by the road leading to Darby Murray's and the Stoney Creek running from Bobbera Creek which divides it from Lawrence Barry's run; south by Harris' old road and lagoon which divides it from Grant and Trevellyan's run.

No. 31.

Comans James. Name of Run-Combaning. Estimated Area—19,200 Acres.

Estimated Grazing Capabilities-600 Cattle.

Bounded on the east by William O'Brien's run; on the north by Mr. Salting's station called Braze Creek; on the south by Mr. Hurley's station called Jemy Creek, and on the west by the level country.

No. 32.

Crowe James. Name of Run-Goburralong. Estimated Area—7,000 Acres.

Estimated Grazing Capabilities-400 Cattle.

Bounded on the east by a gully running north from Clune's hut towards the Port Phillip Road, which separates it from Clune and Quin's station; west by a line running north towards the Port Phillip road, which separates it from Robert Davidson's run; south by the Murrumbidgee River; north by the springs and Walbar ranges which divide it from Francis Taaffe's run.

No. 33.

Croaker John William. Name of Run-Burramunda Troy. Estimated Area—16,000 Acres.

Estimated Grazing Capabilities-3,000 Sheep.

On the east by a line north from the point where Cudgil Creek empties into White's Creek 3 miles; on the north by a line west 5 miles; on the west by a line south 5 miles; on the south by a line east to Cudgil Creek; and on the east by Cudgil Creek to the abovenamed point to complete the east boundary.

No. 34.

Cullinan William. Name of Run-Golgillan. Estimated Area-5,200 Acres.

Estimated Grazing Capabilities—500 Cattle.

Bounded on the east by the Murrumbidgee River; west by the main range between the river and Port Phillip road; north by a blind creek running into the river about 3 miles from the hut which separates it from E. and W. Howe's run; south by the Honeysuckle gully near Clune and Quin's hut.

No. 35.

Dacey Daniel. Name of Run-Grogan Creek. Estimated Area—30,080 Acres.

Estimated Grazing Capabilities-700 Cattle.

Bounded on the east by Stockinbingel Creek; west by a line running north and south from Dudorman hill; south by a line running west from and Burns; west by the Deep Creek Range to No. 109, 27TH SEPTEMBER, 1848.—2.

Dacey's stockyard; north by a line running west from Ryan's stockyard Yoeyeo which divides it from Edward Ryan's run.

No. 36.

Dallas J. A. Name of Run-Brawlin.

Estimated Area-46,080 Acres. Estimated Grazing Capabilities-1,600 Cattle, or

10,000 Sheep.

Bounded on the east by a line running northeast by north from Mr. F. Taaffe's northern boundary along Cowan's ranges; on the north by a line running south-west from Cowan's ranges touching Mug Mug waterhole crossing to Mingie Creek at the bow yards to the top of a scrubby range forming Mr. James Fitzpatrick's southern boundary, and from thence by a line running west south-west crossing the Cunjegong Creek and Buthongra mountain to Stephen White's eastern boundary forming Mr. John Hurly's southern boundary; on the west by Stephen White's eastern boundary, and on the south by Mr. F. Taaffe's northern boundary to Cowan's ranges; the eastern boundary line runs through scrubby ranges; the northern boundary runs through scrubby ranges except Culangare flat and the banks of the creeks; the west side of the run is all scrubby except a strip on the boundary line and one half the southern boundary runs over scrubby ranges.

No. 37.

Dallas John A. Name of Run-Gogeldrie. Estimated Area-42,240 Acres.

Estimated Grazing Capabilities-1,700 Cattle, or

10,200 Sheep.

Bounded on the west by Ulong running due north from the Murrumbidgee River; on the north by a line running due east; on the east by a line running due south to the Murrumbidgee River, joining Mr William Thorne's station, Yanco; and on the Murrumbidgee River 12 miles from Mr. Gardener's boundary running due east, the banks of the river forming the southern boundary is an open forest; the western boundary is principally all plains; the northern boundary is nearly all plains with patches of Myall and pine scrubs, and the eastern boundary is all plain and open forest.

No. 38.

Davison Robert. Name of Run-Jumballa. Estimated Area—640 Acres.

Estimated Grazing Capabilities-50 Cattle, 8

Horses.

Occupying about 1 mile square between the Murrumbidgeo River and a tier of hills called the Moni Moni Range, and bounded by that range, and the runs of Dr. Nicholson and Mr. J. Crow on the west and east.

No. 39.

Dale William. Name of Run-Reedy Creek.

Estimated Area __ 2,000 Acres.

Estimated Grazing Capabilities-300 Cattle.

Bounded on the east by a part of the Black Range which separates it from the runs of Barber the Spring Gully, thence to the Chain of Ponds thence by a line to the boundary line between Reedy Creek run and Michael Byrne's run; north by the range on the south side of the Port Phillip Road; south by the ranges on the south side of the creek.

No. 40.

Dimmock William.

Name of Run—Sheep Station Creek.

Estimated Area—3,200 Acres.

Estimated Grazing Capabilities—300 Cattle.

Bounded on the east by the Port Phillip Road; west by a marked tree line running from the Binnalong Road to Fitzgerald's Ranges, which divides it from Darby Murray's run; north by the Binnalong Road; south by the Black Range to the Gap, which separates it from John Conroy's run.

No. 41.

De Salis and Smythe, per L. F. De Salis Name of Run -- Junee.

Estimated Area—150,000 Acres. Estimated Grazing Capabilities—4,000 Sheep.

Junce run is bounded on the south by a line running due east and west across a point in the Junce watercourse 2 miles above Leith's water-hole, and embraces all the country northward and above the said line, whose waters fall into the Junce Creek; it is bounded on the south by Thompson's; on the east by Thorn, Nicholson, and Hurley; on the north by Cummins; on the west the country is unoccupied.

No. 42.

Dowd John!
Name of Run—Croot.
Estimated Area—12,000 Acres.

Estimated Grazing Capabilities-250 Cattle.

Bounded on the north by a line from a marked tree or a waterhole to Tinpot Ranges, which divide it from Edward Shein's run; on the south by the Back Creek, extending to the Red Hill, which divides it from Hugh O'Neil's run; on the east by Pipeclay Creek, which divides it from John Grant and Thomas Icely's runs; on the west by Tinpot Range, which divides it from Thomas Hadley's run.

No. 43.

Dwyer William.
Name of Run—Curianga.
Estimated Area—3,200 Acres.

Estimated Grazing Capabilities—300 Cattle.

Bounded on the east by Stringy-bark Range and Kuriong road; and west by the Sawyer's Creek and Darby Murray's Ranges, which divide it from the runs of William Mauning and Darby Murray; north by a Stringy-bark Range, which divides it from Grant and Trevellyan's run; south by the Kuriong Road.

No. 44.

Evans Evan.
Name of Run—Paddy's Plains.
Estimated Area—9,600 Acres.
Estimated Grazing Capabilities—700 Cattle.

Bounded on the east and south by the Smiggin Creek, running above the Battery into the Burrowa River, which divides it from William run; north the Lachlan River.

Bolter's run; west by the Crossing-place Creek, which divides it from George Wentworth's run; north the Lachlan River.

No. 45.

Fitzgerald John.
Name of Run—Mylora.
Estimated Area—7,680 Acres.

Estimated Grazing Capabilities-400 Cattle.

Bounded on the east by Fitzgerald's Hills, which divide it from John Conroy's run; west by Bushranger's Hill, which divides it from Cornelius O'Brien's run; north by Fitzgerald's Hills to the Round Mount, thence by the Cumburs murra Road, which separates it from James Manning's run; south by a gully running from Fitzgerald's Hill to Bushranger's Hill, which separates it from John Lamb's run.

No. 46.

Fitzpatrick James.
Name of Run—Cucumla.
Estimated Area—56,320 Acres.
Estimated Grazing Capabilities—400 Cattle,
4,000 Sheep.

Bounded on the south by a marked tree line running east and west from Cucumla Creek sheep station; west by the Cucumla Range; north by the Bandengo Range; thence by a line running nearly east and west to the stockyard at Stockinbingel, which divides it from James Mathason's run, and by a marked tree line from the hut at Stockinbingel to the Dudorman Range, which divides it from William O'Brien's run, and by a range running east and west, which divides it from John Hurley's run.

No. 47.

Flynn John.
Name of Run—Jugiong.
Estimated Area—640 Acres.

Estimated Grazing Capabilities-100 Cattle.
