**CLAIMS TO LEASES OF CROWN LANDS,  
BEYOND THE SETTLED DISTRICTS.  
GWYDIR DISTRICT.**

**H**IS Excellency the GOVERNOR directs it to be notified, for the information of all persons interested, that in pursuance of Her Majesty's Order in Council, of 9th March, 1847, the under-mentioned persons have demanded Leases of the several Runs of Crown Land, particularised in connexion with their respective names.

Persons who object to any of these claims, either wholly or in part, should lodge caveats at this Office within two months from the present date, specifying the Lands to which their objections extend, and the grounds on which their objections are based.

It is to be distinctly understood, that the Government does not pledge itself to the issue of a Lease in any case until due enquiry has been made into the validity of the claim, and whether or not it may be necessary to reserve any portion of the Land claimed, for any of the public purposes contemplated in the Order in Council.

No. 1.

Australasia Bank of.  
Name of Run—Gurly and Bumble.  
Estimated Area—100,000 Acres.  
Estimated Grazing Capabilities—12,000 Sheep.

Bounded on the west by a line commencing at a marked tree at a waterhole known as Pigeon Ball Waterhole to a marked tree known as Mother Ogilvies, dividing it from Bettington's Run; and from thence to a clump of trees on a branch of Waterloo Creek, dividing it from Brown's Run; on the south by said Creek to a Point of timber known as Sparke's Point, and from thence along a belt of scrub to Menandi Creek, dividing it from Eekford's run; from thence on the south and east by a line along a belt of scrub to a hill known as the Black Ridge, and another known as the Hay Stack, to another known as the Black Hill, dividing it from Parnell's and Wentworth's runs; and from thence on the east by a line to a bald ridge dividing it from Bowman's Run; from thence on the north by a belt of scrub, on the north side of Bold Muckle Die Creek to a water hole known as Bold Muckle Die, from thence by a line to a marked tree on Bowman's Creek, dividing it from Wiseman's run; on the north by Bowman's Creek to a lagoon known as B. B. Lagoon, dividing it from Baldwin's Run; and from thence by a line to Pigeon Ball Waterhole, dividing it from Bettington's run.

## No. 2.

**Bowman George.**

**Name of Run—Terry-hie-hie.**

**Estimated Area—83,200 Acres.**

**Estimated Grazing Capabilities—1,200 Cattle or 6,000 Sheep.**

Bounded on the north by a line west from the Gwyder Range, running west to Terry-hie-hie Creek for about  $3\frac{1}{2}$  miles, crossing that creek about 2 miles below or north of the Terry-hie-hie house, yards, &c., and a continued west line of about 6 miles, dividing it from my Gurrygedah Station; in a southerly direction to the Mountain Range about midway between the highest peak and the extreme end of the range, north-west towards the Namoi, being a line about 10 miles south, dividing it from the Gurally Station, belonging to the Bank of Australasia, and by that mountain south and south-east about 4 or 5 miles, then east about 2 miles; south-east by the range of hills leading to what is known as the Bald Hill, near the Gwyder Range, about 8 miles, and dividing it from the Rocky Creek Run, belonging to Mr. Pringle; on the east and north-east by the dividing range between the Gwydir River, and Terry-hie-hie Creek (taking in Darra Gap) about 6 miles to the commencing corner, taking in all the creeks, gullies, and water-courses emptying into Terry-hie-hie Creeks from the before-mentioned mountains and ranges.

The extreme length of this run is about 15 miles from north to south, and at the north end about  $9\frac{1}{2}$  miles wide from east to west, about midway, about 12 or 13 miles wide, and at the north end 4 or 5 miles wide, but varies at different parts according to the curves in the mountains and ranges. It is supposed to contain about 83,200 acres; one-third of the whole is composed of impenetrable scrubs of oak, breggalow, and other brush wood, quite useless for any grazing purposes whatever; one-third is composed principally of stony ranges, very little grass, timber white leafed ironbark; and the remainder portion consists of good grassed downs and meadows, with gum, box and apple tree flats. The whole is watered by two creeks or water-courses, running from the mountains, one called Terry-hie-hie, which commences on the mountains at the south extreme of the run, and runs in a northerly direction about 13 miles, when it turns in a north-west direction. This creek has in general seasons water in holes only for about 4 miles at the north end of the run, and two other holes, one about 10 miles, and the other 12 miles higher up the creek; the other creek is commonly known as or called the Dry Creek, which comes from the Bald Hill and Gwyder Range, and runs in a north-west direction joining the Terry-hie-hie Creek near the station, and has only three or four waterholes, in very dry seasons, those generally fail. During the last year, 1847, the whole of the surface water on this run failed in December, when the men on the station had to sink for supplies for the house. These creeks have a flat sandy bottom with a very great declivity, and consequently do not retain the water.

## No. 3.

**Bowman George.**

**Name of Run—Gurrygedah.**

**Estimated Area—84,000 Acres.**

**Estimated Grazing Capabilities—1,100 Cattle or 4,000 Sheep.**

Bounded on the south by the Terry-hie-hie Station, commencing at the Gwydir Range by a west line about  $9\frac{1}{2}$  miles; on the west by a north-west by north line about  $12\frac{1}{2}$  miles long, dividing Gurrygedah, from the station belonging to the Bank of Australasia; on the north by a marked tree line east about 12 or 13 miles, dividing from Wiseman's and Baldwin's stations; and on the east by the Gwydir Range in a south-east by south direction to the commencing corner; containing by estimation about 84,000 acres, about one-half of which is scrub. The remainder generally good grazing land, but badly watered, which is by some waterholes in Terry-hie-hie Creek, and also in wet seasons by some ponds in water-courses, the whole of which, including all the water in the creek, were dry last December, 1847. This run takes in all the gullies and water-courses running into Terry-hie-hie Creek on both sides.

## No. 4.

**Blake Andrew.**

**Name of Run—Goorable.**

**Estimated Area—156,160 Acres.**

**Estimated Grazing Capabilities—8,000 Sheep.**

The Goorable run is supposed to be 33 miles long and 8 miles in breadth; bounded on the north by Cox's line and scrub; south by a stony range south side of Balala Creek, taking in 8 miles of Balala Creek to its junction; east by Cox's line on Goorable Creek; west and south-west by Jannarany and Cullen's line; north-west by King's line at Weelburn Creek.

## No. 5.

**Browne John.**

**Name of Run—Coppymurrambil.**

**Estimated Area—96,000 Acres.**

**Estimated Grazing Capabilities—1,200 Cattle.**

Coppymurrambil station, bounded on the north by Carbuicki station and a boundary on Morella; on the south by a brigoli brush; on the east by Messrs. John and James Howe's station Medwar; on the west by a large plain.

## No. 6.

**Browne John.**

**Name of Run—Tingun.**

**Estimated Area—32,000 Acres.**

**Estimated Grazing Capabilities—4,000 Sheep.**

Tingun station, bounded on the north and west by Edward White, Esq., station; on the east by a brigoli brush; and on the south by Gundiwinde station.

## No. 7.

**Baldwin Otto and Harvest.**

**Name of Run—Mungio-bundio.**

**Estimated Area—30,720 Acres.**

**Estimated Grazing Capabilities—3,000 Cattle.**

On the south side of the river, from a marked tree line, bounding Mr. Eaton's run, for 8 miles, to Mr. Hall's boundary, and having a ten miles' back-run, due north and south from the before mentioned point.

## No. 8.

Beattie J. F., (per John Taylor.)  
 Name of Run—Molroy.  
 Estimated Area—60,000 Acres.  
 Estimated Grazing Capabilities—1,000 Cattle.

Molroy boundaries commence at a marked tree at the junction of the Stony Gully with the Mei or Big River, nearly opposite the junction of the Gwydir, and runs in a north-easterly direction up the Stony Gully and over a low ridge, passing through the Sugar-loaf or Rodd's Mountain, and thence along the ridge dividing the waters of Oak Creek from those of Spring Creek 8 miles; bounded on the east by a line commencing at the extreme of the north boundary crossing Myal Creek at a marked tree at the mouth of a gully running into the Myal Creek on the south side about 20 rods below Clino's hut, and thence to the ranges heading Bobby Whitlow Creek, following those ranges round the head of said creek to the river at a marked tree situated near a large rock on the Mei or Big River, 3 miles above Collett's crossing place; on the south and west by the Mei or Big River.

## No. 9.

Bettington J. B.  
 Name of Run—Nepickallinna (including Cumbal-dello.)  
 Estimated Area—76,800 Acres.  
 Estimated Grazing Capabilities—2,000 Cattle.

This run is watered by the Myall and Moonin Creeks, and also by the Mehi or Big River, commencing at a marked tree on the Mehi River, near Mr. Baldwin's run, and bounded by a line bearing easterly  $4\frac{1}{2}$  miles, including a lagoon known as the double B. lagoon, then southerly crossing the Myall Creek at a waterhole called Peichambool, 10 miles to a mark on the south side of the said creek, near a run occupied by the Bank of Australasia; thence westerly about 16 miles to the Mehi River, and by that river about 12 miles to the commencing point.

## No. 10.

Bartlett and Gibson.  
 Name of Run—Werrinah.  
 Estimated Area—32,000 Acres.  
 Estimated Grazing Capabilities—1,000 Cattle.

Bounded on the north-west by the River Barwin 10 miles; on the south-west by an oak scrub and marked tree, dividing it from the run Turanby, lately occupied by Mr. J. Single; on the north-east by a marked tree line beginning at a waterhole called Dumborie, dividing it from a run applied for by Messrs. Doyle.

## No. 11.

Bucknell William Wentworth.  
 Name of Run—Yarrouah.  
 Estimated Area—16,000 Acres.  
 Estimated Grazing Capabilities—640 Cattle.

Bounded on the west by the Bomi Creek, beginning at Yarrouah waterhole in that creek, and running upwards from that 10 miles on its east side and back towards the Gil Gil Creek.

## No. 12.

Bucknell C. W.  
 Name of Run—Collyu or Umbry.  
 Estimated Area—46,080 Acres.  
 Estimated Grazing Capabilities—800 Cattle.

Bounded on the east by the Barwin River, west by the Bomi Creek; south by land at present occupied by Mr. Crowder, north by Mr. Bartlett's run, beginning south at a waterhole 2 miles below David Grover's hut, extending up, on the east bank of the Barwin 12 miles; back from the river Barwin 6 miles to the Bomi Creek, higher boundary mark on the Barwin being Turnbull hut and back to the Bomi to a sandy ridge called Negit.

## No. 13.

Bell Archibald.  
 Name of Run—Ulumbarella.  
 Estimated Area—24,600 Acres.  
 Estimated Grazing Capabilities—800 Cattle.

Situated on the Nogra Creek and has on one side the station of Mr. White, from which it is separated by the public road crossing the Gwyder and extending to Bell's Mountains on the other side by the station of Mr. Lethbridge, and lastly it is bounded by a range of mountains which divide it from Rocky Creek. This station is intersected by the river Gwyder for a distance of about 5 miles.

## No. 14.

Bell Archibald.  
 Name of Run—Bengaria.  
 Estimated Area—16,000 Acres.  
 Estimated Grazing Capabilities—640 Cattle.

Commencing from a tea tree creek forming a south boundary line extending eastward and following the course of that creek to where it enters the Main Range dividing the waters of Myal Creek from those of Reedy Creek; thence crossing Kelly's Gully in a northern direction and striking the creek at a small gully about  $\frac{1}{4}$  of a mile on the south side of Warialda, from thence up the Reedy Creek to a gully opposite Warialda; thence running northward to a Main Range dividing the waters of Mosquito Creek from the waters of Reedy Creek; on the west by that range till it joins a range running parallel with the Gwyder River, thence along that range till it joins the Highland Plain Range running nearly parallel with Reedy Creek thence along that range to where a line running easterly would meet this tea tree creek before mentioned, on the south by land in the occupation of James King; on the east by land in the occupation of H. Dangar and W. Hall; on the north by the Warialda Government run, and on the west by M'Mullon and John Eales.

## No. 15.

Brown Thomas.  
 Name of Run—Meero, (Goonal.)  
 Estimated Area—32,000 Acres.  
 Estimated Grazing Capabilities—640 Cattle.

Situated in the Gwyder District, on the Goonal Creek, a branch of the Big River; bounded on the east by a marked line dividing it from Robert Fitzgerald's station known as Meenan; on the north partly by a marked line dividing Robert Fitzgerald's station known as Big Leather, and by partly waterless plains; on the south by a marked

line separating it from Mr. John Single, senior, run known as Folaragang, and on the west by marked line dividing it from Mary Town's station known as Bumble; the country is of a low flooded description capable of depasturing cattle alone; the water in the creek is not permanent.

## No. 16.

Coberoft John, Junr.  
Name of Run—Wathagar.  
Estimated Area—30,000 Acres.  
Estimated Grazing Capabilities—1,200 Cattle.

Bounded on the south by the Big River; on the north by Robert Fitzgerald's station; on the east by Ratcliffe Parnell's; and on the west by John Singles; the station has 8 miles frontage to the River with a depth of 6 miles.

## No. 17.

Campbell and Smith.  
Name of Run—Beeboo and Wyemoo.  
Estimated Area—76,800 Acres.  
Estimated Grazing Capabilities—2,500 Cattle.

Bounded on the east by a line dividing it from Mr. J. M'Dougall's Run, about 6 miles from the present site of "Beeboo Hut," extending 20 miles down the river on both sides to a line crossing the river about 6 miles below the junction of the M'Intyre Brook; north by Captain Dumaresq's Run, at a line terminating the back run of the Severn; south by a line running parallel 5 miles from the Severn.

## No. 18.

Campbell and Smith.  
Name of Run—Elangaba.  
Estimated Area—64,000 Acres.  
Estimated Grazing Capabilities—1,000 Cattle.

Bounded on the east by a north and south line crossing Callico Creek, being the western boundary of Mr. I. Marks' station, westerly in a direction parallel to the Creek and extending 10 miles; on the west by a north and south line, crossing Cobbiott Creek and on the south by a line running parallel to the northern boundary, and extending to the eastern boundary.

## No. 19.

Capel Daniel.  
Name of Run—Piedmont.  
Estimated Area—46,000 Acres.  
Estimated Grazing Capabilities—1,200 Cattle.

Bounded on the south by Bell's Mountain and Armitage's run on the Manilla; north and N. E., by Hall's and Hales station; on the west by Eaton's run Cobbity; and on the east by Mrs. Hughes' and M'Pherson's runs.

## No. 20.

Cox William, senior.  
Name of Run—Doradera.  
Estimated Area—1,000 acres.  
Estimated Grazing Capabilities—18,000 cattle.

Situated on the Guyder or Horton River, between the lines occupied by Messrs. Ogilvie and Ottly, (the course of the river,) about north, bounded on the north by a ridge bearing west about  $\frac{1}{8}$  of a mile from Mr. Ottly's hut on the west side

of the river; on the east by a line bearing east; bounded on the south by a contributory creek and gully on the west side of the river, and on the opposite side by a supposed line running back in an easterly direction, opposite the junction of the said Creek, and bounded on the east and west sides by high mountains.

## No. 21.

Cox William, senior.  
Name of Run—Gunya Warildi (Copper Creek?)  
Estimated Area—35,000 Acres.  
Estimated Grazing Capabilities—1,550 Cattle, 4,000 Sheep.

A creek between the M'Intyre and Big River, running into the latter course about north-west, leaving only 4 miles of permanent water, above the water a long narrow plain about 12 miles, bounded on the north by Ranges; on the south by forest land, running back to the Musquito Range, leave given to occupy by Mr. Commissioner Mayne, in January, 1840; on the north about 7 miles distant, a creek occupied by Mr. Thomas Kerr, of Muswellbrook; on the south by the Musquito Creek, occupied by John M'Geachie; on the east a high range; and on the west a thick scrub.

## No. 22.

Cox William, senior.  
Name of Run—Gunya.  
Estimated Area—60,000 Acres.  
Estimated Grazing Capabilities—1,600 Cattle.

Situated on the Severn River, (generally a running stream, with plenty of watercourse, about west, large flats on either side about 2 miles in width, backed by high ranges,) between the runs occupied by Messrs. Hetherington and M'Dougal, boundary between the applicant's run and Hetherington's, known by a mark tree with WX upon it on the north side of the river; thence an imaginary line back to the range; on the south side by a gully, similar boundaries between the said run and M'Dougall's; leave given to occupy (by Mr. Commissioner Mayne, in January, 1840,) 12 miles of the river on both sides.

## No. 23.

Cox James.  
Name of Run—Moree.  
Estimated Area—23,040 Acres.  
Estimated Grazing Capabilities—1,500 Cattle, 10,000 Sheep.

Open and Myall Plains, with oak scrubs or brushes; bounded on the east by Mr. Hall, of Woobulabulla; on the west by Messrs. Parnell's Tyroole, (and Wynn Baldwins' Wallumhal;) on the north by the Big River; and on the south by R. A. Wiseman's Tycanna Plains.

## No. 24.

Cheoko and Broadhurst.  
Name of Run—Gragin.  
Estimated Area—76,800 Acres.  
Estimated Grazing Capabilities—2,000 Cattle.

Bounded on the north by the Mosquitoe Creek; on the south and south south-west by Dangar's Plain, and the Range separating the head of Hall's creek from Sheep Station creek; on the south-west

by Kelly's Gully; on the east by a line running north 5 miles, from a tree on the south bank of Reedy Creek, known as the boundary tree, and marked R. M.; and on the west by the Dogtrap Range, running north from the Dogtrap on the left hand side of the Road from Gragin to Warialda. The names of the Occupant's of Runs adjacent to Gragin Run, are Messrs. H. Dangar, W. Hall, A. Bell, D. Jones, and Messrs. Cheeke and Broadhurst, occupy Graman Run to the north.

## No. 25.

Cheeke and Broadhurst.  
Name of Run—Graman.  
Estimated Area—46,080 Acres.  
Estimated Grazing Capabilities—15,000 Sheep.

Bounded on the north and north-east by a line running from the point of Cox's Range at Jardin's Creek, to the stone known as the Boundary Stone on Gullingutta Creek, the range dividing the waters of Cucumber Creek, from Gullingutta Creek, and then by Redbank Creek; on the south and south-west by the range dividing the waters of Reedy Creek from those of Graman Creek; on the east by Graman or Wyndham's Creek, and the MacIntyre River; and on the west by the range commencing at the junction of Dry Creek, with the right branch of Musquitoe Creek, extending to Cox's Range, and dividing the waters of Dry Creek, from those of the left branch of Musquitoe Creek. The names of the Occupants of Runs adjacent to Graman are Messrs. G. Wyndham, A. Hickey, R. B. Otley, D. Jones and J. Kelly, and Messrs. Cheek and Broadhurst's Gragin Run.

## No. 26.

Campbell and Ryan.  
Name of Run—Towndey.  
Estimated Area—57,000 Acres.  
Estimated Grazing Capabilities—1,500 Cattle.

Towndey has about 11 miles frontage on the Barwin, by which River it is bounded on the east dividing it from Standish Callaghan's Run, Caidmurry; on the south by a line from a marked tree, at Weetalaba, waterhole dividing it from Eckford's Run, Bunen, and running west 8 or 9 miles till it intersects the Mooney Creek, at Eckford's marked tree; on the west by the Mooney Creek, from that point of intersection 11 miles till it meets the northern boundary which Mooney Creek divides it from Bailey and Bagots Run, Cambo Cumbo; the northern boundary is from a marked tree 1 mile above Colly Biggile, running west 8 or 9 miles till it meets the Mooney Creek.

## No. 27.

Cullen Thomas.  
Name of Run—Turilari.  
Estimated Area—35,000 Acres.  
Estimated Grazing Capabilities—1,600 Cattle.

Turilari on the north branch of the Big River, commencing where the River divides, and down this branch to the stony point on the eastern side by Crawford's station by a marked tree line running north to Crawford's brush, and bounded by that brush to Tunderany Waterhole about 7 miles; on the west by a line running north dividing me

from Boolooroo station to Wallen Creek about 7 miles; on the north by that creek to Tunderany Waterhole, these lines to include Cullens ponds as now occupied by me.

## No. 28.

Campbell and Wentworth.  
Name of Run—Argowan Plains.  
Estimated Area—35,000 Acres.  
Estimated Grazing Capabilities—1,500 Cattle.

Bounded on the south by the Big River; on the west by a line commencing at the point where the Big River divides into two parts, running thence to a black stump on the plain, and thence in a northerly direction; on the east by a line commencing at the edge of a scrub and at the junction of a gully with the Big River, and running thence to the junction of Mosquito Creek with Flat Bottom Creek; within this line is contained the Wonungamya water and Mosquito Creek as far as its junction with Flat Bottom Creek; on the north by a scrub and Blake's Run.

## No. 29.

Clynos John.  
Name of Run—Keriongobeldi.  
Estimated Area—26,880 Acres.  
Estimated Grazing Capabilities—700 Cattle.

Situate on Sheep Station Creek and Miall Creek, the waters of the latter running into the former, within the boundary, the water running nearly from east to west; bounded on the east by William Hall's station, a marked tree on each side of the creek being the boundary, and by Henry Dangar's station, a gully known as the Horse Gully, and a gully known as the Rainbow Gully, being the boundary; bounded on the south by Mr. Hale's station a creek known as Bobby Whitlow creek, being the boundary; bounded on the west by the station of the Aberdeen Company, two gullies known as Green Wattle gully and Tea Tree gullies, being the boundary; bounded on the north by the station of Messrs. King and Gally, a range of mountains being the boundary.

## No. 30.

Callaghan Standish.  
Name of Run—Caidmurry.  
Estimated Area—Not stated.  
Estimated Grazing Capabilities—1,500 Cattle.

Bounded on the north by Mr. Crowder's run terminating at Collobigola on the west, and Mr. Crowder's hut on the east; on the west by the Barwin terminating north at Collobigola, and on the south at Mille; on the south by Mr. Isaac White's run commencing at Mille on the Barwin, and crossing the Balloon Creek below Collogorar eastern boundary bush unknown.

MEMO.—This Run is intersected by the Barwin, Balloon, and Goll Gell creeks.

## No. 31.

Crowder John and Alfred.  
Name of Run—Wirra.  
Estimated Area—54,000 Acres.  
Estimated Grazing Capabilities—2,000 Cattle.

Frontage the Barwin River, running in a north-easterly direction, west by a line running at right angles with the river from a tree marked, about

two miles below Mr. McDonald's hut on the opposite side; east by a line running from a marked tree at a water hole called Colly Ew, and crossing the Bomi at Mr. Bucknell's hut, and cutting the Gillgil Creek at Sir Thomas Mitchell's road; south by a line running parallel with the river, and 10 miles from it.

## No. 32.

Dangar Henry.  
Name of Run—Myall Creek.  
Estimated Area—48,000 acres.  
Estimated Grazing Capabilities—1,280 Cattle,  
8,000 Sheep.

Watered by Myall and Sheep Station Creeks; and bounded (commencing at the junction of the said creeks,) on the west and north-west by the Sheep Station Creek one mile, thence by a north line to the summit of the range dividing the waters of the said creek and Roody Creek; on the north and north-east by the range dividing the waters of Myall Creek and the McIntyre River, separating this run from Waterford's, McIntyre's, and Borthwick's runs, about 10 miles, and including all the table land and waters falling into Myall Creek; on the east and south-east by the dividing range of the waters of Myall Creek and the Big River, dividing this from Mr. Hale's run about 10 or 12 miles, the country being very broken; thence on the south by the same range to Clyne's Run; thence on the remainder of the west by a north line from the summit of the said range to the commencing corner, at the junction of the Sheep Station and Myall Creeks.

## No. 33.

Druitt George, (Executors of the Estate of.)  
Name of Run—Turrawa or Dindeerna.  
Estimated Area—32,000 Acres.  
Estimated Grazing Capabilities—1,200 Cattle.

Turrawa is situated on the eastern side of the Boomi Creek (which creek is an ana-branch of the Barwin,) having a frontage of 10 miles; it is bounded on the north by impenetrable scrubs; on the south by Mr. Crowder's run known as "Wirrar"; on the west by Boomi; and on the east by extensive plains. The country is well grassed, but the water is not permanent.

## No. 34.

Dight George.  
Name of Run—Boonal.  
Estimated Area—55,000 Acres.  
Estimated Grazing Capabilities—1,600 Cattle.

Commencing on the south side of the McIntyre, at the junction of the Severn, bounded by the Run of Messrs. Bounded on the north by the Bald hill ranges dividing Rocky Creek from Terry-hie-hie Creek; on the east by a range of mountains dividing it from Pallal Creek; on the south by a range of mountains dividing it from Lethbridge's Creek; and on the west by the range of mountains dividing it from the waters which fall into the Namoi River.

Estimated Area—64,000 Acres.

Estimated Grazing Capabilities—591 Cattle.

Bounded by Rocky Creek on the south, by Terry-hie-hie Creek on the east, on the north by Myall Creek, and on the west by a range of mountains.

Pringle Robert.

Name of Run—Winton.

Estimated Area—64,000 Acres.

Estimated Grazing Capabilities—853 Cattle.

Having 10 miles frontage on Tarrolwan or Robberina Creek with a 5 miles back run on each side, the boundary lines cutting the creek running north and south, bounded on the west by Mr. Jacob Low's eastern boundary denoted by a marked tree, and on all others by unoccupied Crown Lands.

Estimated Area—64,000 Acres.

Estimated Grazing Capabilities—1,320 Cattle.

On the east by a line running north and south cutting the M'Intyre at a point twenty yards east of the present stockyard at Terraba, indicated by a marked tree; on the south by a line parallel to and 5 miles distant from the said river; on the west by a line running north and south cutting

the M'Intyre River and Boomi Creek through a point on the former, distant by estimation 10 miles west from the tree first mentioned, which point is indicated by a tree marked with the letter P; and on the north by a line parallel to and 5 miles northward, distant from the said river.

Estimated Grazing Capabilities—2,000 Cattle.

Bounded on the north by a branch of the Big River and Mr. Fitzgerald's run; east by Mr. Cox's run and a marked tree line running north and south, commencing half a mile from the old hut; south by the Big River, Mr. Baldwin's and Mr. Bottington's runs; west by a line running north and south, commencing opposite Moonah hut adjoining Mr. Fitzgerald's and Mr. Cobcroft's runs.

## No. 80.

Parnell James.

Name of Run—Eulowrie.

Estimated Area—40,960 Acres.

Estimated Grazing Capabilities—1,000 Cattle.

Bounded on the north by Mr. Ogilvie's run, Gwydir River, below the crossing place, a ridge leading east to the mountains, and all waters that flow into the Gwydir above the crossing place; east by a range of mountains adjoining Mr. Capel's run, south by a range of mountains adjoining Mr. Eaton's run, Bell's mountain, and mountains adjoining; west by Mr. Ogilvie's run, Tea tree Creek, mountain, Mr. Bell's run, and paddock fence, a ridge, and also a mountain leading south to the river.

## No. 81.

Pitt G. M.

Name of Run—Coorar.

Estimated Area—72 Square Miles.

Estimated Grazing Capabilities—1,500 Cattle.

Bounded by R. Fitzgerald, Esq., on the south 6 miles; Coorar Creek and Mr. J. Hoskinson north 12 miles; R. Skuthorp west 6 miles; and on the south-west 12 miles by waste lands.

## No. 82.

Rusden Alice.

Name of Run—Lindesay.

Estimated Area—38,400 Acres.

Estimated Grazing Capabilities—2,000 Cattle.

Lindesay station situated at the head of the Gwydir River, being a block of country lying between two parallel lines, commencing at known points, 15 miles in extent, bearing north-west and north-east, and distant from each other throughout about 4 miles; the country being very much broken and intersected by ravines; the country included by these lines is not all available; the table land is considered to belong to Lindesay station; there is no trespass, as the nearest neighbours, Ogilvie and Lothbridge, are 16 miles from Lindesay and Onus, on the Namoi, 22 miles.

Name of Run—Blue Nobby.

Estimated Area—35,000 acres.

Estimated Grazing Capabilities—Together with following Run, 18,000 Sheep.

A continuation of Cunningham's Creek runs through the centre of the run, but is only a dry wa-

tercourse. The boundary on the north is a succession of myal and brigalow scrubs and plains, without permanent water through which the watercourse runs; on the east by a brigalow lagoon and the runs of Mrs. Dight and Mr. Simpson; on the south by a dividing line from Mr. Ottley running east and west; on the west by a low dividing range, separating the waters of Cunningham's Creek and Yalleroy Creek.

## No. 84.

Russell W. and G. Burges.

Name of Run—Eena.

Estimated Area—50,000 Acres.

Estimated Grazing Capabilities—Together with preceding Run, 18,000 Sheep.

The Macintyre River runs through the run from Mr. Hickey's boundary to the mouth of Eena Creek. Bounded on the north by Eena Creek and the waters thereto falling on the left bank of the river, and by Mundowio Creek and the waters thereto falling on the right bank of the river; on the east by the runs of Messrs. Keys and Blaxland; on the south and eastward by Wollongora run from a point fixed by Mr. Commissioner Mitchell three-quarters of a mile down the river from Mr. Hickey's hut door; on the west by Mr. Ottley's run and unappropriated land.

## No. 85.

Russell W. and G. Burges.

Name of Run—Tukka Tukka.

Estimated Area—35,000 Acres.

Estimated Grazing Capabilities—1,800 Cattle.

The Macintyre River flows through the run; a low flat country. Bounded on the north by thick brigalow scrubs; on the south-east by Mrs. Dight's run; on the south by brigalow and myal scrub; on the west by Messrs. Dight's run.

## No. 86.

Sculthorp Richard, Senr.

Name of Run—Bingerang.

Estimated Area—16,000 Acres.

Estimated Grazing Capabilities—700 Cattle.

On the south side of Gill-gill Creek. Bounded on the west by Mary and William Town; on the north by Gill-gill Creek; on the east by George M. Pitt; and on the south by lines to include the quantity.

## No. 87.

Single John.

Name of Run—Tellarraga.

Estimated Area—10,000 Acres.

Estimated Grazing Capabilities—1,500 Cattle.

Bounded on the east by Mr. Coberoff; west by O'Neil; north by Mr. Brown; and south by Mr. Bettington.

## No. 88.

Simpson R. Porey.

Name of Run—Trigamon.

Estimated Area—225,000 Acres.

Estimated Grazing Capabilities—12,000 Sheep.

Situated on the River Macintyre. Bounded on the north by Campbell's Creek and part of Simpson's or Oaky Creek; on the east by the Mundowio range of mountains; on the south by Mr. Ottley's Creek and the large plains of Amalgawitta; and on the west by the Plains of Yetman.

## No. 89.

White Edward.

Name of Run—Bromfield.

Estimated Area—64,000 Acres.

Estimated Grazing Capabilities—12,000 Sheep.

Bounded on the south by the Calladon Creek; on the east by Dangar's and Young's stations, on a north line 10 miles; on the north side (from the end of ten miles) by a westwardly line to a creek called Gither Gither; and on the west side by unappropriated country, on a southwardly line to Calladon Creek.

## No. 90.

White William (now Campbell and Ryan.)

Name of Run—Kelo.

Estimated Area—20,000 Acres.

Estimated Grazing Capabilities—1,000 Cattle, 4,000 Sheep.

On the south by a waterhole known by the name of Kelo; on the west by the River Barwan; on the north by a waterhole known as Kidemerce; on the east undefined.

*N.B.—This run has been transferred, with the sanction of the Government to Messrs. Campbell and Ryan, in whose names the Lease will accordingly be prepared.*

## No. 91.

Wiseman Richard Alexander.

Name of Run—Tyeannah.

Estimated Area—24,000 Acres.

Estimated Grazing Capabilities—1,200 Cattle, 5,000 Sheep.

Bounded by Messrs. Thomas Hall and O. Baldwin on the north; Bank of Australasia (Bumble) south; Wynn Baldwin (Onimale) west; and by G. Bowman on the east side; commencing from an oak scrub called the Black Scrub, and continuing on the north side of Bowman's Creek, 10 miles by  $2\frac{1}{2}$  miles wide to an old hut called the Ponds Hut, also commencing on the south side from a marked tree A. J., and continuing 5 miles by  $2\frac{1}{2}$  wide to the aforesaid ponds, making the run 10 miles by  $2\frac{1}{2}$  wide, north side of Bowman's Creek; and on the south side 5 miles by  $2\frac{1}{2}$  wide.

## No. 92.

Yeomans and Baldwin, per G. Yeomans.

Name of Run—Boogabilla or Bugobilla.

Estimated Area—64,000 Acres.

Estimated Grazing Capabilities—1,200 Cattle.

A perfectly flat country, alternate brigalow forest and plains; nearly the whole of the river front is a belt of barren scrub; a back watercourse running nearly parallel with the River at about 5 miles distance; the westerly portion of the run very scrubby. Boundaries determined by Mr. Commissioner Mitchell, and subsequently by Mr. Bligh as follows;—on the east a marked tree line commencing at a tree on the south bank of the M'Intyre River, half a mile eastward of the Bugobilla Hut, and running thence by compass due south; on the north the M'Intyre River from the said tree to a tree on the bank of the said river, marked Y, and distant from Bugobilla Hut about  $9\frac{1}{2}$  miles westward; and on the west a marked tree line running from the last mentioned tree due south by compass.
