PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ ROY, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

W HEREAS by an Act of the GOVERNOR and Legislative Council of New South Wales, passed in the fourth year of the reign of Her present Majesty Queen Victoria, intituled, "An Act " to provide for the more effectual administration " of Justice in New South Wales and its Depend-"encies," it was amongst other things enacted, that it should be lawful for the Governor of the said Colony, by Proclamation under his hand, issued and published from time to time, by and with the advice of the Executive Council of the same, to direct Circuit Courts to be holden in or at such towns or places within the Colony, as he should by the advice aforesaid think fit to appoint; and to fix from time to time, and vary or alter, as occasion may require, the times and places for holding the said Courts respectively;—and it was enacted, that every such Circuit Court should be holden by a Judge of the Supreme Court, and should have such ministerial officers as should be required; and whereas, under and by virtue of the said Act, Circuit Courts have been appointed to be and are holden in this Colony, in the towns of Maitland, Goulburn, and Bathurst; and, in addition to the said Courts, it has now become expedient that another Circuit Court shall be established, to be holden at the town of Brisbane; and whereas, for that purpose, it is necessary to vary the times for holding the said three first mentioned Circuit Courts; and it is convenient, therefore, to embody the several regulations concerning the whole in one Proclamation: Now,

therefore, I, the Governor aforesaid, with the advice of the said Executive Council, do hereby direct and appoint that Circuit Courts for the trial therein respectively of Criminal and of Civil Issues, and for the assessment of damages in actions at law, and the exercise of all other the powers vested in or incident to Circuit Courts in this Colony shall henceforth be holden, in the year now ensuing, and in every following year, before one of the said Judges, at the towns and on the days respectively hereinafter mentioned;—that is to say, at Goulburn, on the first Monday in the months of February and August; at Bathurst, on the third Monday, in the same months; at Maitland, on the first Monday in the months of March and September; and at Brisbane, on the second Monday in the months of May and November; and I do, with the advice of the said Executive Council, hereby further direct and appoint, that each of the said Circuit Courts shall, in addition to the Sheriff or his Deputy in attendance on the said Court, have the following ministerial officers,that is to say, a Clerk and a Crier of the Court, which Clerk shall be the Clerk of Assize and Arraigns of the same Court, and which Crier shall also be and act as Tipstaff: Provided that in all cases where the Clerk and Tipstaff of the presiding Judge shall not be prevented from attending the Court, the duties of the said offices shall respectively be discharged by such Judge's Clerk and Tipstaff.

Given under my Hand and Seal, at the Government House, Sydney, this thirteenth day of November, in the year of our Lord one thousand eight hundred and fortynine, and in the thirteenth year of Her Majesty's reign.

LL persons having claims on the Colonial Treasury are requested to furnish their accounts through the proper channel, before the end of the year or as soon thereafter as practicable.

The several Collectors and Officers in the receipt of public monies will pay over to the Colonial Treasurer, on or before the 31st of December, the amount of all collections remaining in their hands respectively up to that date, so that the entire Revenue collected by each may be credited in the accounts of the year within which it was received.

The Heads of Departments and other Officers who have received advances to enable them to defray expenses incurred under their superintendence, are requested to furnish to the Audit Office, as far as practicable, and with all convenient despatch, the accounts of the expenditure thereof, and on or before the last day of December to pay into the Colonial Treasury the unexpended balance of such advances, that the adjustment of the same may appear in the accounts to the 31st proximo.

They will also as soon as practicable, after the close of the year, bring forward all accounts of expenses incurred within the same which do not admit of being previously settled, so that if possible, all the expenses incurred in the present year may be finally adjusted and liquidated within one month after its termination.

The Colonial Treasurer is requested to use his endeavours to give effect to these directions, and to report through the proper channel, for the information of His Excellency the Governor, any instance of neglect in complying therewith on the part of the Government officers concerned.

HEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the fourth year of the reign of Her present Majesty Queen Victoria, intituled, "An Act to provide for the more effectual administration" of Justice in New South Wales and its Depend-" encies," it was amongst other things enacted, that it should be lawful for the Governor of the said Colony, by Proclamation under his hand, issued and published from time to time, by and with the advice of the Executive Council of the same, to direct Circuit Courts to be holden in or at such towns or places within the Colony, as he should by the advice aforesaid think fit to appoint; and to fix from time to time, and vary or alter, as occasion may require, the times and places for holding the said Courts respectively ; - and it was enacted, that every such Circuit Court should be holden by a Judge of the Supreme Court, and should have such ministerial officers as should be required; and whereas, under and by virtue of the said Act, Circuit Courts have been appointed to be and are holden in this Colony, in the towns of Maitland, Goulburn, and Bathurst; and, in addition to the said Courts, it has now become expedient that another Circuit Court shall be established, to be holden at the town of Brisbane; and whereas, for that purpose, it is necessary to vary the times for holding the said three first mentioned Circuit Courts; and it is convenient, therefore, to embody the several regulations concerning the whole in one Proclamation: Now,

therefore, I, the Governor aforesaid, with the advice of the said Executive Council, do hereby direct and appoint that Circuit Courts for the trial therein respectively of Criminal and of Civil Issues, and for the assessment of damages in actions at law, and the exercise of all other the powers vested in or incident to Circuit Courts in this Colony shall henceforth be holden, in the year now ensuing, and in every following year, before one of the said Judges, at the towns and on the days respectively hereinafter mentioned;—that is to say, at Goulburn, on the first Monday in the months of February and August; at Bathurst, on the third Monday in the same months; at Maitland, on the first Monday in the months of March and September; and at Brisbane, on the second Monday in the months of May and November; and I do, with the advice of the said Executive Council, hereby further direct and appoint, that each of the said Circuit Courts shall, in addition to the Sheriff or his Deputy in attendance on the said Court, have the following ministerial officers, that is to say, a Clerk and a Crier of the Court, which Clerk shall be the Clerk of Assize and Arraigns of the same Court, and which Crier shall also be and act as Tipstaff: Provided that in all cases where the Clerk and Tipstaff of the presiding Judge shall not be prevented from attending the Court, the duties of the said offices shall respectively be discharged by such Judge's Clerk and Tipstaff.
