PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

THEREAS by an Act of the Governor and Council of New South Wales, passed in the fourth year of the reign of Her present Majesty, intituled, "An Act for the Regulation of Gaols, "Prisons, and Houses of Correction, in the Colony of New South Wales, and its Dependen-"cies, and for other purposes relating thereto," it is enacted that all Buildings, Erections, Houses, and Premises, which should thereafter be erected, built, purchased, enlarged, or maintained at the public expense, as and for public Gaols, Prisons, and Houses of Correction within the said Colony and its Dependencies, and which should, by Proclamation, to be from time to time published in the New South Wales Government Gazette, by order of the Governor for the time being of the said Colony, be declared and notified as such public Gaols, Prisons, or Houses of Correction, should from and after the publication of such notification, be severally deemed and taken to be the public Gaol, Prison, or House of Correction of the place or District where the same was or should be situated within the said Colony or its Dependencies respectively, and should be subject

to the several provisions thereinafter made for the regulation, management, care and discipline of the public Gaols, Prisons, and Houses of Correction belonging to the said Colony and its Dependencies, and of the prisoners confined within the same; and whereas there has been for some time in course of alteration, as and for a public Gaol, the building formerly called and known by the name of the Female Factory, and now called and known as the Gaol, at Brisbane, in the District of Moreton Bay, in the said Colony; and it is expedient that the said Gaol should be and be declared to be a public Gaol, Prison, and House of Correction:—

Now, therefore, I, the Governor, by virtue of the said recited Act, and in pursuance of the power and authority thereby in me vested, do hereby proclaim, declare, and notify, the said building at Brisbane, to be a public Gaol, Prison and House of Correction.

PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ ROY, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

THEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the fourth year of the reign of Her present Majesty Queen Victoria, intituled, " An Act to "provide for the more effectual administration of Justice in New South Wales and its Depen-"dencies," it was amongst other things enacted, that it should be lawful for the Governor of the said Colony, by Proclamation under his hand, issued and published from time to time, by and with the advice of the Executive Council of the same, to direct Circuit Courts to be holden in or at such Towns or places within the Colony, as he should, by the advice aforesaid, think fit to appoint; and to fix from time to time, and vary or alter, as occasion may require, the times and places for holding the said Courts respectively, and whereas it is expedient that a Circuit Court should be held at the Town of Geelong, in the District of Port Phillip: Now, therefore, I, the Governor aforesaid, by and with the advice of the said Executive Council, do hereby direct and appoint that a Circuit Court for the trial of Criminal as well as Civil Issues shall be holden at the Town of Geelong aforesaid, and that during the year now next ensuing, and every following year until otherwise ordered, such Court shall be holden in the months of February, June, and October, commencing on the twentieth day of each of such months unless the same shall happen to fall on a Sunday, in which case the said Courts shall commence on the Monday next following.

PROCLAMATION.

By His Excellency Sir Charles Augustus Fitz Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c., &c.

HEREAS by an Act of the GOVERNOR of New South Wales, with the advice of the Legislative Council, passed in the second year of His late Majesty's reign, initialed, "An Act for re"pealing so much of an Act, initialed, "An Act
"to continue until further provision shall be
"made, certain Duties, Tolls, Rates, Fees, or
"other sums of money imposed by the Governor
"of New South Wales, and for other purposes,
"as relates to the levying of Tolls in New South

" Wales, and for raising a fund towards making, " repairing, and upholding Public Roads, Bridges, " 'and Ferries, and for regulating the collection " 'of Tolls thereon,' " it is amongst other things enacted, that it shall and may be lawful for the Governor of the said Colony, for the time being, by any Proclamation, or Proclamations under his hand, from time to time to appoint places at which Tolls shall be collected, and to cause the same to be colshall be wholly or partly made, and which has been, or shall be wholly or partly made, and which is re-paired at the public expense; and to cause Toll to be collected at any Bridge built, purchased, or repaired at the public expense, and at any Ferry constructed or upheld at the same; and to cause such Gates, Bars, Chains, Rails, and Fences, to be built and set up, as shall be deemed necessary for preventing passengers, beasts, and carriages from passing, unless there shall be then paid such Toll as shall be due or demandable under the authority of the said recited Act; and whereas it has become necessary to appoint a place at the crossing of the Snowy River, at Janmingee, about four miles below the junction of the Bobundara Creek with the Snowy River, where the road from Cooma to Gipps' Laud meets that River, for the purposes of the said recited Act; now, I, the Governor aforesaid, in pursuance of the authority vested in me by the said recited Law or Ordinance, do, by this my Proclamation, hereby appoint the said crossing of the Snowy River, at Janmimgee, to be a place at which a Ferry shall be established, and at which Tolls shall be collected, to the amount and under the regulations, restrictions, and provisions of the said recited Law or Ordinance, of which Ferry all persons concerned are hereby required to take due notice.

—CONDITIONAL PARDON. REWARD.
