#### FLOATING LIGHTS IN THE PRINCES CHANNEL.

Trinity House,  
London, 22nd August, 1848.

Notice is hereby given, that in compliance with the request of numerous owners and masters of vessels, and other persons using or interested in the navigation between the North Foreland and the Nore, two floating light vessels are about to be placed in the Prince's Channel; the lights on board of which will be first exhibited on the evening of Sunday, the 1st day of October next, and thenceforth continued every night from sun-set to sun-rise.

#### PROCLAMATION.

By His Excellency Sir Charles Augustus Fitz Roy, Knight Companion of the Royal Hanoverian Guelphic Order Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c. &c.

**W**HEREAS by an Act of the Governor of New South Wales, with the advice of the Legislative Council thereof, passed in the sixth year of her Majesty's Reign, intituled, "An Act to provide for the division of the Colony of New South Wales into Electoral Districts, and for the election of Members to serve in the Legislative Council," certain acts and things are thereby required to be done and performed by the Governor of the said Colony, but to whom however was given power to delegate to any other person the performance of any such act or thing, provided such delegation be made under His hand and the Seal of the Colony, and be duly announced in the New South Wales Government Gazette:

Now, therefore, I, Sir Charles Augustus Fitz Roy, Knight-Companion of the Royal Hanoverian Guelphic Order, as such Governor as aforesaid, being about to absent myself temporarily from the seat of Government, do hereby, in pursuance of the said recited Act, announce and proclaim that I have this day duly delegated and appointed unto his Honor Charles Joseph La Trobe, Esquire, the Superintendent of the District of Port Phillip, in the said Colony, full power and authority during such my absence, to appoint such additional officers as may be necessary to complete the registration of Voters in any Electoral Districts within the District of Port Phillip, and also, in the event of a deficiency of Magistrates for the revision of the Electoral Lists in any such District, in the manner contemplated by the said Act, to appoint other persons to perform any of the duties therein directed to be performed by Magistrates in Petty Sessions assembled, as may be done by the Governor of the said Territory under the provisions of the said recited Act.

Given under my Hand and Seal, at Government House, Sydney, this Twenty-sixth day of February, in the year of Our Lord One thousand eight hundred and forty-nine, and in the twelfth year of Her Majesty's reign.

# OCCUPATION OF CROWN LANDS WITHIN THE SETTLED DISTRICTS.

REFERRING to the 9th clause of the Regulations for the occupation of Crown Lands within the Settled Districts, dated 29th March, 1848, which declares that leases obtained under those Regulations will not be assignable, nor shall any portion of the lands held thereunder, be assigned or sub-let, under penalty of absolute forfeiture of the lease, His Excellency the Governor, with the advice of the Executive Council, directs it to be notified, that Leases obtained under the 22nd clause of the same Regulations of Lands brought by Her Majesty's order in Council within the Settled Class, but which were previously occupied under Squatting Licenses for pastoral purposes, may be transferred as heretofore with the approval of the Government, notwithstanding the general provision against the assignment of leases contained in the 9th section of the Regulations as above quoted.

2. It is however, to be clearly understood, that the subletting or the transfer of portions only of the holdings to which this rule refers, will not be allowed, and that the rule is applicable only to the particular class of Lands above described.
