PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ ROY, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the second year of the reign of Her Majesty Queen Victoria, intituled, "*An Act for regulating the Police in the Towns of Parramatta, Windsor, Maitland, Bathurst, and other Towns respectively, and for removing and preventing nuisances and obstructions, and for the better alignment of streets therein*," it was amongst other things enacted, that upon a description of the boundaries of the said Towns being published in the New South Wales Government Gazette, the same should be deemed to be the limits of the said towns respectively: Now, therefore, I, the Governor aforesaid, do hereby direct, that the following shall be deemed to be the boundaries of the said *Town of Windsor*, for the purposes of the said Act, that is to say:—Commencing at the point where the western side of Palmer-street meets South Creek; and bounded thence by South Creek to a stake situated on the bank of the Creek on Fitzgerald's farm; from this stake by a line bearing west 91 chains to another stake; from this by a line passing the north fence of land belonging to the Benevolent Asylum, bearing west 34 degrees, north 52 chains 80 links,

to a marked dead stump on Rickaby's Creek; from this stump by Rickaby's Creek to the Hawkesbury River; by the Hawkesbury River to the point where the western side of Palmer-street meets that river; and thence by the western side of Palmer-street to South Creek aforesaid.

POSTAGE.—PETITIONS.

SOME recent cases having occurred, in which persons have forwarded to this Department, under sealed cover, Petitions addressed to the Governor, under the impression apparently that they were free of Postage, His Excellency directs it to be notified, that according to the provision contained in the 17th clause of the Act 13 Vict., No. 38, Petitions of the above nature, in order to be free of Postage, must be sent *without covers, or in covers open at the sides.*

2. In every case where this Regulation is disregarded, the petition will be liable to the usual Postage, which in conformity with the rule laid down, in the Notice of 11th January last, must be pre-paid.

3. For more convenient reference, the clause of the Act referred to is reprinted herewith.

" 17. And be it enacted, That Members of the Executive and Legislative Councils may receive by the post petitions and addresses to Her Majesty and His Excellency the Governor, and petitions addressed to either the Executive or Legislative Council, not exceeding thirty-two ounces in weight, exempt from postage : Provided such petitions and addresses be sent without covers, or in covers open at the sides."

TRANSFERABLE AND REMITTABLE LAND AND

IMMIGRATION DEBENTURES.

SEALD Tenders will be received at this Office until noon of Monday the 25th instant, from persons desirous of advancing the whole or any portion of the Sum of Twenty-five thousand pounds on the following security, and subject to the undermentioned terms and conditions, viz.:—

(1.) Each tender must be for an even sum of hundreds of pounds, and must be endorsed "Tender for Debentures."

(2.) If the tender be accepted, Land and Immigration Debentures for £100 each, secured upon the Territorial Revenue of the Sydney or Middle District, will be issued for the sum advanced, and will bear interest at the rate of 3½d. per diem, or £4 18s. 10½d. per £100 per annum, payable half-yearly, on the 1st of January, and 1st of July.

(3.) They will be receivable as cash at any time for the purchase of Crown Lands in the Sydney District, or for any other payment due on account of the Territorial Revenue within the same.

(4.) (8.) Whenever a Debenture may be made payable in London a Duplicate thereof will be transmitted by the Colonial Treasurer to the Colonial Agent General by such opportunity as the holder may desire, in order that the same may be available on proof of the loss of the original.

(9.) The Debentures will be transferable, if made out in blank, in the same manner as Exchequer Bills; but if made payable to any individual or firm, then by endorsement as in the case of Bills of Exchange.
