PROCLAMATION,

By His Excellency Charles Joseph La Trobe, Esquire, Licutenant Governor of the Colony of Victoria and its Dependencies, &c., &c., &c.

WHEREAS by an Act of the Imperial Parliament of Great Britain and Ireland, made and passed in the fifth and sixth years of the Reign of Her Majesty Queen Victoria, intituled "An Act for the Government of New South "Wales and Van Diemen's Land." It is amongst other things enacted, that it shall be lawful for the Governor of New South Wales to fix such place or places within any part of the said Colony, and such times for holding the first and every other Session of the Legislative Council, constituted under the said recited Act, as he might think fit. AND WHEREAS by a certain other Act of the said Parliament made and passed in the 13th and 14th years of the Reign of Her said Majesty, intituled "An Act for the "better Government of Her Majesty's Australian " Colonies." It is amongst other things enacted, that after the separation of the said Colony of Victoria from the Colony of New South Wales, there shall be within and for the said Colony of Victoria a separate Legislative Council, and that subject to the provisions therein contained the provisions of the said first recited Act as explained and amended by certain Acts of Parliament therein mentioned, concerning amongst other things the places and times of holding the Legislative Council of New South Wales shall apply to and be in force in the said Colony of Victoria. NOW THEREFORE, I, Charles Joseph La Trobe, Esquire, as such Lieutenant Governor as aforesaid, do hereby in pursuance of the power and authority so in me vested, announce and proclaim that the first Session of the Legislative Council of the said Colony of Victoria shall commence and be holden on Tuesday, Victoria a separate Legislative Council, and that toria shall commence and be holden on Tuesday, the Eleventh day of November, in the year of

our Lord 1851, at 12 of the clock at noon, in the building known as the St. Patrick's Hall, situate in Bourke-street, in the City of Melbourne. And the Members of the said Council are hereby required to give their attendance at the said time and place accordingly.

Given under my Hand and Seal at Melbourne, in Victoria, this seventeenth day of October, A.D. 1851, and the fifteenth year of Her Majesty's reign.

August last, flis Excellency the Lieutenant-Governor has been further pleased to direct that every exertion will be made by the Commissioners for the Gold Districts, to prevent seamen or other persons leaving their hired service, without permission of their employers, from obtaining licenses to search for gold, and further that any persons known or recognized to have been at a late date in the public service will not be allowed to hold a license to dig or search for gold, unless satisfactory proof be given that their leaving the service at this juncture, has not only been authorized, but is unattended with embarrassment to the Government.

Colonial Secretary's Office, Melbourne, 30th September 1851. CONVEYANCE OF GOLD UNDER ESCORT FROM BUNINYONG.

IS Excellency the Lieutenant Governor directs it to be notified that arrangements have been made for the conveyance of Gold from Buninyong to Melbourne and Geelong once a week under the charge of an armed escort.

2. The Escort will leave Buninyong every Tuesday morning at 6 o'clock, will arrive at Geelong that evening at 4 o'clock, and the following morning will leave for Melbourne, where it will arrive the same day at half past three o'clock

- 3. Persons desirous of forwarding gold under the security afforded by this Conveyance are to take care that it is forwarded to Buninyong not later than 4 o'c'ock P.M. of the Monday preceding the departure of the escort, by which it is wished it should be sent. A responsible officer will be appointed to take charge of it at Buninyong into whose charge it is to be delivered, and he will be instructed previously to receiving it, to have it accurately weighed in the presence of the perso. bringing it, he will then tie it up in a leather bag, seal it, and attach a label to it, on which the weight of the gold is to be stated, the name of the person sending it, and also the name of the person to whom it is consigned, and whether residing in Melbourne or Geelong. The Officer acing for the Government in this matter will grant a receipt to the depositor of the Gold, containing the above particulars. A notification will shortly appear in the Government Gazette appointing an Officer to conduct this business
- 4. There will be two boxes in which the gold to be escorted will be secured, the one for Geclong the other for Melbourne. On the arrival of the escort at Geelong both boxes will be placed in charge of the Police Magistrate, and he will the following morning deliver the box containing the gold for Melbourne to the Officer in charge of the esco t, who upon reaching Melbourne will forthwith deliver it to the Colonial Treasurer.

5. Persons to whom the gold is consigned will receive it from the Colonial Treasurer or the Police Magistrate of Geelong, upon producing their authority, signing receipts for it, and paying the escort charge of one per cent on washed gold, to be estimated at the rate of £3 the ounce, and on gold mixed with a larger portion of stone at the rate of £2 10s, the ounce

6. Every precaution will be taken for the safety of the gold sent under escort, but in the event of loss the Government will not be responsible for it.

Thaving been ascertained that it would be more convenient to the persons wishing to send gold by the Weekly Escort, if it were depo-sited with the Commissioner at the workings, instead of with the Police Magistrate at Buninyong; intimation is given that His Excellency the Lieutenant Governor has caused arrangements to be made for this purpose. Persons therefore wishing to take advantage of the Escort can place their gold in charge of Mr. Commissioner Doveton, by application to him on

the ground.

It is also notified, that those persons who have no agents, and who may wish to deposit their gold in a place of safety, until they can make arrangements for the disposal of it, will be allowed to place it in the custody of the Colonial Treasurer, in which case a document must be prepared, in duplicate, stating the contents of the bag in which the gold is secured, the name and sufficient description of the owner for identification, one of which is to be sent to the Colonial Treasurer and the other to be kept by the owner, and to be presented by him to the Colonial Trees rer when the gold is claimed.

CERTIFICATES OF NATURALIZATION.

THE LIEUTENANT GOVERNOR directs it to be notified, that in pursuance of the 10th section of the Act of the Governor and Legislative Council of New South Wales, 11 Victoria, No. 39, intituled, "An act to amend the laws relating to Aliens within the Colony of New South Wales, a fee of £1 1s. (one pound one shilling) has been fixed by His Excellency, with the advice of the Executive Council, to be paid by each person to whom a Certificate of Naturalization may be issued, under the provisions of the Act referred to.

2. His Excellency has further directed it to be notified, that any person desirous of obtaining a Certificate of Naturalization, should make application by memorial, in the form hereto annexed, stating in conformity with the 5th section of the Act above-mentioned, the age, profession, trade or other occupation of the Memorialist, and the duration of his or her residence in Victoria, and all other the grounds on which he or she seeks

to obtain any of the rights and capacities of a natural born British subject within the Colony.

3. Should the Certificate be granted, it will be necessary for the person obtaining it, to have it enrolled in the Supreme Court, as required by the 7th section of the Act; and within sixty days from the date thereof, to take and subscribe before a Judge of the Supreme Court, the oath prescribed in the 8th clause.

4. For more convenient reference, the clauses of the Act which relate to the proceedings to be taken for obtaining the Certificate, are subjoined to the form of memorial annexed to this notice.

IV. And be it enacted, That upon obtaining the certificate and taking the oath hereinafter prescribed, every alien now residing in, or who shall hereafter come to reside in, any part of the Colony of Victoria, with intent to settle therein, shall enjoy all the rights and capacities within the said Colony which a natural born subject of the United Kingdom of Great Britain and Ireland can enjoy or transmit, except that such Alien shall not be capable of becoming a Member of the Executive or Legislative Council of the said Colony, or of enjoying such other rights and capacities, if any, as shall be specially excepted in and by the certificate to be granted in manner hereinafter mentioned.

(Aliens desirous of being naturalized to present a memorial to the Lieutenant Governor.)

V. And be it enacted, That it shall be lawful for any such Alien as aforesaid to present to the

Insert District or Town, and Country.
Profession, Trade or Calling.

Here state the grounds on which the Certificate is desired.

Lieutenant Governor of the said Colony, for the time being a memorial stating the age, profession, trade or other occupation of the memorialist, and the duration of his or her residence in Victoria, and all other grounds on which he or she seeks to obtain any of the rights and capacities of a natural born British subject, within the said Colony, and praying the said Lieutenant Governor to grant to the memorialist the certificate hereinafter mentioned.

(Memorial to be considered by Lieutenant Governor who may grant a certificate.)

V1. And be it enacted, That every memorial shall be considered by the said Lieutenant Governor, who shall inquire into the circumstances of each case, and receive all such evidence as shall be offered by affidavit or otherwise, as he may deem necessary or proper for proving the truth of the allegations contained in such memorial; and that the said Lieutenant Governor if he shall so think fit, may issue a certificate reciting such of the contents of the memorial as he shall consider to be true and material, and granting to the memorialist (upon his or her taking the oath hereinafter prescribed) all the rights and capacities within the said Colony of Victoria, of a natural born British subject, except the capacity of being a Member of either the Executive or the Legislative Council, and except the rights and capacities (if any) specially except in and by such certificate.

(Certificate to be enrolled.)

VII. And be it enacted, That such certificate shall be enrolled for the safe custody as of record, in the Supreme Court of the said Colony, and may be inspected, and copies thereof taken, under such regulations as a Judge or Judges of the said Supreme Court shall direct.

(Oath to be taken.)

VIII. And be it enacted, That within sixty days from the day of the date of such certificate, every memorialist to whom rights and capacities shall be granted by such certificate, shall take and subscribe the following oath, (that is to say): "I, A, B., do sincerely promise and swear, that I will be faithful and bear true allegiance to Her Majesty Queen Victoria, and will defend Her to the utmost of my power against all conspiracies, and attempts whatever which may be made againt Her Person, Crown, or Dignity; and I will do my utmost endeavour to disclose and make known to Her Majesty, Her Heirs and Successors, all treasons and triatorous conspiracies which may be formed against Her and Them; and I do faithfully promise to maintain, support and defend to the utmost of my power the succession of the Crown, which succession by an Act intituled, "An act for the further limitation of the Crown and better securing the rights and liberties of the Subject," is and stands limited to the Princess Sophia, Electress of Hanover, and the Heirs of Her Body, being Protestants, hereby utterly renouncing and abjuring any obedience or allegiance unto any other person claiming or pretending a right to the Crown of this realm.—So help me God:" Which oath shall be taken and subscribed by such memorialist, and shall be duly administered to him or her before any one of the Judges of the Supreme Court of Victoria, and that the Judge before whom such oath may he administered, shall grant to the memorialist a certificate of his or her having taken and subscribed such oath accordingly; and such certificate shall be signed by the said Judge.

(Certificate.)

IX. And be it enacted That the several proceedings hereby authorised to be taken for obtaining such certificate as aforesaid, shall be regulated in such manner as the Lieutenant Governor of the said Colony for the time being shall from time to time direct.

(Fees to be fixed by the Lieutenant Governor and Executive Council.)

X. And be it enacted, That the fees payable in respect of the several proceedings hereby authorised, shall be fixed and regulated by the said Lieutenant Governor-with the advice of the Executive Council.

Tenders for each of the above to be enclosed in separate envelope, scaled and endorsed "Tender for" (as the case may be), and deposited in the box marked "Tenders for works and stores" placed in the entrance passage of the Colonial Treasury, William street, or forwarded per post prepaid, and addressed to the "Board for opening Tenders" Colonial Treasury, Melbourne.

The Government will not necessarily accept the lowest or any Tender.

CONDITIONS.

1. All the articles above enumerated, are to be of the best quality of their several kinds, and must be (in cases where samples are required),

equal to those provided and left with the tenders at the Treasury.

2. One price is to be stated for each article.

3. All orders for supplies under this contract must issue from the Colonial Storekeepeepers' department, to which office the supplies must be delivered for inspection an approval.

- 4. In the event of a difference of opinion between the contractor and the party receiving the supply, as to the quality, such difference is to be decided by a Board of Survey, to consist of the party receiving the supply, the contractor, and a party appointed by him, and a second Government officer.
- 5. If the Board shall decide that the article is not of proper quality it must be immediately replaced by the contractor, failing which it will be procured elsewhere, and the extra expense, if any, deducted from the amount then due to the contractor by the party requiring it.
- 6. In the event of any unnecessary delay or failure of the contractor to supply the articles when required, they will be otherwise procured and charged in like manner.
- 7. A repetition of irregularity in the quality or quantity of the supplies, or of any delay in delivering or replacing them when required, will subject the contractor to the forfeiture of his con-
- 8. It will be in the power of either party to limit the duration of the contract, by giving in writing a notice of one calendar month to the opposite party, and to end the contract at the expiration of that period, it being understood that such notice can be given only on the first day of a month, and within the period for which the contract is made or agreed to be made.
- 9. Each supply must be accompanied by an invoice, shewing the quantity of the supply, which invoice must be signed by the party receiving the stores, and these receipts are to be produced with the contractors' quarterly accounts; no goods will be received unless accompanied by such an invoice.
- 10. The value of all packages to be included in the prices demanded.
- 11. The Contractors will be required to prepare their own quarterly accounts in the pre-scribed form, and leave them at the Auditor General's office, to be forwarded from that department to the Treasury, and upon approval pays ment will in due course be made.
- 12. Security will be required in the sum of one hundred pounds for the due fulfilment of the contract.
- 13. No tender can be considered unless accompanied by a certificate from the parties proposed as security for the contractor, and the bond must be executed within ten days from the notification of the acceptance of the tender, failing which the contract will be again advertised or another tender accepted.
- 14. The Tenders to contain the names of the tenderers and their surcties, with their places of residence at full length.

CONTRACTS FOR THE COLONIAL SER-VICE FOR 1852.

OTICE is hereby given that Tenders will be received at this Office until Saturday the 8th November next, for furnishing the undermentioned supplies for twelve calendar months, commencing 1st January, 1852, upon the conditions hereafter specified.

DAILY RATIONS OF PROVISIONS.

No. 1. Emigrants.—For men 24 oz wheaten bread, 16 oz fresh meat, 8 oz vegetables, half oz salt, quarter oz tea, one and a half oz sugar, quirter oz soap. For women—16 oz wheaten bread, 12 oz fresh meat, 6 oz vegetables, half oz salt, quarter oz tea, one and a half oz sugar, half oz soap,. Children under 10 years to be allowed two-thirds the rations of female adults; above that age and under fifteen the same as adults.

No. 2. To prisoners of the Crown and others in the employment of the colonial department-16 oz wheaten bread, 8 oz maize meal, 16 oz fresh meat, quarter oz salt, 1 oz sugar, quarter

oz soap, 16 oz vegetables.

No. 3. To officers in charge of surveying parties when in field, and men composing such parties-24 oz flour, 16 ozs fresh or salt beef, half oz salt, half oz tea, two and a half oz sugar, half oz tobacco, quarter oz soap; or, in lieu thereof, if preferred, 24 oz flour, 24 oz fresh or salt beef one oz salt, half oz tea, 4 oz sugar.

No. 4. Prisoners confined in goal - 12 ozs wheaten bread, 12 oz maize meal, 4 oz fresh beef 8 oz vegetable, half oz salt, quarter oz soap. (Ration No. 2 is issued to gaol attendants, and to witnesses, and others waiting bail; and if confined in solitary cells, ration No. 8)

No. 5. Children of female prisoners confined in gaol-8 oz wheaten bread, 4 oz fresh beef, 1

pint milk, quarter oz yellow soap.

No 6. Prisoners confined in lock-up or watch-

houses—24 oz wheaten bread.

No. 7. Forage for horses and oxen, in all colonial service-8lbs maize or barley, or 10lbs oats as demanded, 4lbs bran, 12lbs oaten or cultivated grass hay, and 4 lbs wheat straw for eash horse per day, and half the quantity for

each bullock. No. 8. For men attached to Lighthouses, Teiegraphs, Water Police, and Harbour Master's boat's crews-24 oz wheat bread, 16 oz fresh beef, a quarter oz salt, one quarter oz soap.

No 9 Fuel and light-sperm and common oil per gallon, mould and dip candles per lb

cotton wick ditto.

No. 10. For the Lunatic Asylum, Yarra, fresh beef, fresh mutton, suet, wheaten bread, bread of the 1st quality, flour 1st. quality raisins, rice, tea, sugar, salt, pepper, milk, tobacco, soap, vegetables, port wine, vinegar sago, oatmeal, arrowroot, treacle, dip candles, common oil, common wick, forage, per ration, reach lime, straw, in such quantities as may be required.

Military rations of provisions for native Police, or other mounted force, if required, 24oz flour 16 oz fresh or salt beef, half oz salt half oz tea two and a half oz sugar. half oz tobacco quarter oz soap.

For Hospitals, Aboriginal Establishments, Native Police, and all other services when ordered-20 per cent. flour, fresh beef and mutton, wheaten bread, (first second and third quality), maize, meal, bottled port wine, arrowrott, rice,

sago, pearl barley, tea sugar, salt, oatmeal, yellow soap, colonial tobacco, vegetables, milk, vinegar, straw, common oil, dipt and mould candles, rum, brandy, porter, cotton, wick, salt beef, and salt pork.

CONDITIONS.

1. All the articles required by this notice are to be of the best quality of their several kinds.

2. The flour and bread must be the produce of clean'sound colonial wheat, from which on the rations of emigrauts, surveying parties, border police, 20 per cent, and on the ration to prisoners of the crown 10 per cent. has been extracted in bran and waste.

3. Beef and mutton to be issued in such proportions as may be required, and when the quantity'admits of it, to be delivered in fore and hind

quarters alternately.

4. The maize meal to be similar in quality to the wheat meal, and to be twice ground.

- 5. When it may be necessary to substitute one article for another, the following proportions are to be observed, viz., 1lb wheat flour, or 1lb biscuit equal to $1\frac{1}{4}$ lb bread; 11b salt beef or 11b mutton, or 10 oz salt pork, equal to 1lb of fresh
- 6. The tobacco to be the best colonial.
- 7. The above substitutions are not to be made except on the requisitions of the officer authorised to draw the several rations.
- 8. Vegetables to be supplied in reasonable proportions of potatoes, greens, pumpkins, onions,
- 9. The supplies for road parties and surveying parties are to be delivered at the nearest fixed stations to the places where the party may be employed, on the requisition of the officer in charge; and in case the whole ration of forage be not required or delivered, each of the species to be reckoned as the portion of the ration undermentioned:—The maize or barley 4-12—the hay 5-12—the bran 2-12—the straw 1-12.

10. The supplies (not specified in the preceeding paragraphs) are to be delivered direct to the parties or establishment entitled thereto, on the written order of the person duly authorised for

the purpose.

11. Provisions, and forage, when required by rations, according to the scales under their respective heads, the tenders are to express the

- price per raition only.

 12. The tenders for forage are not required to state the price per ration for oxen, as when the latter is required, one half the allowance fixed for horses will be drawn, and one half the price allowed to the contracter, whose engagement is to provide for both horses and oxen.
- 13. In the event of a difference of opinion between the contractor and the party receiving the supplies, as to the quality the same is to be decided, in cases where the article is not of a perishable nature, by a Board of Survey according to the practice of the service. But in country districts, where a Board of Survey connot be conveniently assembled, the party objecting will name one person as arbitrator, the contractor or his agent another, and these two will (previously to any other proceeding on their part) concur in naming a third, as umpire, who in the event of the arbitrators not agreeing in opinion, will be called upon for his decision which shall be final.
- 14. If the board, arbitrators, or umpire shall decide that the article is not of proper quality, it must be immediately replaced by the contractor,

failing of which it will be procured by the department requiring it, and the expense charged to the contractor.

15. In the event of any unecessary delay or failure of the contractor to supply the articles when required, they will be otherwise procured

and charged in like manner.

- 16. In cases where the article is of a perishable nature, or from some other cause, injury would be sustained either by the parties to whom the rations are due or the contractor, by waiting for a Board of Survey, the head of the department or officer in charge of the party or parties for whom the rations are to be received, shall have the power to reject such article or articles as are obviously of inferior quality; it being distinctly understood that he will be responsible to the government for so doing; and that the contractor will have a right of appeal to the Governor, although in the meantime he must take back the rejected article and supply good in its stead, failing of which it will be obtained by the officer or party requiring it, and the expense charge to the contractor.
- 17. A repetition of irregularity in the quantity or quality of the supplies, or of any delay in delivering or replacing them when required, will subject the contractor, upon the report of the officer in charge of the parties or establishment, to such mulet, not exceeding one-fourth the amount of his monthly account, as the Governor may direct. It will also be in the power of the Governor, upon such repetition, to terminate the contract forthwith.
- 18. It will be in the power of either party to limit the duration of the contract, by giving in writing a notice of three full calender months tothe opposite party, and to end the contract at the expiration of that period, it being understood that such notice can be given only from the first day of a month, and within the period for which the contract is made or agreed to be made.
- 19. The contractor will be required to prepare his own account, monthly or quarterly, in the prescribed form; and on the production thereof, with the requisite vouchers in a complete state, to the Auditor General for examination, and upon their approval, a warrant will be prepared; and payment made from the Colonial Treasury.
- 20. The value of all packages to be included in the prices demanded.
- 21. Printed forms of tender may be obtained from the Auditor General; and a security of £2000 will be required for the due fulfilment of the contract. No tender can be attended to unless accompanied by a certificate from two responsible parties proposed as security, stating they are willing to become bound as securities for the contractor accordingly, and the bonds must be executed within twenty days, from the day of acceptance of the tender being notified, failing of which the contracts will be again advertised or another tender accepted.
- 22. The tenders to contain the names of the tenderers and their sureties, and places of residence at length.
- 23. All tenders to be enclosed in a separate envelope, and marked "Tender for provisions, &c." and to be deposited in a box marked, "Tender" at the western entrance of the Government
- 24. The tenders must include the whole of the rations and separate 'articles above mentioned.

25 The tenders are to be given in for the undermentioned districts, which may be tendered for separately or collectively. When the latter is the case each locality, as given below, must be stated in the tender.

1. Melbourne, including the county of Bourke the Mounted and Police Stations on the Goulburn and Broken Rivers, and any other Stations on or near the Sydney Road within the Province of Victoria, also the Aboriginal Stations at the Golbourn and Loddon.

2. Geelong, including the county of Grant. 3. The county of Normanby, and the towns

of Portland, Port Fairy, and Warnambool.
4. Gipps Land, including Alberton.
