PROCLAMATION.

No. 25.

By His Excellency Charles Joseph La Trobe, Esquire, Lieutenant Governor of the Colony of Victoria, and its Dependencies.

WHEREAS by an Act of the Governor and Council of New South Wales, passed in the fourth year of the Reign of Her present Majesty, intituled, "An Act for the Regulation of Gaols, Prisons, and Houses of Correction, in the Colony of New South Wales and its Dependencies, and for other purposes relating thereto;" it is enacted, That all buildings, erections, houses, and premises, which should thereafter be erected, built, purchased, enlarged, or maintained at the public expense, as and for public Gaols, Prisons, and Houses of Correction, within the said Colony, and its Dependencies, and which should, by Proclamation to be from time to time published in the New South Wales Government Gazette, by order of the Governor for the time being, of the said Colony, be declared and notified as such Public Gaols, Prisons, or Houses of Correction; should from and after the publication of such notification be severally deemed and taken to be the Public Gaol of the Place or District where the same was or should be situated, within the said Colony, or its Dependencies, respectively, and should be subject to the several provisions thereinafter made for the regulation, management, care and discipline of the Public Gaols, Prisons, and Houses of Correction, belonging to the said Colony, and its Dependencies, and of the Prisoners confined within the same: And whereas it is expedient that the Buildings and Premises now called and known as the Richmond No. 25,-June 24TH, 1852.-1.

Stockade, with the Reserve attached thereto, in the Colony of Victoria, should be and be declared as a House of Correction: Now, therefore, I, the Lieutenant Governor aforesaid, by virtue of the said recited Act, and infurtherance of the power and authority thereby in me vested, and of all other powers enabling me in this behalf, do hereby proclaim, declare, and notify the Buildings and Premises called and known as the Richmond Stockade, with the Reserve attached thereto, containing twenty-five acres two roods, in the Parish of Jika Jika, in the County of Bourke, in the aforesaid Colony of Victoria, Allotment No. 32, commencing at the north-east corner of the Allotment, and bounded on the north by Allotment 33, bearing west 25 chains 50 links; on the west by Allotment 34, bearing south 9 chains 50 links; on the south by a Road of one chain wide, bearing east 29 chains 40 links to the Yarra Yarra River; and on the cast by that River northwards to the commencing point; reserving to the use of the public a Road one chain wide, leading in a north-casterly direction to the New Bridge over the Yarra Yarra River,—to be a House of Correction.

Given under my Hand and Seal at Melbourne, in the Colony of Victoria, this Twenty-third Day of June, in the Year of our Lord One thousand eight hundred and fifty-two.
