"Your petitioners therefore humbly pray your Excellency will be pleased to interpose, so that the influence and authority of the Govern-ment may be exerted to shield them from so great an injustice.

"And, further, your petitioners hereby declare their desire that the provisions of the aforesaid Municipalities Act should be extended to them at the earliest possible period, and humbly pray that your Excellency will be pleased, for that purpose, to proclaim the area contained within the following boundaries a Municipal District, that is to say :- Commencing at the Sandridge public pier, running westerly to the junction of the river Yarra Yarra with Hobson's Bay; bounded by Hobson's Bay from the said junction, up the said river to a point on the bank of the said river, opposite the Gas Works; bounded by the river Yarra Yarra from such said point to the Sandridge Road, at a point on the said road about ten chains from the head of the Sandridge Lagoon, in the direction of Emerald Hill; bounded by a straight line from the latternamed point to the boundary of the proposed park, at point to the boundary of the proposed park, as its junction with a certain place described on the Government Survey Maps as Dundas Place; bounded by a straight line along Dundas Place, by the boundary of the proposed park, to the three-chains-wide road proposed to be made, as laid down in the Government Survey Maps; by the said road to the sea-beach, and from the point where the said road terminates at the sea-beach along the beach to the commencing point, namely, the Sandridge public pier; which said boundaries are shown on the accompanying map, and therein marked red.
