Every water drawer for hire shall keep his cart or dray loaded with water from sunset to sunrise, and on neglect thereof he shall forfeit and pay for every such offence a sum not exceeding Forty shillings.

Every water drawer for hire when called upon to attend a fire by a policeman or fireman shall on neglect or refusal of the same forfeit and pay for every such offence a sum not exceeding Forty shillings.

9. All monuments, vaults, graves, gravestones, and fences to be kept in repair and proper condition at the expense of the dwners.

14. No servant or other person employed by or engaged in any duty on behalf of the council, will be permitted to receive any gratuity for the discharge thereof.

The keeper shall have power to turn out or to take into custody (as the case may require) any person who shall behave indecorously, or commit any trespass or injury to the trees, flowers, or erections, or otherwise infringe the Act of Council relating to the cemetery or the regulations for the protection of the same, and such person will be proceeded against according to the provisions of the 14th section of the Act 7 Victoria No. 12.

16. The council reserve the right to make any alterations from time to time in these charges and regulations.
