It having been found necessary to correct the latitude of Eden Harbor Light, as stated in the Government notice, dated 22nd ultimo, the following description is now published for general

EDEN HARBOR LIGHT, TWOFOLD BAY.

The Lighthouse is a white tower, built of wood, is 38 feet high to the centre of the lantern, and built on the southern extremity of Look-out Point, 102 feet above the level of the sea. The light consequently will be 10 feet above that level, and will be seen in clear weather from a ship's deck at a distance of nine miles, showing a fixed real light.

The Lighthouse is situated in latitude 37° 4′ 30″ south, longitude 149° 55′ 30″ east, from which the following bearings are taken.—

North point of Twofold Bay or Mewstone Point, north 40°

South Point or Red Head, south 60° cast.

Jew's Point, south 50° cast.
