PROCLAMATION.

By His Excellency SIE HENBY BARKLY, Knight Commander of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

Admiral of the same, &c., &c., &c.

WHEREAS by an Act of the Lieutenant Governor and Legislative Council of the colony of Victoria, passed in the sixteenth year of Her present Majesty's reign, intituled, An Act for making and improving Roads in the Colony of Victoria, it is amongst other things enacted, that it shall be lawful for the Lieutenant Governor, from time to time, by notice in the Government Gazette, to proclaim and declare any such portion of the said colony as to him shall seem meet, as and to be a road district for the purposes in the said Act contained, and also to define the boundaries of every road district thereby proclaimed and declared, and to give a specific name or designation to every such road district, and from time to time revoke any such Proclamation and vary and alter the boundary of any such district as may be necessary and advisable: Now therefore I, Sir Henry Barkly, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim and declare the portion of the said colony hereinafter defined as and to be a road district for the purposes in the said Act contained, and do define the boundaries thereof in manner following, that is to say:—

Commencing at the junction of the western boundary of the

Commencing at the junction of the western boundary of the Stanley Road District with the Ovens River, and extending seventeen miles north; and bounded on the east by the Stanley Road District and proposed Indigo Road District; from thence by a line bearing cast nineteen miles to the Ovens River; and bounded on the north by Crown lands and the agricultural areas of Bremen, Norong, and Lilliput; from thence by the Ovens River; bounded on the south-west by the Ovens River to the point first mentioned.

And I do hereby give to such road district the specific name or designation of "The North Ovens Road District."

Given under my Hand and the Seal of the Colony, at Melbourne, this tenth day of June, in the year of our Lord One thousand eight hundred and sixty-three, and in the twenty-sixth year of Her Majesty's reign,

SANDHURST MINING DISTRICT.

Bye-law for the Election of Managers of the Gold Fields Commons within the Mining District of Sandhurst.—[28th May, 1863.]

A Ta meeting of the mining board of the mining district of Sandhurst, begun and holden at Sandhurst, in the said district, on the 28th day of May, One thousand eight hundred and sixty-three, it is ordained by the said board as follows, that

and sixty-three, it is organized by the sand board at the sand whereas by the 69th section of the Land Act, No. CXLV., 1862, the mining board of the mining district within which any gold fields common is situated, is directed to elect annually, in such manner as such mining board might by bye-laws prescribe, three persons to be managers of such gold fields common, and such mining board being also empowered to remove any one or more of such managers, and elect others in their stead, it is hereby ordained:

1. Annual election.—That the annual election of managers of the gold fields commons within the mining district of Sandhurst shall take place at the first regular meeting of the board held in July of each year, or as soon thereafter as practicable.

2. Mode of election.—That such election shall take place by ballot, and each member of the board shall or may vote thereat.

3. Assent of candidate to be given in writing.—That no person shall be nominated or elected to fill the office of manager without his assent in writing, which assent shall be given to the chairman by the member nominating, when required so to do by any member of the board.

4. Chairman and clerk to count votes, and declare result in writing.—That the votes so soon as recorded shall be counted in the presence of the members by the chairman, who shall be assisted by the clerk of the board; and the chairman, upon ascertaining the result of such election, shall declare the names of the successful candidates to the board as being duly elected, and shall thereupon direct the clerk to enter such declaration in the minute book, and acquaint, in writing, the persons elected to fill the oflice of managers of such circumstance.

5. Removal of managers.—Managers when elected shall be entitled to retain office for twelve months, but the mining board may, at any time before the expiration of that period, remove any one or more of the managers from office, if it should be deemed by the board, or a majority of its members, expedient to do so; and on the removal by the board of any such manager, the board will or may elect another in his stead, and the person so elected shall hold such office for the remainder of the term his predecessor would have been entitled to have held the same, unless removed by the mining board.

ADDITIONAL REGULATION UNDER "THE LAND ACT, 1862," RESPECTING LICENSES TO SEARCH FOR ANY METAL OR MINERAL EXCEPT GOLD.

At the Government House, Melbourne, the first day of June, 1863.

WHEREAS certain regulations respecting the granting of licenses to enter upon any Crown Lands not under lease for the purpose of searching for any metal or mineral except gold were made by the Governor in Council on the thirteenth day of October, One thousand eight hundred and sixty-two, in pursuance of The Land Act, 1862: And whereas it is expedient to make an additional regulation for the purpose aforesaid: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order make the additional Regulation hereto subjoined respecting licenses to search for any metal or mineral except gold, that is to say:—

Special Cases.—In cases where it shall be shown that a departure from the areas named in the Regulations dated the 13th of October, 1862, would under special circumstances be desirable, the same may be diminished, extended, or otherwise altered, provided that the total area shall in no case exceed Six hundred and forty acres.
