**NOTICE TO MARINERS.**

**TEMPORARY BUOYS ON THE LIGHTNING ROCKS.**  
MASTERS of vessels navigating between Port Phillip Heads are hereby cautioned to avoid four small temporary spar buoys, colored red, which have been placed round and close to the Lightning Rocks.

As these buoys are very liable to be washed away, and are placed there for a special purpose, mariners must not trust to them in any way to mark the position of these rocks, but, as hitherto, use the shore marks for that purpose on Point Lonsdale and Shortland's Bluff, as published in the *Gazette*, dated 22nd December, 1862.

**SAILING DIRECTIONS FOR ENTERING THE PORT OF INVERCARGILL.**

VESSELS bound for New River should steer for the north end of Point Island, around which, to within a cable's length, there is not less than five fathoms water. A small patch is said to exist about a quarter of a mile off, in a westerly direction, but the pilots have not been able to find less than five fathoms on it, hard sand bottom. Outside the Bar, in six fathoms, is moored a spiral-shaped black buoy, bearing from the north end of the island north half a mile. Steer for this buoy, and as you approach it, the leading beacons, painted white, will come on with each other bearing from you E.  $\frac{1}{2}$  S. Keep the beacons in one, leaving the black buoy on your port hand, which will lead you over the bar in fifteen feet at low water, spring tides. The breadth of the bar is about a good cable's length, and inside of it, in four fathoms, is a spiral-shaped white buoy, marking the south side of the channel.

The course from this buoy, to about two cables' length above the Pilot Station, is E.  $\frac{1}{2}$  N., and from thence, to about four cables' length farther up, E. by N. The channel then gradually bends to the northward until past the Bombay Rock.

The Pilot Station is situated between the leading beacons, and, except in heavy gales, a pilot will board the vessel abreast of the station; but, should the wind and sea be too strong for him to put off, the shipmaster, by attending to the following directions, may be able himself to conduct his vessel to a place of safety:—

The channel is marked by white buoys on the starboard or south side, and by black buoys on the port or north side. Keep midway between the black and white buoys.

About three cables' length below the Bombay Rock lies a small rock called the Guiding Star Rock, with only four feet water over it. A white buoy has been placed on the west side of this rock, in twelve feet water. The Sand Spit, on the opposite side of the channel, has been advancing into it during the last six months, and at present the breadth of the passage between the Spit and the rock is so narrow, that it would not be prudent for a stranger to run through.

It would be safer to anchor abreast of the second black buoy, above the Pilot Station, where a vessel with good ground-tackle could ride in comparative safety.

The leading mark to pass midway between the rock and the Spit is:—Keep the high hummock on the extreme end of Sandy Point a sail's breadth open to the eastward of the iron white beacon on Bombay Rock, bearing N.E.  $\frac{1}{2}$  N. When abreast of the white buoy, keep off a little, so as not to shave the point of the Spit too close; a N. by E. half E. course will then lead you through between the Bombay Rock and the black buoy on the opposite side of the channel.

On the west side of the Bombay Rock is placed an iron beacon, surmounted by a barrel painted white. The top of the beacon is fifteen feet above low-water mark, and the rock projects from the beacon twenty feet W.N.W. into the channel; immediately beyond there is eighteen feet water. The course from abreast of this beacon to the second white buoy, as you proceed upwards, is N.E. by N., and from thence to the third white buoy N.E., but allowance must be made for the set of the tide, which runs through the blind channel and strikes across the ship

channel, between the Bombay Rock and the first white buoy above it.

The flood setting east, the ebb west.

The best anchorage for a stranger to take is abreast of the third white buoy from the Bombay Rock, letting go the anchors nearest to the S.W. side, as it is pretty steep, too. The depth of water near the shore is three, and in mid-channel, five fathoms—good holding ground.

It is high water full and change at the Pilot Station at 12h. 30m., and the rise of tide from six to eleven feet, according to the winds and state of the tides, westerly winds setting the tides up.

A flagstaff has been erected on the Steep Head, on which will be hoisted, on and after the 15th August, 1863, tidal signals nearly the same as shown at Lonsdale Point, Port Phillip, viz.:

**BETWEEN SUNRISE AND SUNSET.**

- During the first quarter flood, a blue flag halfmast high.
- During the second quarter flood, a blue flag at the mast-head.
- During the third quarter flood, No. 7, Marryatt's, halfmast high.
- During the last quarter flood, No. 7, Marryatt's, at the mast-head.

**EBB TIDE.**

- During first quarter, a blue flag halfmast high, with a ball underneath.
- During second quarter, a blue flag at mast-head, with a ball underneath.
- During third quarter, No. 7, Marryatt's, halfmast high, with ball underneath.
- Last quarter, No. 7, Marryatt's, at the mast-head, with a ball underneath.

When the sea is high at the bar, a ball will be hoisted at the north yard-arm, in addition to the tidal signals; but when it is unfit for a vessel to enter the harbor, the tidal signals will not be shown, but two black balls will be hoisted at the north yard-arm. Communication may be had with vessels at sea by means of Marryatt's signals, at the south yard-arm.

Marryatt's signals at the north yard-arm, will be intended for the pilots at the station.

Masters of vessels should not run for the harbor during the ebb tide, unless with a good commanding breeze, smooth water, and with a vessel easily steered.

The bearings and courses given are by compass, and the soundings at low water spring tides.

**ROAD DISTRICTS ALTERED.**

**PROCLAMATION.**

By His Excellency SIR HENRY BARKLY, Knight Commander of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

**WHEREAS** by an Act of the Lieutenant Governor and the Legislative Council of the colony of Victoria, passed in the sixteenth year of Her present Majesty's reign, intituled, *An Act for making and improving Roads in the Colony of Victoria*, it is amongst other things enacted, that it shall be lawful for the Lieutenant Governor, from time to time, by notice in the *Government Gazette*, to proclaim and declare any such portion of the said colony as to him shall seem meet, as and to be a road district for the purposes in the said Act contained, and also to define the boundaries of every road district thereby proclaimed and declared, and to give a specific name or designation to every such road district, and from time to time revoke any such Proclamation and vary and alter the boundary of any such district as may be necessary and advisable; and whereas it is necessary and advisable to vary and alter the boundaries of the Road Districts hereinafter mentioned: Now therefore I, Sir Henry Barkly, the Governor of Victoria, do, with the advice of the Executive Council, revoke so much of any Proclamation as describes the boundaries of the Road Districts hereinafter mentioned; and, with the advice aforesaid, I do hereby vary and alter the boundaries of the said Road Districts in manner following, that is to say:—

**THE BACCHUS MARSH AND MADDINGLEY ROAD DISTRICT** (the boundaries whereof were defined in a Proclamation bearing date the sixth day of October, 1862) is hereby altered, and the boundaries hereafter described shall be the boundaries thereof, viz. — Commencing at the junction of the Myrning Creek and the Werribee River; thence northward by the Myrning Creek to its most northern source; thence by a direct line north to the northern boundary of the county of Bourke; thence easterly by the said boundary to a point in the boundary due south of the west boundary of the township of Woodend; thence by a direct line southerly to the west boundary of the parish of Bullengarook; thence south by the said west boundary of the said parish to its south-west angle; thence east to the north-west angle of H. Matson's pre-emptive right; thence south to the south-west angle of the said right; thence east to its south-east angle; thence by a direct line easterly to a point on the Djerriwarth Creek due west of the northern boundary of the township of Sunbury, being the north-west corner of the Melton Road District; thence south by the western boundary of the said road district to the Werribee River; thence westerly by the Werribee River to the north-east angle of the parish of Parwan; thence south by the eastern boundary of the parish of Parwan to the centre of a one-chain road, which forms the southern boundaries of blocks 13, 12, 11, 10, 14, 15, 16, 18, 19, 21, 22, 24 of section 8, and of blocks 3, 2, 1 of section 4, of the said

parish; thence westerly by the centre of the said road to the western boundary of the said parish of Parwan; thence north by the said western boundary to the north-east angle of block 6, section 13, of the parish of Corrocburghap; thence by the northern boundaries of blocks 6 and 5 of section 13 to the eastern boundary of block 4 of the said section; thence north to the centre of a road which forms the southern boundary of the Penland Hills and Maddingley Farmers' Common; thence by the centre of the said road north-westerly to the western boundary of the parish of Corrocburghap; thence north by the said western boundary to the Werribee River; thence easterly by the said river to the commencing point.—(62.1398.)

**THE GISBORNE ROAD DISTRICT** (the boundaries whereof were defined in a Proclamation bearing date the twenty-second day of October, 1860) is hereby altered, and the boundaries hereafter described shall be the boundaries thereof, viz. — Commencing at the south-west angle of H. Matson's pre-emptive right; thence north to the south boundary of the parish of Bullengarook; thence west to the south-west angle of the said parish; thence north by the western boundary of the said parish and a direct line to a point on the northern boundary of the county of Bourke due south of the west boundary of the township of Woodend; thence north-easterly and north by the county boundary of Bourke to the south-west angle of block 1, section III., of the parish of Newham; thence east by the south boundary of the said block to its south-east angle; thence by a line north-easterly to the south-west angle of block 10, parish of Rockford; thence easterly by the south boundaries of blocks 10 and 9 of the said parish to the north-west angle of block 5 in the said parish; thence southerly by the west boundaries of block 5 and 1 of said parish and a direct line to the south-west boundary of the parish of Monegetta; thence south-easterly by the said parish boundary to a point due north of the south-west angle of Brock's pre-emptive right; thence south to the south-west angle of the said right; thence south-easterly by a direct line to a point in the centre of the Bullando Creek which is due west of the south boundary of section A in the parish of Havelock; thence south to the north-eastern boundary of the Mount Alexander Railway; thence south-easterly by the said boundary of the railway to the north-east angle of the parish of Buttlejork; thence westerly by the northern boundary of the said parish to the eastern boundary of the parish of Gisborne; thence south by the said eastern boundary of the parish of Gisborne and a direct line to the centre of the Mount Alexander road; thence by the centre of the said road to a point due west of the northern boundary of the township of The Gap; thence by a direct line west to the Djerriwarth Creek; thence by a direct line westerly to the south-east angle of H. Matson's pre-emptive right; thence west by the south boundary of the said right to the commencing point.—(63.1183.)

**THE GREENSBOROUGH ROAD DISTRICT** (the boundaries whereof were altered in a Proclamation bearing date the first day of December, 1862) is hereby further altered, and the boundaries hereafter described shall be the boundaries thereof, viz. — Commencing at a point in the centre of the River Plenty, opposite the south boundary of section XXVIII., in the parish of Keelbundora; thence west to the centre of the Upper Plenty road; thence southerly by the centre line of said road to the north boundary of section x. in said parish; thence east to the western boundary of the Eltham Road District; thence northerly by the said boundary to a point in the centre of Arthur's Creek due east of the northern boundary of section XIII. in the parish of Morang; thence by a direct line west to the centre of the River Plenty; thence southerly by the centre line of the said river to the commencing point.—(63.1235.)

**THE UPPER PLENTY OR MORANG ROAD DISTRICT** (the boundaries whereof were defined in a Proclamation bearing date the first day of September, 1862) is hereby altered, and the boundaries hereafter described shall be the boundaries thereof, viz. — Commencing at a point in the centre of the River Plenty where the said river is intersected by the centre of the road running westward from the Yan Yan reservoir to Woodstock; thence proceeding westward along the centre of the said road to the eastern boundary of the Woodstock Road District; thence southward along the eastern boundary line of the Woodstock Road District and the Epping Road District to the junction of the Plenty road and the Epping road; thence eastward along the line separating section 137, parish of Keelbundora, from section 138 of the said parish, to the centre of the Darebin Creek; thence northward by the centre of the said creek to the southern boundary line of section 10, parish of Keelbundora; thence eastward by the said boundary line to the south-east angle of the said section; thence northwards by the eastern boundary line of the said section to the southern boundary line of the Greensborough Road District; thence westward by the said southern boundary line to its western extremity; thence north-easterly by the western boundary line of the said Greensborough Road District to the centre of the River Plenty; and thence northward by the centre of the said river to the north-west angle of section XIII. in the parish of Morang; thence by a line east to Arthur's Creek; thence northerly by Arthur's Creek to the southern boundary of the Whittlesea Road District; thence west by the said southern boundary to the centre of the River Plenty; thence northward by the centre of the River Plenty to the commencing point.—(63.818.)

MELBOURNE TOWN COMMON.

PROCLAMATION.

By His Excellency SIR HENRY BARKLY, Knight Commander of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by *The Land Act, 1862*, it is amongst other things enacted, that when any Crown land remains unsold in or within five miles of any municipal district, or upon or within five miles of any gold field, or in or within five miles of any town not contained in any municipal district, or within any agricultural area of which at least one-fourth part has been selected, the Governor in Council may proclaim such land to be a municipal common, or a gold fields common, or a town common, or a farmers' common respectively, as the case may be; and it is also enacted that the Governor in Council may at any time increase, diminish, alter, or abolish any common proclaimed before or after the passing of the said Act: Now therefore I, Sir Henry Barkly, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the lands hereinafter mentioned to be a Town Common for Melbourne, subject to the condition that stringent measures be taken by the Corporation of Melbourne for the preservation of the trees thereon, that is to say:—

Area, one thousand and seven acres, more or less, being the unappropriated land embraced within the following described boundaries: Commencing at a point where the north bank of the Yarra Yarra River is intersected by the old city boundary; thence north by said boundary to the south fence of the Melbourne and Murray River Railway; by that fence south-easterly to its intersection with the northern boundary of the railway reserve at Batman's Hill; by part of the northern boundary thereof south-westerly to its north-western angle; thence south-easterly by said railway reserve and a prolongation thereof to the Yarra Yarra River, and by that river westerly to the point of commencement. Also the unappropriated land lying north of Grattan street, west of the Nicholson street, south of the city boundary, and east of the Sydney road, including Prince's Park. Also Fawkner Park and the unappropriated land lying south of the Commercial road, Prahran, west of the Punt road, north of a prolongation of the north side of Union street, Prahran, and east of the Brighton road. Also the unappropriated land lying east of Prince's Bridge, north of the Yarra Yarra River, west of the Jolimont road, and south and west of the Melbourne Railway fence, and south of Flinders street. As shown on plan deposited in the Crown Lands Office, Melbourne. —(63.H.6323.)

THE TOLLS WITHIN THE BANNOCKBURN AND SHELFORD ROAD DISTRICTS.

PROCLAMATION.

By His Excellency SIR HENRY BARKLY, Knight Commander of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act passed in the sixteenth year of Her present Majesty's reign, intitled, *An Act for making and improving Roads in the Colony of Victoria*, it is amongst other things enacted, that it shall be lawful for His Excellency the Lieutenant Governor, with the advice of the Executive Council, by Proclamation in the *Government Gazette*, to declare the rates of tolls to be collected by any district road board, as hereinafter mentioned, and such rates and tolls from time to time to vary and alter, and any such Proclamation to revoke; and it is also enacted, that in case any district road board shall deem it advisable that money should be raised by tolls, it shall be lawful for such board, subject to the approval of His Excellency the Lieutenant Governor, to cause from time to time such and so many toll-bars, toll-gates, and toll-houses to be erected and built in, and upon the roads within their respective road districts, at such places as to each board shall seem fit, and in like manner to cause such toll-bars, toll-gates, and toll-houses to be removed, or built, or placed on other parts of the said roads, and to direct tolls to be paid for all animals and vehicles passing or repassing through such toll-bars, toll-gates, or toll-houses, at a rate not exceeding the rates to be declared as aforesaid, and such rates from time to time to reduce or raise to any amount not exceeding the rates to be so declared: And whereas the Bannockburn District Road Board and the Shelford District Road Board deem it advisable that money should be raised by tolls within their respective districts: Now therefore I, Sir Henry Barkly, the Governor of Victoria, with the advice of the Executive Council, do hereby declare the rates of tolls hereinafter specified to be the rates of tolls which may be collected by the said Bannockburn District Road Board and Shelford District Road Board, within their respective districts, that is to say:—

WHEREAS by an Act of the Lieutenant Governor and Legislative Council of the colony of Victoria, passed in the sixteenth year of Her present Majesty's reign, intituled, *An Act for making and improving Roads in the Colony of Victoria*, it is amongst other things enacted, that it shall be lawful for the Lieutenant Governor, from time to time, by notice in the *Government Gazette*, to proclaim and declare any such portion of the said colony, as to him shall seem meet, as and to be a road district for the purposes in the said Act contained, and also to define the boundaries of every road district thereby proclaimed and declared, and to give a specific name or designation to every such road district, and from time to time revoke any such Proclamation and vary and alter the boundary of any such district as may be necessary and advisable: Now therefore I, Sir Henry Barkly, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim and declare the portion of the said colony hereinafter defined as and to be a road district for the purposes in the said Act contained, and do define the boundaries thereof in manner following, that is to say:

BYE-LAW No. 32.—FOR REGULATING THE KILLING AND SALE OF BUTCHERS' MEAT WITHIN THE MUNICIPALITY OF MALDON.

WHEREAS by the Act of Council 18 Victoria No. 15, intituled, *An Act for the establishment of Municipal Institutions in Victoria*, it is amongst other things enacted, that it shall be competent for any municipal district, established under the provisions of the said Act, to make bye-laws for the killing and sale of butchers' meat: Be it therefore enacted by the municipal council of Maldon as follows, that is to say:—

1. That it shall not be lawful for any butcher, unless he possess a slaughtering license, to kill large cattle within the said municipal district of Maldon.

2. That it shall not be lawful for any butcher to kill small animals within the said municipal district, except in slaughter-houses paved to the satisfaction of the said council, or any officer duly appointed by them, either with closely jointed flags, or with bricks set compactly on edge, the outer course of which shall be on an incline towards one corner thereof, where a tub or other proper receptacle shall be provided to catch the blood and other matter; and such slaughter-houses shall be open at all times to the inspection of the inspector of nuisances for the said municipal district.

3. Butchers shall keep their slaughter-houses clean by washing them out daily if used, and shall remove therefrom all offal, refuse, blood, and filth of every description, daily, after Six o'clock in the afternoon and before Seven o'clock in the forenoon, and shall render the same, together with the court-yards and premises near or adjoining thereto, inoffensive smell, or otherwise, and keep all skins in proper order until their removal.

4. In construing this bye-law the words "large cattle" shall be held to mean and include bulls, cows, oxen, heifers, steers, and calves over six months old; and the words "small animals" shall mean and include calves under twelve months old, rams, ewes, sheep, lambs, pigs, and goats; and the words "kill and killing" shall be held to mean and include slaughtering, disembowelling, and dressing.

5. For the purpose of carrying out the provisions of this bye-law, all premises where butchers' meat may be slaughtered or sold shall be duly registered with the town clerk, who shall under his hand, on receiving the authority of the council, grant a license to slaughter under the provisions of this bye-law; and any person who shall slaughter butchers' meat without being duly licensed under the provisions of this bye-law (except the *bona fide* servants of a duly licensed person), or who shall sell any tainted or unwholesome butchers' meat for human food, or whose premises shall not be kept and maintained inoffensive as above required, or who shall neglect or refuse to comply with the provisions of this bye-law, shall, upon conviction before any two or more justices of the peace, forfeit and pay a penalty not exceeding Twenty pounds (£20).

And be it further ordered and enacted, that it shall not be lawful for any licensed butcher or other person to slaughter any butchers' meat on premises situated distinct and apart, except all such premises are severally registered and licensed as though they belonged to the different owners or persons.

And be it also ordered and enacted, that written notice of application for such license and registration shall be given to the town clerk, at least eight days before the same be granted, and shall be exhibited for such period in his office at the municipal chambers, and that the said licenses shall issue and be in force for twelve months from the date of granting the same.

BYE-LAW No. 54.—TO ENABLE THE MUNICIPAL COUNCIL OF WILLIAMSTOWN TO ELECT MANAGERS OF THE WILLIAMSTOWN TOWN COMMON, AND TO FIX THE TIME AND MANNER OF THEIR ELECTION.

WHEREAS by an Act of Council, 18 Victoria No. 15, intituled, *An Act for the establishment of Municipal Institutions in Victoria*, power is given to the council of any municipal district to make bye-laws for the conducting of elections: And whereas by an Act of His Excellency the Governor and Parliament of Victoria, intituled, *An Act to consolidate and amend the Laws relating to the Sale and Occupation of Crown Lands*, 25 Victoria No. 145, section 69, it is declared that the municipal council of any municipal district, within or in the vicinity of which any town or municipal common is situated shall elect annually, in such manner as they may by bye-laws prescribe, three persons to be managers of such town or municipal common, and may at any time remove any one or more of such managers and elect others in their stead: Be it therefore ordered and directed by the municipal council of Williamstown, that from and after the date of this bye-law receiving the assent of His Excellency the Governor, the election of managers of the municipal common shall be held and conducted in the time and in the manner following, viz.:

1. That the election for the appointment of managers of the Williamstown municipal common shall be held annually at the second regular meeting of the council in each municipal year, viz., in April; and that the election of such managers for the unexpired portion of the current municipal year shall be held at the second regular meeting of the council after the publication in the *Government Gazette* of this bye-law.

2. That at such meeting, or at any subsequent meeting of the council appointed for such purpose, any member of the council may propose the names of the same number of persons as there are vacancies to be filled up; and in the event of there being more persons proposed than there are vacancies, the voting shall be on cards provided for the purpose, on which the voter shall write the name or names of the candidate or candidates he supports, and sign his own; the result of such election shall be entered in the minutes of the day, and the voting cards shall be kept in the town clerk's office for twelve months as a record.

3. That when any one or more vacancies occur through death, resignation, or removal by the council of any manager or managers during his or their term of office, the council shall, as speedily as possible, elect in the same manner a person or persons to fill such vacancy or vacancies as is hereinbefore mentioned.

4. Notwithstanding anything hereinbefore contained, it shall be lawful for the said council, instead of proceeding to the nomination and election of managers as aforesaid, to adjourn

any such meeting from time to time as they may think proper, and the election taking place at any such adjourned meeting shall be equally valid.

3. Special meetings shall be summoned at any time by the secretary, upon receiving a written requisition signed by two members stating the matter to be discussed at such meeting.
4. No special meeting shall be held unless the secretary shall have given notice thereof, by post, five clear days before such meeting.
5. The minutes of any preceding meeting not previously confirmed shall be read as the first business at all meetings of the board, in order to their confirmation, and no discussion shall be permitted thereon except as to their accuracy.
6. At all meetings, the reading of correspondence unconnected with the business of the meeting, the presentation of petitions, and the bringing up of reports, shall have the precedence of all motions.
7. Every communication addressed to the board shall be in proper form, and presented by one of its members, who shall be responsible for its being respectfully worded.
8. On the presentation of a petition or the bringing up of a report, no debate shall take place thereon until notice has been given in the usual manner; and the only question that shall be entertained shall be that the petition or report be received, and, if necessary, that it be referred to a committee.
9. The orders of the day shall include all matters arising out of the proceedings of former meetings of the board, and any business which the chairman may think fit to bring under consideration; any member of the board may, however, bring forward such business as he may consider advisable, in the form of notice of motion. No such motion, however, shall be decided on at any meeting of the board, unless notice thereof shall have been given to the secretary in writing, by the member bringing it forward, at the meeting previous to that in which the same shall be taken into consideration.
10. No motion entered on the notice paper shall be proceeded with unless the member who has given such notice, or some one authorised by him, be present when the business is called in order. Notices of motion not so proceeded with shall be struck out of the papers.
11. No bye-law shall be finally passed or adopted at the meeting at which it shall have been first proposed, nor until the next meeting.
12. The mover of any motion which may be referred to any committee shall be (*pro hoc vice*) a member of such committee.
13. Any bye-law may be suspended (*pro tem.*) in case of emergency, with the consent of the majority of the board.

##### ORDER OF DEBATE.

14. The presiding chairman's ruling shall be final on all matters of order or practice, and he shall state the same without comment or argument.
15. Every motion or amendment shall be entered in the minutes, with the name of the mover and seconder, and on a division thereon the votes shall be recorded.
16. Any member may of right require the production of any of the documents of the board relating to the question or matter in discussion.
17. One amendment only shall be discussed at one time; but, if lost, another may be moved before the original is put to the vote.
18. All questions before the board shall be decided by open voting, unless a motion for any particular question is made and carried that it shall be by ballot.
19. No discussion will be allowed on any motion for adjournment of the board; but if, on the question being put, the motion be negatived, the subject then under consideration, or the next on the notice paper, shall be discussed, or any other that may be allowed precedence, before any subsequent motion for adjournment shall be entertained; but if the motion for adjournment shall be carried, the business then undisposed of shall have precedence at the next meeting of the board.
20. No motion, the effect of which, if carried, would be to rescind any resolution of the board which shall have been negatived by the board, shall be again entertained during the same year.
21. Every member, including the chairman, shall stand up while addressing the board.

**CONTRACTS.**

22. All contracts shall be made by tender, advertised not less than twice. Each tender shall be addressed to the chairman, and such tender or tenders only be opened at the time of their consideration by the board, the respective amounts, together with the names of the parties tendering, to be entered in every case on the minutes of the board; and when tenders are accepted, a contract bond shall be entered into, signed by the contractor and by two members of the board, one of whom shall be the chairman of the board, or, in his absence, the chairman of the meeting at which such tender is accepted, and the expense of preparing such bond shall in all cases be borne by the person or persons giving the same.

23. No officer or member of the board shall have any pecuniary interest, either directly or indirectly, in any contract under the board.

**PAYMENTS OF MONEY.**

24. All payments shall be made by cheque, signed by the chairman and one member of the board, and countersigned by the secretary, and no such cheques shall be given unless they be passed at a regular meeting of the board.

**LOCAL ASSESSMENT.**

25. The board may meet on such days as may be appointed after the completion of each annual assessment, to hear appeals against the same, after notice being given of the day of hearing such appeals; and the board may, in their discretion, alter the assessment so appealed against, or may confirm the same.

26. Notices of appeal must be in writing, and lodged with the secretary to the board at least seven (7) clear days before the day appointed for hearing appeals.

27. In all cases it shall be considered sufficient for the collector to call once for payment of any amount due on the assessment roll, and in the event of such amount not being paid to him, a notice shall be left stating that unless the amount be paid to the collector of the board, before the expiration of one month from the date thereof, legal proceedings will be taken for its recovery.

28. The collector shall pay into the treasurer's hands all moneys collected immediately after such collection.

29. The treasurer shall place all money received from the collector to the credit of the board in the London Chartered Bank

of Australia, Maryborough, within one week from the receipt thereof.

30. The collector and treasurer shall present their accounts at each meeting of the board.

## CONDITIONS.

1. The hay to be eaten, good, sound, and sweet; the straw to be wheaten, and both to be in all respects of the best quality; oats (colonial grown) and bran to be sound and sweet and of the best description.

2. The supplies to be delivered on the requisition of the officer in charge of the district or station, the quantities stated in schedule being, however, only approximative, and it must be understood that the Government will draw either more or less than stated. The excess over the estimate will not, however, exceed during the whole year 50 per cent. of the estimated quarterly consumption.

3. The contracts entered into under this notice are not to be considered as being infringed or vitiated by any contracts made by the military commissariat.

4. The forage, when delivered, must be accompanied by an invoice of quantity, showing the gross weight, the tare, and the net weight (this should be on the back of the requisition or order), which, when signed by the officer in charge of the station for the net quantity received, will be returned to the contractor, and by him rendered in support of his account.

5. Each contractor will be required to prepare his own account in the prescribed form, and on presentation thereof to the officer in charge of the station or district, it will be forwarded for payment at the Treasury, Melbourne, or the Pay Office of the District, as may be indicated by the contractor on the account.

6. Should forage duly ordered under these contracts not be delivered within forty-eight hours from a reasonable time to be fixed on the order, it will be competent for the department (should circumstances require it) to purchase the same at the risk of the contractor, from whose account any expense over and above the contract price is to be deducted.

7. In the event of a difference of opinion between the contractor and the officer receiving the forage as to quality of the same, it is to be decided by a board of survey composed of persons named by the head of a department, and the decision of the board is to be considered final.

8. If the board shall decide that the forage is not of proper quality, it must be immediately replaced by the contractor, failing which it will be procured elsewhere, and the extra cost, if any, will be charged as in clause 6.

9. When a board of survey cannot be conveniently assembled, or when from some other cause injury would accrue either to the public service or the contractor by waiting for a board of survey, the officer in charge will have the power to reject such supplies as are obviously of inferior quality, it being understood that he will be responsible to the Government for so doing; and the contractor must take back the rejected forage, and supply good in its stead, failing which it will be obtained by the officer requiring it, and the expense will be charged as in clause 6.

10. A repetition of irregularity in the quantity or quality of the forage, or of delay in delivering or replacing it when required, will subject the contractor, upon report from the Government Storekeeper, to such mulct, not exceeding one-fourth of the monthly account, as the Government may direct. It will also be in the power of the Government, upon such repetition, to terminate the contract forthwith.
