WHEREAS by *The Electoral Act, 1863*, it is amongst other things enacted, that the Governor in Council shall, within thirty days after the commencement thereof, and afterwards as he shall see fit from time to time, appoint within and for each division of every province and district respectively one place and not more for taking the poll in such division at contested elections for the province or district, and every such appointment may revoke; provided that if the returning officer of the province or district and any police magistrate or superintendent of police acting in the locality shall by writing under their hands certify to the Governor that it is necessary so to do it shall be lawful for the Governor in Council from time to time to appoint as aforesaid in and for such division one or more polling place or places, and the appointment of such place or places or any of them from time to time to revoke; provided also that no appointment of any polling place in or for any division of a province or district shall be revoked between the issue of any writ for election for the same and the return of such writ: And whereas the returning officer for the Grenville electoral district and the police magistrates acting in the respective localities hereinafter mentioned have, by writing under their hands, certified to the Governor that it is necessary to appoint additional polling places for certain divisions of such district: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order appoint Napoleon Lead to be an additional polling place in and for the Buninyong division, and Happy Valley to be an additional polling place in and for the Linton division, for taking the poll in and for such respective divisions at contested elections for the electoral district of Grenville.

And the Honorable James McCulloch, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.

WHEREAS by *The Electoral Act, 1863*, it is amongst other things enacted, that the Governor in Council shall, within thirty days after the commencement thereof, and afterwards as he shall see fit from time to time, appoint within and for each division of every province and district respectively one place and not more for taking the poll in such division at contested elections for the province or district, and every such

appointment may revoke; provided that if the returning officer of the province or district and any police magistrate or superintendent of police acting in the locality shall by writing under their hands certify to the Governor that it is necessary so to do it shall be lawful for the Governor in Council from time to time to appoint as aforesaid in and for such division one or more polling place or places, and the appointment of such place or places or any of them from time to time to revoke; provided also that no appointment of any polling place in or for any division of a province or district shall be revoked between the issue of any writ for election for the same and the return of such writ: And whereas the returning officers for the respective electoral districts and the police magistrates acting in the respective localities hereinafter mentioned have, by writing under their hands, certified to the Governor that it is necessary to appoint additional polling places for certain divisions of such districts, and to revoke the appointment of certain polling places for the district of Mandurang: Now therefore His Excellency the Governor, by and with the advice and consent of the Executive Council, doth by this present Order appoint the polling places mentioned in the First Schedule hereunto annexed to be polling places for the divisions opposite to the names of which they are respectively placed; and with the advice aforesaid doth hereby revoke the appointment of the polling places mentioned in the Second Schedule hereunto annexed, that is to say:—

## REGULATIONS FOR INDUSTRIAL SCHOOLS.

THE Governor in Council in exercise of the power conferred by *The Neglected and Criminal Children's Act, 1864*, has made the subjoined Regulations for the management and supervision of Industrial Schools established for the purposes of the said Act, and for the education of the children detained therein, viz.:

## SUPERINTENDENT.

1. The superintendent shall be under the directions of the Chief Secretary, and shall reside in the institution.
2. He shall have the immediate superintendence and control of the entire establishment, and shall be responsible for its proper conduct and management.
3. Subject to the approval of the Chief Secretary, he shall have the power of summarily dismissing any officer or servant guilty of insubordination, or negligence, or carelessness in the discharge of his or her duty, or of any conduct calculated to bring discredit upon the institution.
4. He shall not have power to dismiss the matron, but may suspend her from duty, and appoint some person in her place, pending instructions from the Chief Secretary.
5. He shall have the custody of all documents, books, and papers, and shall conduct the correspondence.
6. He shall have charge of all stores and other property of whatever description belonging to the institution.
7. He shall keep proper books of account of all moneys, stores, and other property received and disbursed.
8. He shall inspect the food of the inmates, and see that it is of good quality and properly prepared.
9. He shall, by close personal supervision, satisfy himself that the officers and servants of the institution discharge their respective duties zealously and efficiently, and that the provisions of the Act and the regulations of the Governor in Council are faithfully carried out.

## MATRON.

10. The matron shall reside in the institution, and shall not absent herself therefrom without leave first obtained from the superintendent.
11. She shall attend to any directions given to her by the superintendent.
12. She shall have the immediate superintendence of the female officers and servants of the establishment, and shall enforce among them personal cleanliness, neatness, and obedience; and in case of any misconduct, disobedience, or neglect of duty, she shall at once report the same to the superintendent.
13. She shall see that the girls are properly washed and clothed, and shall, by daily inspection, see that the beds are clean and properly made.
14. She shall superintend the cooking of the food, and see that the table utensils are kept clean and in proper order.

## TEACHERS AND EDUCATION.

15. Teachers shall obey all reasonable orders and directions of the superintendent and matron respectively.
16. The system of education shall be, as far as possible, in accordance with that pursued under the Common Schools Act; and the teachers shall be guided by the regulations of the Board of Education, as far as they are applicable.

## INFERIOR OFFICERS AND SERVANTS.

17. Inferior officers and servants shall render prompt obedience to all orders received from the superintendent and matron respectively, and shall be careful to maintain personal cleanliness, neatness, and propriety of behavior.

18. Servants in charge of wards shall maintain order, cleanliness, and decency therein, and shall immediately check improper language or conversation.

## WARDS.

19. The wards shall be appropriated so as to group separately the Roman Catholic children and the Protestant children, and the latter, as far as possible, according to their denominations.

## PRAYERS.

20. Prayers to be read in each ward morning and evening. The form of prayers to be used to be approved of by the heads of the denomination to which the children in the respective wards belong.

## ATTENDANCE AT PUBLIC WORSHIP.

21. On Sundays, the children shall attend the places of worship belonging to their respective denominations that are nearest to the school, and shall be attended by officers of the institution.

## RELIGIOUS INSTRUCTION.

22. On each week day between the hours of Twelve noon and One p.m., and Four p.m. and Five p.m., the children shall be allowed to receive religious instruction from duly authorised persons belonging to their respective denominations.

## MEDICAL OFFICER.

23. The medical officer shall visit the sick at least once daily, and in cases requiring more frequent attendance as much oftener as may be deemed necessary.

24. He shall provide all necessary medicines and surgical appliances for such as may require them.

25. He shall keep a book in which the names and ages of the sick, the symptoms and treatment of the diseases, and the diet and medical comforts requisite for each case, shall be carefully recorded. The change of symptoms, the progress of the disease, and the medicines prescribed, shall be daily noted.

26. He shall cause all cases of contagious and infectious disease to be immediately removed to hospital, and isolated as far as possible from the rest of the inmates.

27. In ordinary medical comforts he shall exercise the strictest economy. No articles shall be ordered except those named in the accompanying list, and only such of those as are absolutely necessary:—

Arrowroot,	Port wine,
Beef or mutton,	Rice,
Bread,	Sago,
Lime juice,	Sherry,
Milk,	Sugar,
Oatmeal,	Tea,
Porter, bottled,	Brandy.

28. At the end of each quarter he shall transmit to the chief medical officer a return in the form provided, of all cases of sick under treatment during the period.

29. He shall comply with such instructions, and forward such returns as the chief medical officer may from time to time direct.

## DIETARY SCALE.

30. A dietary scale shall be hung up in each mess-room of the institution.

## VISITORS.

31. No person, except ministers of religion and Sunday school teachers duly appointed, shall be allowed to visit the institution on Sundays.

32. Ministers of religion visiting the institution on Sundays, shall visit between the hours of Eight a.m. and One o'clock p.m., and Three to Five p.m.

33. The friends of children shall have admission to the institution on the first Monday in each month, between the hours of Nine a.m. and One p.m., and Two to Five p.m.; but shall only be allowed to see and converse with the children in the presence of an officer of the institution.

34. All persons authorised by the Act (save as aforesaid) are requested to visit the institution between the hours of Nine a.m. and Five p.m.

35. Visitors shall not give or offer to any officer or servant of the institution any gratuity, fee, or reward.

## VISITORS' BOOK.

36. There shall be kept in some convenient place a book, to be called the "Visitors' Book," in which visitors shall be required to enter their names; and in which they may make such remarks or suggestions relative to the institution as they may desire.

**NOTICE TO APPLICANTS FOR LEASES OF AURIFEROUS LANDS.**

THE attention of applicants for Mining Leases is directed to the Ninth and Eleventh clauses, Leases, of the Regulations under Act No. 148, relating to Leases of Auriferous Lands, and for other purposes, where it is notified that—

9. The parcel of land demised shall be, in ordinary leases, in the form of a parallelogram (except where the same shall be impracticable by reason of the adjoining land being occupied, or from insuperable impediments), and the maximum length thereof shall not, except as hereinafter provided for, exceed more than twice the maximum breadth, and shall be accurately described by metres and bounds.

If from any cause injury would accrue to the public service by waiting for a board of survey, the Chief Medical Officer, the Government Storekeeper, or such other officer as may be appointed (as the case may be), will have the power to reject such article or articles as are obviously of inferior quality, it being understood that he will be responsible to the Government for so doing, and that the contractor must take back the rejected article and supply good in its stead, failing which it will be procured elsewhere, and the extra expense (if any) will be charged as in clause 6.

8. A repetition of irregularity in the quantity or quality of the supplies, or of delay in delivery or replacing them when required, will subject the contractor to such mulct, not exceeding one-fourth the amount of the monthly account, as the Government may direct. It will also be in the power of the Government, upon such repetition, to terminate the contract forthwith.

9. It will be competent for the Government Storekeeper, or such other officer as may be appointed on behalf of the Government, or the contractor on his own behalf, to terminate the contract by giving a notice in writing of three full calendar months; it being understood that such notice can be given only from the first day of a month, and within the period for which the contract is made.
