POLLING PLACES FOR THE WESTERN PROVINCE.

At the Government House, Melbourne, the second day of September, 1864.

PRESENT:

His Excellency the Governor in Council.

WHEREAS by The Electoral Act, 1863, it is amongst other things enacted, that the Governor in Council shall, within thirty days after the commencement thereof, and afterwards as he shall see fit from time to time, appoint within and for each division of every province and district respectively one place and not more for taking the poll in such division at contested elections for the province or district, and every such appointment may revoke; provided that if the returning officer of the province or district and any police magistrate or superintendent of police acting in the locality shall by writing under their hands certify to the Governor that it is necessary so to do it shall be lawful for the Governor in Council from time to time to appoint as aforesaid in and for such division one or more polling place or places, and the appointment of such place or places or any of them from time to time to revoke; provided also that no appointment of any polling place in or for any division of a province or district shall be revoked between the issue of any writ for election for the same and the return of Province and the police magistrates acting in the respective localities hereinafter mentioned have, by writing under their hands, certified to the Governor that it is necessary to appoint additional polling places for certain divisions of such province, and it is expedient to revoke the appointment of another polling place for the same province: Now therefore His Excellency the Governor, by and with the advice of the Executive Council doth by this present Order appoint the polling places mentioned in the Schedule hereunto annexed to be polling places for the divisions of the Western Province opposite to the names of which they are respectively placed; and with the advice aforesaid doth hereby revoke the appointment of Tower Hill as a polling place for the said province, that is to say:—

THE SCHEDULE. Divisions. Polling Places appointed. Mount Rouse... Tower Hill ... Dunkeld. Koroit (in lieu of Tower Hill).

And the Honorable James McCulloch, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.

POLLING PLACES FOR CERTAIN ELECTORAL DISTRICTS.

WHEREAS by The Electoral Act, 1863, it is amongst other things enacted, that the Governor in Council shall, within thirty days after the commencement thereof, and afterwards us he shall see fit from time to time, appoint within and

for each division of every province and district respectively one place and not more for taking the poll in such division at contested elections for the province or district, and every such appointment may revoke; provided that if the returning officer of the province or district and any police magistrate or superintendent of police acting in the locality shall by writing under their hands certify to the Governor that it is necessary so to do it shall be lawful for the Governor in Council from time to time to appoint as aforesaid in and for such division one or more polling place or places, and the appointment of such place or places or any of them from time to time to revoke; provided also that no appointment of any polling place in or for any division of a province or district shall be revoked between the issue of any writ for election for the same and the return of such writ: And whereas the returning officers for the respective electoral districts and the police magistrates acting in the respective localities hereinafter mentioned have, by writing under their hands, certified to the Governor that it is necessary to appoint additional polling places for certain divisions of such districts, and it is expedient to revoke the appointment of certain other polling places: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order appoint the polling places mentioned in the First Schedule hereunto annexed to be polling places for the divisions opposite to the names of which they are respectively placed; and with the advice aforesaid doth hereby revoke the appointment of the polling places mentioned in the Pirst Schedule hereunto annexed to be polling places for the divisions opposite to the names of which they are respectively placed; and with the advice aforesaid doth hereby revoke the appointment of the polling places mentioned in the Schedule hereunto annexed, that is to say:—
