WHEREAS by *The Local Government Act, 1863*, it is amongst other things enacted, that in and for each original district within thirty days after the commencement of this Act, and in and for each single proclaimed district within fifteen days after the constitution thereof, the Governor in Council shall, and from time to time afterwards, if it shall seem fit may on the application of the board of any such district, appoint a sufficient number of polling places for every such district at which the poll shall be taken at all elections held for the same, and may from time to time on the like application alter and vary the same: And whereas by an Order in Council made on the thirtieth day of September, 1863, certain polling places were appointed for elections in the Swan Hill Road District amongst others, and it is expedient to substitute other places in lieu of the polling places thereby appointed: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order appoint the places mentioned in the second column of the schedule hereunto annexed to be substituted polling places for the Swan Hill Road District, viz.:-

WORKS ON MAIN ROADS ORDERED UNDER "THE LOCAL GOVERNMENT ACT, 1863."

THE Governor in Council, in exercise of the power conferred by *The Local Government Act, 1863*, has, by Orders severally made on the 30th day of January, 1865, directed that the undermentioned Council of a Shire and District Boards of Road Districts shall, within the times by the said respective Orders appointed, execute the works on Main Roads hereinafter named and described, in accordance with sufficient plans deposited by the said Council and District Boards respectively, as provided by the 220th section of the said Act, that is to say:-

The Council of the Shire of Grenville shall, within twelve months from the 30th of January aforesaid, drain, form, and metal about two miles seventeen chains and ten links of the Main Ballarat to Smythesdale road.

The District Board of the Newstead Road District shall, within twelve months from the 30th of January aforesaid, drain, form, and metal about thirty-four chains and fifty-links of the Main Newstead to Carisbrook road.

The District Board of the Oakleigh and Mulgrave Road District shall, within twelve months from the 30th of January aforesaid, drain, form, and metal about one mile and twenty-two and a half chains of the Main Dandenong road.
