ADDITIONAL POLLING PLACES FOR THE NORTH-WESTERN PROVINCE.

At the Executive Council Chamber, Melbourne, the third day of July, 1865.

PRESENT:

His Excellency the Governor

Mr. McCulloch	Mr. Hervey

WHEREAS by *The Electoral Act 1863* it is amongst other things enacted that the Governor in Council shall, within thirty days after the commencement thereof, and afterwards as he shall see fit from time to time, appoint within and for each division of every province and district respectively one place and not more for taking the poll in such division at contested elections for the province or district, and every such appointment may revoke; provided that if the returning officer of the province or district and any police magistrate or superintendent of police acting in the locality shall by writing under their hands certify to the Governor that it is necessary so to do it shall be lawful for the Governor in Council from time to time to appoint as aforesaid in and for such division one or more polling place or places, and the appointment of such place or places or any of them from time to time to revoke; provided also that no appointment of any polling place in or for any division of a province or district shall be revoked between the issue of any writ for election for the same and the return of such writ: And whereas the returning officer for the North-Western Province and the police magistrates acting in the localities hereinafter mentioned have, by writing under their hands, certified to the Governor that it is necessary to appoint additional polling places for certain divisions of the said province: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order appoint the places mentioned in the second column of the Schedule hereunto annexed, to be polling places for the divisions named opposite to the same respectively for taking the poll in and for such respective divisions at contested elections for the North-Western Province, and doth hereby revoke the appointment of Talbot as a polling-place for the Back Creek division of the said province, that is to say:—

THE SHIRE OF METCALFE.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Local Government Act 1863* it is amongst other things enacted that if at any time in any district, whether single or united, which shall contain an area of not less than one hundred square miles, the total amount actually paid in respect of the general rate then last made shall have amounted to One thousand pounds, it shall be lawful for the Governor in Council to proclaim, if it shall seem fit, such district, by such name as in and by such Order in Council may be assigned thereto, to be a shire within the meaning of the said Act, and such district shall thereupon be and be called such shire accordingly; and no district, after the proclamation thereof as such shire, save as therein provided with regard to the adjustment of boundaries to those of electoral districts, shall be united with any other shire or district, or with any borough or municipal district: And whereas by a Proclamation under the hand of the Governor and the seal of the colony, bearing date the sixth day of August, 1860, a Road District was proclaimed under the designation of "The Metcalfe Road District," and whereas by another Proclamation bearing date the thirtieth day of January, 1865, the said Road District was altered as therein mentioned: And whereas the area of the said district and the amount of the last general rate therein are not less than the area and amount in the said Act mentioned, and it seemed fit to make an Order in Council this day to proclaim the said district to be a shire accordingly: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the district heretofore proclaimed and called the Metcalfe Road District to be a shire within the meaning of the said Act, by the name in and by such Order in Council assigned thereto, that is to say:—

THE SHIRE OF METCALFE.

Given under my Hand and the Seal of the Colony, at Melbourne, this tenth day of July, in the year of our Lord One thousand eight hundred and sixty-five, and in the twenty-ninth year of Her Majesty's reign.

SHIRE OF AVOCA.

NOTICE.

THE Council of the Shire of Avoca, at a meeting holden on Thursday, July 13, 1865, confirmed the two bye-laws following, viz.: Bye-law No. 1, to regulate by standing orders the proceedings and affairs of the council; and Bye-law No. 2, to provide for the examining, comparing, and stamping weights and measures, and the fees to be paid thereon, within the Shire of Avoca.

BYE-LAW No. 1.—TO REGULATE BY STANDING ORDERS THE PROCEEDINGS AND AFFAIRS OF THE COUNCIL OF THE SHIRE OF AVOCA.

1. The business of the council shall be conducted on all ordinary occasions with open doors, and shall be open to the public; but any two councillors present may require the exclusion of strangers, until it shall have been decided by the council whether the question proposed to be brought forward shall be discussed publicly or otherwise.
2. The ordinary meetings of the council shall be held on the first Thursday in each month, commencing at Eleven o'clock a.m., the business to commence as soon as the legal quorum is present; but should such quorum not be present at the expiration of one hour after the said time appointed for meeting, the same shall be entered, with a note of the councillors present, in the minute-book; and such meeting shall accordingly be adjourned.
3. The first business at all meetings of the council shall be the reading and confirmation of the minutes of the preceding meeting, and no discussion shall take place thereon, except as to their accuracy as a record of the proceedings; after confirmation, such minutes shall be signed as confirmed by the president of the council, or in his absence by the acting president, and, when practicable, by the president of the meeting at which the proceedings took place.
4. Special meetings of the council shall, on the requisition of three or more councillors, be convened by the secretary, the object of such meeting being set forth in the requisition.
5. At all ordinary meetings of the council, after confirmation of the minutes, the following shall be the order of business:—
 - I. Reading, considering, and ordering upon correspondence unconnected with the orders of the day.
 - II. Receiving and reading petitions and memorials.
 - III. Reading and ordering on reports of committees and officers.
 - IV. Orders of the day.
 - V. Motions of which previous notice has been duly given.
 - VI. Examination and passing of accounts for payment.
 - VII. Reading notices of motions for future meetings.
6. Any memorial or petition addressed to the council shall be presented by a councillor, who shall be responsible for its being respectfully worded, and no debate shall take place thereon except as to its being received, until notice of motion shall have been given with reference to the subject of such petition in the manner required by section 10; or such memorial or petition may, by resolution, be referred to a committee to report upon.
7. No report of a committee shall be considered or adopted on its presentation, nor until due notice shall be given. All such reports shall be read and received *pro forma*, and, if ordered by the council, printed for distribution among the councillors; to be considered at any subsequent meeting. If in the report of a committee there are distinct recommendations contained in such report, such report shall not be adopted until the sense of the council be taken separately on each.
8. All reports sent in to the council by any councillor or committees thereof, or by any officer of the council, shall be written on sheets of large foolscap paper, on one side only, a broad margin being left, so that the sheets can be properly bound together.
9. The orders of the day shall include all matters arising out of the proceedings of former meetings of the council, and any unimportant business, not requiring a formal notice of motion, which the president, or any councillor, or the secretary, may bring forward, and in the ordering of which a verbal instruction to the secretary or other officer may be deemed sufficient.
10. Any councillor may introduce any business in the form of a notice of motion; and every such notice shall be in writing, signed by the mover, who shall endorse thereon the day upon which he intends to submit it for consideration; and every such notice shall be read aloud by the mover at the meeting previous to that at which such notice is to be considered by the council, and shall then be given to the secretary, to be entered in the minute-book, and all notices of motion shall be considered in the order in which they are given. No important business introduced by any councillor, or any motion involving an expenditure exceeding £20, shall be considered or ordered upon at any meeting of the council, unless notice of motion in accordance with the provisions of this section shall have been given at a previous meeting.
11. No motion shall be proceeded with unless the councillor who has given such notice, or one of the council authorised by him in writing, be present to proceed with the same when called upon; and all notices of motions not so proceeded with shall be struck out, unless the consideration of the same shall be postponed by consent of the council.
12. Every motion or amendment shall be in writing, and shall be signed by the mover and seconder; and, on the division thereon, if any, the votes shall be recorded, and the names of the councillors voting *pro* and *con* entered in the minute-book. The original manuscript of any motion or amendment that is submitted to the council shall be preserved until the minutes of the meeting at which the same has been disposed of are confirmed in the usual manner.

13. *Points of order.*—1st. Every councillor, including the president, shall stand while addressing the council. 2nd. The decisions of the president shall be final on all questions of order or practice; and he shall state the same without comment or argument. 3rd. No councillor shall digress from the subject under discussion, nor impute motives, nor make personal reflections. 4th. Any councillor who shall use an expression capable of being applied offensively to any other councillor shall, if required by the president, withdraw such expression, and make a satisfactory apology to the council. 5th. The president shall call to order anyone out of order (whether he be a councillor or ratepayer); and if the person deemed out of order refuse to sit down and be silent, the president shall order him by name to leave the room; and if he still persist in his interruptions, the president shall order his removal, or give him in charge and prosecute him as the law directs.

14. Any councillor, when proposing a motion or amendment, shall address the president, and shall not be interrupted except by a call to order, when he shall be silent, until the councillor calling to order shall be heard, and the question of order decided, when the councillor in possession of the chair shall proceed with the subject.

15. If two or more councillors shall rise to speak at the same time, the president shall decide which of them is entitled to priority.

16. Any councillor moving or seconding any motion or amendment, shall be held to have spoken on that motion or amendment.

17. No councillor shall speak twice on the same question, except by way of explanation, or in reply to any original motion of which he may have been the mover, or as the mover of the amendment last proposed; and the president shall, without waiting for the interposition of the council, call to order any councillor proceeding to speak a second time on the same motion or amendment. After the reply, the amendment, or the original motion, as the case may be, shall be immediately put to the vote.

18. One amendment only shall be discussed at one time, but all amendments shall be discussed and put before the original motion; and no councillor shall move more than one amendment on the same question.

19. The president shall, on taking the vote on any motion or amendment, put the question first in the affirmative and then in the negative, and he may do so as often as may be necessary to enable him to decide which is in the majority. The council shall in all cases vote by show of hands; and all questions before the council shall be decided by open voting.

20. No discussion shall be allowed on any motion for adjournment of the council; but if on the question being put the motion for adjournment be negatived, the subject then under consideration, if any, or if none, then the next on the notice paper, shall be discussed, before any subsequent motion for adjournment be entertained.

21. Upon the adoption of any amendment by the council such amendment shall be held to have quashed the original motion.

22. Any councillor may of right require the production of any document of the council relating to the question or matter under discussion; and any councillor may require the secretary to take down any particular words used by a councillor, immediately upon the same being uttered.

23. Any councillor may record his protest against any resolution of the council, on giving verbal notice of his intention so to do, on the adoption of a resolution; and on such councillor entering his protest, and his reasons for the same, in a book to be kept for that purpose in the office of the council, and on his signing the same before the next meeting of the council; provided always that such protest may be expunged if decided by a majority of the council not to be in accordance with the truth, or not to be in terms respectful to the council.

24. It shall be competent for any councillor, without previous notice, to move a call of the whole council for the consideration of any subject at the next or any subsequent meeting; and upon such motion being carried seven days' notice thereof shall be given by the secretary to each councillor, by post or otherwise, of the day for which the order of the day or notice of motion for which such call is made is set down for consideration; and any councillor not in attendance when such order of the day or notice of motion comes under consideration, or not in attendance at the voting upon such question or any amendment thereof, shall be liable to a penalty of One pound, unless reasonable cause for such absence be shown to the satisfaction of the council. The fines to be applied by the council to charitable purposes.

25. No resolution previously passed by the council shall be revoked or altered, except in strict accordance with clause CXXXVI. of the Local Government Act.

26. All contracts over £20 shall be made by tender, unless the council shall otherwise direct. All tenders shall be written on the council's printed forms, and shall be addressed to the president, and only opened at the time of their consideration by the council; and a preliminary cash deposit of ten per cent. on the bulked sum shall be enclosed in and accompany each tender, which deposit shall, in the case of unsuccessful tenders, be returned after the council meeting. All tenders not in accordance with these conditions shall be rejected as informal; the respective amounts, together with the names of the parties tendering, to be entered in every case on the minutes of the council.

27. Any contractor whose tender shall be accepted by the council, and who fails or refuses to sign the contract within six days from the date of the notification of the acceptance of such contract, shall forfeit the amount of his preliminary deposit, and be disqualified for twelve months from tendering directly or indirectly under the council.

28. The ten per cent. preliminary deposit of any contractor whose tender shall have been accepted by the council, shall be retained by the council as security for the due fulfilment of his contract; such amount to be refunded to the contractor, on

production of the engineer's certificate of satisfactory completion of the works under the contract; but in the event of the non-performance of such works by the contractor through any cause whatsoever, the council shall be entitled absolutely to forfeit such deposit as liquidated damages for breach of contract, and to retain the same for the use and benefit of the councillors and ratepayers of the shire.

29. Advances may be made to contractors at a rate not exceeding ninety per cent. on the engineer's estimate of the value of work then done.

30. When any tender shall have been accepted by the council, a contract bond shall be entered into, signed by the contractor, and also by the president and one other councillor, or, in the absence of the president, by the acting president who shall act as such at the meeting at which such tender shall have been accepted; and the contractor shall also be required to sign the plan and specification of the work for which his tender has been accepted.

31. In the event of any contractor not completing his contract within the term stipulated in the conditions thereof, the engineer shall immediately report thereon to the council.

32. All revenue accruing from rates, licenses, Government grants in aid, or otherwise, shall be, as a general rule, allocated to each riding wherein they are raised, or for whose benefit such grant is made, except in the execution of necessary works for the joint benefit of each riding.

33. All payments shall be made by cheque, and signed by the president and one other councillor, and countersigned by the treasurer; and no cheque shall be given unless the account for which it is payable shall have been passed at a meeting of the council or by a committee duly empowered so to do.

34. The Shire Office shall be open every day, except the days excepted by the Local Government Act, and the days proclaimed as holidays under the Civil Service Act, between the hours of Ten and Three, and on Saturdays from Ten to Twelve o'clock, during which hours the secretary shall attend to transact the ordinary business of the council. The surveyor shall attend during the hours of business at every meeting of the council, and at such committee meetings as he may be required.

35. The valuer or valuers appointed by the council shall visit and examine every rateable property within the shire, and after having valued such property, shall deliver, or cause to be delivered, to the owner or occupier thereof (or if such owner or occupier cannot be found, the same to be left on the premises) a notice setting forth the amount at which such property is valued, together with other particulars sufficient to describe such property; and every such notice shall be signed by the valuer.

36. The secretary and surveyor, and every other officer and servant, shall, whenever called on to do so, furnish official reports to the council. The collector shall furnish detailed monthly reports to the council of the rates paid during the preceding month.

37. The secretary shall have the custody of the common seal of the corporation, and shall be empowered to affix the same to any corporate document requiring such affixture; and also in case of powers of attorney and other legal documents not relating to the corporation, the signatures to which require to be verified before the president by declaration; and in any such case the said seal shall and may be affixed by the secretary to the president's certificate accompanying the same, on the receipt of a fee of 10s. 6d. for each attestation.

38. In all cases it shall be sufficient for the collector to call once for any sum due on the rate roll; and in the event of any such sum not being paid to him when he calls for it, he shall leave a notice bearing the date upon which he calls, demanding payment of such sum at the office of the council within fourteen days from the date of such notice, wherein shall be stated that in default of such payment legal proceedings for the recovery of such sum shall be taken. Every seven days all moneys received by the collector for rates shall be paid to the treasurer, and the collector shall take a receipt for the same.

39. Any officer or servant of the council who shall wilfully, by any act of omission or commission of any matter or thing appertaining to his duties, by which the council shall sustain any loss or damage, shall be liable to a penalty not exceeding £5.

40. No election to any office at the disposal of the council shall take place until fourteen clear days' notice shall have been given in some local newspaper, inviting applications for the same, nor until the salary or allowance attaching to such office shall have been fixed before proceeding to such election.

41. The shire surveyor shall be the custodian of all plans and specifications of works executed, and hereafter to be executed, under the orders of the council; and all such plans and specifications shall be the property of the council, and the shire surveyor shall be responsible for the safe custody of the same.

42. Any section or sections of this bye-law may be suspended *pro tem* in case of emergency, with the unanimous consent of the councillors present at any meeting, except the purport of such suspension be the rescinding of any motion previously adopted by the council.

BYE-LAW No. 2.—TO PROVIDE FOR THE EXAMINING, COMPARING, AND STAMPING WEIGHTS AND MEASURES, AND THE FEES TO BE PAID THEREON, WITHIN THE SHIRE OF AVOCA.

THE copies of the standard weights and measures shall be entrusted to the custody of the shire inspector for the time being, who shall give security to the council for the proper use and safe custody of the same, as also the due payment of all moneys received by him, and the surrender of the said weights, measures, and all other things the property of the corporation, when he may be required to do so.

The inspector shall attend at the Shire Office on the first and third Monday in every month, from Ten o'clock in the forenoon till Three o'clock in the afternoon, unless such day shall be appointed a public holiday, or that he may of necessity be absent, when he shall attend at the earliest possible date, a notice

of which shall be posted on the door of the council chamber, or such other building in which the council may have deposited the said authorised copies; and when the said inspector is so in attendance he shall examine, compare, and stamp, if necessary, all weights and measures which may be brought to him, and shall demand and take such fees for so doing as are mentioned in the schedule of this bye-law marked A.

The inspector shall travel through the shire once at least in every six months, at such specified times as may be directed by the council, notice of which shall be given by placards posted up in the localities to be visited, at least seven days before such visitation; and on such occasions the period of the inspector's stay having been published, he shall examine, compare, and stamp, if necessary, all weights and measures which he may be requested to do, and shall demand and receive such fees for so doing as are mentioned in the schedule of this bye-law marked B.

The inspector shall on or before the third day of each month make a return to the treasurer of the shire of all moneys received by him during the past month, showing the several particulars for which the same were received, the number of prosecutions under the Act, and how the same were disposed of. He shall also keep a diary of the whole of the transactions under this Act.

If any person shall refuse to pay the inspector the fees for examining, comparing, and stamping any weights and measures, after having requested him to do so, he shall be liable to a penalty of not more than Twenty shillings, in addition to the amount of fees, and which may be recovered before any two or more justices of the peace; and the inspector shall be at liberty to detain the said weights or measures until the fees shall have been paid.

3. That he shall travel through the district of the union, or to any place adjoining thereto, at specified times as he may be directed.


