RULES FOR MINING SURVEYORS IN THE BALLARAT MINING DISTRICT.

THE Governor, with the advice of the Executive Council, by Order made on the 3rd day of June, 1867, in exercise of the power conferred in the 47th section of *The Mining Statute 1855*, has made the following Rules for Regulating the Duties of Mining Surveyors in the matter of the Survey of Mining Tenements in the Mining District of Ballarat, under the Bye-laws of the Mining Board, and for prescribing the Fees to be charged by the Mining Surveyors for the Survey of such Tenements, viz.:-

1. Every mining surveyor shall be required to keep an office within the division to which he shall have been appointed, and shall keep such office open for the transaction of business not less than two hours during each day (Sundays and public holidays excepted), and the hours during which such office will be so kept open shall be notified by a notice legibly painted outside and in front of such office.

2. Upon receipt by the mining surveyor of a certificate of application for a mining tenement, signed by the mining registrar of the division in which such tenement is situated, the mining surveyor shall enter in a proper book, in the form of the schedule hereto numbered one, to be by him kept for that purpose, the particulars of such application, and each such entry shall be numbered in the order and dated of the day and hour on which the certificate was delivered to and received by him.

3. The mining surveyor shall endorse upon the certificate the date and hour on which it was delivered to him, and the number of the entry made as aforesaid in his book respecting it, and such certificate, so endorsed, shall, after survey of the tenement, be handed by him to the applicant or applicants for the tenement, or his or their agent.

4. At the time of the delivery to him of the certificate of application the mining surveyor shall appoint a time for making a survey of the tenement referred to in such certificate.

5. Every survey of a mining tenement shall be connected with some fixed point in the survey of some other mining tenement, or in some Government survey.

6. Within eighteen days from the date on which the certificate relating to any mining tenement other than a water-right shall have been delivered to him, the mining surveyor shall make survey of the tenement, and furnish to the applicant or applicants, or his or their agent, a plan and tracing of the tenement so surveyed, together with a report containing a full and accurate description of all the boundary and connecting lines, and stating clearly the nature, extent, and locality of such tenement, and whether such tenement will or will not, in his opinion, interfere with any other tenement, or with the rights of the holders of any other tenement; also stating the date of the survey and by whom made. In the case of alluvial claims, the extent in acres of the claim and the approximate depth of sinking shall be stated in the report, and every such plan and report shall be signed by the mining surveyor.

7. The depth of the lead shall mean the depth to which it shall be necessary to sink a shaft for the purpose of working or mining any auriferous deposit, or any alluvial deposit, earth, drift, or gutter containing or supposed to contain gold, within the claim, or the depth below the surface of the claim, at which the bed-rock immediately under the lead, gutter, deposit, or drift shall be found, or shall be known, or shall be supposed to exist; and when the depth of the lead shall not have been previously ascertained, it shall be by the mining surveyor computed from the most reliable data obtainable.

8. Within twelve days from the date on which the certificate of application for a water-right shall have been delivered to him, the mining surveyor shall make survey of the water-right referred to in such certificate, and shall furnish to the applicant or applicants, or to his or their agent, a plan and tracing of such water-right, together with a report containing a full and accurate description of the length and course of any race, tail-race, or channel referred to in such certificate; the source or sources from which the water is to be taken, diverted, or obtained, and the point to which it is to be conducted; the position, locality, and extent of any dam or reservoir in which water is to be stored; and stating clearly whether in his opinion such water-right will or will not interfere with any other water-right, or with the rights of the holders of any other water-right; and in the event of the water being diverted from any river, creek, or running stream, stating the point in such river, creek, or running stream at which it is to be diverted, the quantity (in sluice-heads) of water to be taken, and the order as to priority of such water-right in respect to any other water-right from the same source; and also stating the date of the survey, and by whom made; and every plan and report shall be signed by the mining surveyor.

9. Upon every plan of a mining tenement shall be clearly delineated all the boundary, connecting, and other lines that may have been surveyed, and the length and bearing of each such line distinctly marked thereon.

10. Each plan of a mining tenement other than a water-right shall be drawn to the following scale:-

If containing 2 acres and under ... 2 chains to an inch.

From 5 up to 20 acres ... 8 chains to an inch.

From 20 acres upwards ... 20 chains to an inch.

Each plan of a water-right shall be drawn to a scale of eight chains to an inch if delineating a race or channel not more than one mile in length, and to a scale of sixteen chains to an inch if beyond that length.

11. The mining surveyor shall keep locality plans of his division in his office, upon which shall be delineated in neutral tint the boundaries and dimensions of all mining tenements surveyed by him, such plans to be drawn to a scale of eight chains to an inch, and the tenements shall be plotted thereon within one month from the date of survey.

12. In the event of any mining tenement being forfeited by the holders thereof, the mining surveyor shall, on discovering the same, make a record of such forfeiture in the remark

column of his register-book, and neatly deface the boundary-lines of the tenement, thus



13. The mining surveyor shall be entitled to demand and receive as payment for the survey of mining tenements, fees in accordance with the scale in the schedule annexed; but no surveyor shall, under any circumstances, be entitled or permitted to demand or receive, in payment for the survey of any mining tenement, any fees other than or in excess of those prescribed in such scale.

6. If any error whatsoever be made to appear in the descrip-
