## POLLING-PLACES FOR ELECTORAL DISTRICTS.

*At the Executive Council Chamber, Melbourne, the ninth day of February 1880.*

PRESENT:

His Excellency the Governor.

IN pursuance of the provisions contained in the 73rd section of *The Electoral Act 1865*, His Excellency the Governor, with the advice of the Executive Council, doth by this present Order revoke the appointment of Kangaroo Flat (within the division) as a Polling-place for the Marong division of the Electoral District of Mandurang, of Tabilk as a Polling-place for the Avenel division and of North Wangaratta as a Polling-place for the Wangaratta division of the Electoral District of Moira, and of Barraport as a Polling-place for the Boort division of the Electoral District of Avoca, and with the advice aforesaid doth make the following appointments, viz. :—

*For the Electoral District of Avoca.*

LEAGHUR to be a Polling-place for the Kerang West division ;  
QUAMBATOOK and BARRAPORT to be Polling-places for the Glenloth division ;  
LLANELLY to be a Polling-place for the Newbridge division.

*For the Electoral District of North Gippsland.*

EAGLEHAWK to be a Polling-place for the Walhalla division ;  
STRADBROOK to be a Polling-place for the Sale division.

*For the Electoral District of South Gippsland.*

THE TARWIN RIVER, near Jagoe's, to be a Polling-place for the Alberton division.

*For the Electoral District of the Ovens.*

POREPUNKAH to be a Polling-place for the Bright division ;  
EVERTON to be a Polling-place for the Beechworth division ;  
HURDLE FLAT to be a Polling-place for the Stanley division.

*For the Electoral District of Kara Kara.*

MITCHELL'S HILL to be a Polling-place for the Korocubal division ;  
SUTHERLAND'S PLAINS to be a Polling-place for the St. Arnaud division.

*For the Electoral District of Portland.*

MYAMYN to be a Polling-place for the Heywood division.

*For the Electoral District of Stawell.*

THE COSMOPOLITAN REEF to be a Polling-place for the Pleasant Creek division.

And the Honorable Graham Berry, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.
