ROLLS OF RATEPAYING ELECTORS RECTIFIED.

At an Executive Council held at Government House, Melbourne, the thirtieth day of June 1880.

PRESENT :

His Excellency the Governor.

Mr. Cuthbert

Mr. Clark.

WHEREAS by *The Electoral Act 1885* it was amongst other things enacted that where any accidental or unavoidable impediment, misfeasance, or omission should have happened in the preparation or transmission or printing of any general roll or supplementary roll or ordinary electoral roll or roll of ratepaying electors, the Governor in Council might take all such measures as might be necessary for removing such impediment or rectifying such misfeasance or omission, or might declare any such roll valid as to and notwithstanding such impediment, misfeasance, or omission, and every such Order in Council should state specifically the nature of the impediment, misfeasance, or omission, and should be forthwith published in the *Government Gazette*: And whereas in the preparation of the Rolls of Ratepaying Electors, in November last, for the Swan Hill and Towaninny divisions of the Electoral District of Wimmera the names of the electors set forth in the subjoined Schedule were erroneously inserted in the Roll for the Swan Hill division instead of in the Roll for the Towaninny division of the said Electoral District: Now therefore the Governor, with the advice of the Executive Council, under and by virtue of the power in him vested by the 63th section of the said Act, doth by this present order direct that the Rolls of Ratepaying Electors for the Swan Hill and Towaninny divisions of the Electoral District of Wimmera be rectified by expunging the names contained in the subjoined Schedule from the Roll of Ratepaying Electors for the Swan Hill division and including the same in the Roll of Ratepaying Electors for the Towaninny division of the Electoral District of Wimmera aforesaid, and that the Rolls of Ratepaying Electors for the said Electoral divisions of Swan Hill and Towaninny be reprinted accordingly. And the Governor in Council doth hereby also declare valid the Rolls so rectified as aforesaid.
