COMMISSION ON SUPPLIES FOR RAILWAY DEPART. MENT WITHOUT PUBLIC COMPETITION.

THE Governor, with the advice of the Executive Council, has been pleased to appoint the undermentioned gentlemen, viz.:-

to constitute a Royal Commission to enquire into and report upon
the various works executed, and materials supplied to the Government, for which contracts or agreements were made or orders
given by the Victorian Railway Department with or to the firm
of Messrs. Bain and Son, or with or to other firms without advertising for tenders, and the price charged in each case for the work
done or article supplied, and the market value thereof; and also
the persons who are or were members of the firm of Messrs. Bain
and Son, or such other firms; also as to the nature of the various
mechanical appliances or machines which were called "patented"
or otherwise designed by and manufactured for or on behalf of
Mr. Ford, and supplied for the use of the Victorian Railways
during the time he occupied the position of "Engineer for Construction" in the Railway Department.

Also generally to enquire and report whether since the 1st day

Also generally to enquire and report whether since the 1st day of January 1878 considerable sums of money have been paid by the Railway Department to persons or firms for works and manufactured articles which were not let after either open or limited competition.

Ilmited competition.

The amounts, if any, which were originally claimed and finally paid in each case for such works or manufactured articles. The person or persons who ordered such works and his or their authority for doing so. The person or persons who inspected or carried out the work, either on behalf of the Government or the supplier, and certified to the day time, materials, &c., charged for. The persons or firms to whom orders to execute the works were given. The amounts paid for such works, and the person or persons who certified the accounts.

Whether the amounts so paid were fair and reasonable, in each case, for the work done, taking into account the special circumstances, if any, connected with the execution of such tracks.

Whether, when the amount paid in any case exceeded One hundred pounds sterling, there were special circumstances in such case to justify a departure from the rule of the Public Service against giving work to contractors, amounting in value to more than One hundred pounds sterling, without inviting tenders, and whether, when this rule was departed from, an Order in Council was obtained for doing so.

Whether such appeals discourate ages justified a departure from.

Whether such special circumstances justified a departure from the rule of the service to the extent to which the departure was carried.

And to extend the enquiry as to the practice of the Railway Department in similar matters over a period of two years ending in January 1878.
