PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency Sir Henry Brougham Loch, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the eighty-eighth section of The Public Service Act 1883, and in the fifth section of The Bank Holidays Act 1873, I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

Tuesday the 6th day of December instant *to be observed as a Public and Bank Holiday at St. James, Tungamah, and Yarrawonga;

THURSDAY THE 8TH DAY OF DECEMBER INSTANT to be observed as a Public and Bank Holiday within the Shire of Moorabbin;

SATURDAY THE 10TH DAY OF DECEMBER INSTANT to be observed as a Public and Bank Holiday at Birregurra and Winchelsea;

Wednesday the 14th day of December instant to be observed as a Bank Holiday within the Borough of Daylesford and the Shire of Creswick; and as a Public and Bank Half-Holiday at Hamilton,* from the hour of Twelve o'clock noon;

MONDAY THE 19TH AND TUESDAY THE 20TH DAYS OF DECEMBER INSTANT

to be observed as Public and Bank Half-Holidays at Sale, from the hour of Twelve o'clock noon on each day;

THURSDAY THE 29TH DAY OF DECEMBER INSTANT * to be observed as a Public and Bank Holiday at Birregurra and Winchelsea.

- That no person or persons shall employ in the said factory more than twelve females for more than fifty-six hours in any one week in preparing or manufacturing articles for trade or sale.
 That none of such females who are paid weekly wages shall be so employed without receiving overtime payment for the extra work they are called upon to perform.
 That none of such females shall be so employed for more than forty-eight hours in any one week without their consent.
 That a copy of this Order be kept conspicuously and continually posted in such factory for the information of all concerned.
