P R O C L A M A T I O N

By His Excellency Sir HENRY BROUGHAM LOCH, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

**I**N pursuance of the provisions contained in the eighty-eighth section of *The Public Service Act 1883*, and the fifth section of *The Bank Holidays Act 1873*, I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

THURSDAY THE 17TH DAY OF MARCH INSTANT

to be observed as a Public and Bank Holiday at Coleraine, Echuca, and Warrnambool, and within the Shires of Ballarat, Broadford, Creswick, East Loddon, Kowree, Pyalong, St. Arnaud, Winchelsea, and Yarrawonga; as a Bank Holiday at Scarsdale, and as a Public Half-Holiday within the Borough of Heathcote, from the hour of Twelve o'clock noon;

FRIDAY THE 18TH DAY OF MARCH INSTANT

to be observed as a Public and Bank Holiday within the Shires of Buln Buln and Warragul;

WEDNESDAY THE 23RD DAY OF MARCH INSTANT

to be observed as a Public and Bank Holiday at Ararat, Geelong, and Queenscliffe, and within the Shire of Kowree;

THURSDAY THE 24TH DAY OF MARCH INSTANT

to be observed as a Public and Bank Holiday within the Shire of Winchelsea;

FRIDAY THE 25TH DAY OF MARCH INSTANT

to be observed as a Public and Bank Holiday within the Shires of Buln Buln, Narracan, and Warragul;

TUESDAY THE 29TH AND WEDNESDAY THE 30TH DAYS OF MARCH INSTANT

to be observed as Public and Bank Half-Holidays at Casterton, Merino, Sandford, and Tallangatta, from the hour of Twelve o'clock noon on each day;

WEDNESDAY THE 30TH DAY OF MARCH INSTANT

to be observed as a Public and Bank Holiday at Carisbrook, and within the Shire of Alberton and the Borough of Maryborough;

FRIDAY THE 1ST DAY OF APRIL NEXT

to be observed as a Public and Bank Holiday at Violet Town;

THURSDAY THE 7TH DAY OF APRIL NEXT

to be observed as a Public and Bank Holiday within the Shire of Narracan.

Given under my Hand and the Seal of the Colony, at Melbourne, this fifteenth day of March, in the year of our Lord One thousand eight hundred and eighty-seven, and in the fiftieth year of Her Majesty's reign.

WHEREAS by *The Licensing Act 1885* it was enacted that the Governor in Council might, upon the receipt of any petition or petitions, in accordance with section 22 of the said Act, by an Order in Council direct the Returning Officer for the Electoral Division forming such Licensing District to take a Poll of the Electors upon a day to be fixed in the said Order in Council for that purpose: And whereas petitions have been received by the Governor in Council, in accordance with the provisions of the said Act, from one-fifth of the number of persons whose names are on the Rolls of Electors for the Electoral Divisions forming the Licensing Districts hereunder specified for a Poll of the Electors to be taken to determine whether or not the number of Victuallers' Licenses in such Licensing Districts should be decreased: And whereas the number of Victuallers' Licenses in the subjoined Licensing Districts is in excess of the statutory number: Now therefore His Excellency the Governor, with the advice of the Executive Council, under and by virtue of the power and authority in him vested by the said Act, doth hereby direct the Returning Officers for the Electoral Districts to take, on the days and dates specified hereunder, a Poll of the Electors to determine whether or not the number of Victuallers licensed shall be decreased in the districts hereinafter mentioned, viz. :—
