PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency Sir HENRY BROUGHAM LOCH, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the eighty-eighth section of *The Public Service Act 1883*, and in the fifth section of *The Bank Holidays Act 1873*, I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

- THURSDAY THE 1ST DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday at Charlton and within the Shire of Dunmunkle ;
- FRIDAY THE 2ND DAY OF SEPTEMBER NEXT
to be observed as a Public Holiday at Borung, and also as a Public and Bank Holiday at Korong Vale ;
- TUESDAY THE 6TH DAY OF SEPTEMBER NEXT
to be observed as a Public Holiday within the North Riding of the Shire of Benalla ;
- WEDNESDAY THE 7TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday within the Borough of Stawell ;
- THURSDAY THE 8TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday within the Borough of Stawell and within the Shire of Lowan ;
- FRIDAY THE 9TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday at Ballarat and Violet Town, within the Boroughs of Inglewood and Wangaratta, within the Shire of Oxley, and within the North and Central Ridings of the Shire of Korong ; to be observed also as a Bank Holiday within the Shire of Creswick, and as a Public Holiday within the Shire of North Ovens ;
- TUESDAY THE 13TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday within the Shires of Dunmunkle and Lowan, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Coleraine ;
- FRIDAY THE 16TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday within the Shire of Dunmunkle ;
- WEDNESDAY THE 21ST DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday at Warracknabeal, within the Borough of Inglewood, within the Shires of Dunmunkle and Lowan, and within the South Riding of the Shire of Korong ;
- FRIDAY THE 23RD DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday at Charlton and within the Shire of Dunmunkle ; as a Bank Holiday, and as a Public Half-Holiday, from the hour of Twelve o'clock noon, at Echuca ;
- WEDNESDAY THE 28TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday at Korong Vale, within the Borough of Inglewood, and within the North Riding of the Shire of Korong ;
- FRIDAY THE 30TH DAY OF SEPTEMBER NEXT
to be observed as a Public and Bank Holiday within the Shire of Dunmunkle.

Given under my Hand and the Seal of the Colony, at Melbourne, this twenty-ninth day of August, in the year of our Lord One thousand eight hundred and eighty-seven, and in the fifty-first year of Her Majesty's reign.

SMALL-POX.—INSPECTION OF VESSELS AT THE QUARANTINE STATION ARRIVING FROM NEW SOUTH WALES, QUEENSLAND, OR THE NORTHERN TERRITORY OF SOUTH AUSTRALIA WITH TRANSHIPPED PASSENGERS FROM HONG KONG, SINGAPORE, THE EASTERN PORTS GENERALLY, AND PORT DARWIN IN THE NORTHERN TERRITORY OF SOUTH AUSTRALIA.

At the Executive Council Chamber, Melbourne, the twenty-ninth day of August 1887.

WHEREAS by *The Public Health Statute 1865* (28 Victoria No. 264, Sec. 90) it is amongst other things enacted that the Governor in Council may make such orders as may be deemed expedient, upon any unforeseen emergency, with respect to any vessel arriving in Victoria under any alarming or suspicious circumstances as to infection or contagion, and also with respect to the persons and things on board the same: And whereas the contagious disease known as Small-pox exists at Hong Kong, Singapore, the Eastern Ports generally, and at Port Darwin in the Northern Territory of South Australia: And whereas it is expedient to make an Order to prevent, as far as possible, the spread of such contagious disease in Victoria: Now therefore I, the Governor, with the advice of the Executive Council, do by this Order direct that, from and after the date hereof, any vessel entering Port Phillip Bay, bringing any passengers to Victoria who have reached Sydney or Brisbane, or any port of New South Wales or Queensland, within fifteen days previously, from Hong Kong, Singapore, or any port in the Chinese Seas or in the Northern Territory of South Australia, may be inspected by the Health Officer at the Quarantine Station, near the Heads of the said Bay, and may be detained for a reasonable time to permit of such inspection and all needful fumigation and disinfection of persons and things on board any of such vessels; and all persons found on board or who may have been on board any of such vessels who may have arrived from any of the ports aforesaid shall and may be detained at the said Quarantine Station or any other convenient place for inspection and care for a period not exceeding fourteen clear days from the date of leaving any of the ports aforesaid; and that the clothing, bedding, bunks, or other articles of clothing or furniture used by any such person or persons may, in the discretion of the said Health Officer, be disinfected or destroyed.

And the Honorable Alfred Deakin, Her Majesty's Chief Secretary for Victoria, shall give the necessary directions herein accordingly.

MALICIOUS FIRE AT McLEOD'S FLAT, NEAR BACCHUS MARSH.

FIFTY POUNDS REWARD.

WHEREAS during the night of Saturday the 6th August instant, at McLeod's Flat, near Bacchus Marsh, a stack, containing twenty tons of wheat hay, valued at Seventy pounds, the property of Mr. Michael O'Connell, was deliberately set on fire: And whereas the owner of the said stack has offered a reward of Twenty-five pounds for such information as will lead to the apprehension and conviction of the person or persons by whom the fire was wilfully caused: Notice is hereby given that a reward of Twenty-five pounds (supplemental to that offered by Mr. O'Connell) will be paid by the Government for such information as will lead to the conviction of the person or persons who caused the fire aforesaid.
