"THE FEDERAL COUNCIL OF AUSTRALASIA ACT 1885."—ACT ASSENTED TO.

PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

WHEREAS by an Act of the Imperial Parliament of the 48th and 49th Vict. Ch. 60, intituled *An Act to constitute a Federal Council of Australasia*, it was enacted that every Act assented to in the first instance should be proclaimed in the *Government Gazette* of the Colony in which the Session of the Council at which it was passed was held, and should also be transmitted by the Governor assenting thereto to the Governors of the several Colonies affected thereby, and should be proclaimed by them within the respective Colonies of which they are Governors: And whereas the Bill, as set forth hereunder, passed in the Fourth Session of the Federal Council, held at Hobart, in the Colony of Tasmania, has been assented to and proclaimed in the *Hobart Gazette*, bearing date the twenty-ninth day of January, One thousand eight hundred and ninety-one, by His Excellency the Governor of Tasmania, and transmitted by him to me in accordance with the provisions of the hereinbefore in part recited Act: Now therefore I, the Governor of Victoria, do hereby proclaim the said Act so passed and assented to as aforesaid, that is to say:—

No. 1. "An Act to facilitate the Recognition in other Colonies of Orders and Declarations of the Supreme Court of any Colony in matters of Lunacy." (23rd January, 1891.)

ANNO QUINQUAGESIMO QUARTO VICTORIÆ REGINÆ.—No. 1.

An Act to facilitate the Recognition in other Colonies of Orders and Declarations of the Supreme Court of any Colony A.D. 1891.  
in matters of Lunacy. [23rd January, 1891.]

WHEREAS the Legislatures of the Colonies of Victoria, Queensland, Tasmania, and Western Australia have, pursuant Preamble. to the provisions of an Act of the Imperial Parliament, intituled "An Act to constitute a Federal Council of 48 and 49 Vict. Australasia," referred to the Federal Council the matter relating to the recognition in other Colonies of Orders and ch. 60. Declarations of the Supreme Court of any Colony in matters of Lunacy, for the exercise of Legislative authority thereon:

Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Federal Council of Australasia, assembled at Hobart, in the Colony of Tasmania, and by the authority of the same, as follows:—

1. This Act may be cited as *The Australasian Orders in Lunacy Act 1891*.

Short title.

2. In this Act—

"Registrar" shall mean and include the Prothonotary, Chief Clerk, Registrar, or other officer having Interpretation, authority to affix the Seal of the Supreme Court of any Colony.

Order or Declaration in Lunacy shall be produced to and a copy thereof deposited with the Registrar of the Supreme Court of any other Colony, such Order or Declaration shall be sealed with the Seal of the last-mentioned Court, and shall have the like force and effect and have the same operation in such other Colony, and every Master, Guardian, Committee, and Receiver acting thereunder shall perform the same duties and be subject to the same liabilities in such other Colony as if such Order or Declaration had been originally made by such last-mentioned Court.

Provided that a Guardian, Committee, or Receiver appointed under any such Order shall not have or exercise any power or authority in any Colony other than that in which the Order or Declaration was made, until his appointment has been confirmed by the Supreme Court of the Colony in which the power or authority is proposed to be exercised, or a Judge thereof, which confirmation may be granted upon such terms as to the Court or Judge may seem fit, or may be refused.

4. No such Order or Declaration shall be sealed as aforesaid until all such stamp duty and other fees, if any, have been paid, and such certificate of payment, if any, has been produced as would have been payable or required respectively if such Order or Declaration had been originally made by the Supreme Court the Seal whereof is sought to be affixed.

In the name and on behalf of Her Majesty the Queen, I assent to this Act.

IN pursuance of the provisions contained in the *Public Service Act 1890* (54 Vict. No. 1133, Part VI., section 135) and in the *Banks and Currency Act 1890* (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint

WEDNESDAY, THE 18TH DAY OF FEBRUARY INSTANT,  
to be observed as a Public Holiday within the Shire of Healesville, and as a Bank Holiday at Queenscliff and Seymour;

FRIDAY, THE 20TH DAY OF FEBRUARY INSTANT,  
to be observed as a Bank Holiday at Cobram and Nhill;

TUESDAY, THE 24TH DAY OF FEBRUARY INSTANT,  
to be observed as Public Holiday within the Shires of Lancefield and Romsey, and as a Bank Holiday at Romsey;

WEDNESDAY, THE 25TH DAY OF FEBRUARY INSTANT,  
to be observed as a Public Holiday within the Boroughs of Rutherglen and Talbot\*, within the Shire of Maldon, as a Public Half-Holiday (from the hour of Twelve o'clock noon) within the Shire of Rutherglen, and as a Bank Holiday at Chewton, Echuca, Talbot, and within the Borough of Rutherglen;

THURSDAY, THE 26TH DAY OF FEBRUARY INSTANT,  
to be observed as a Public Holiday within the Shire of Ballan and within the Central and Eastern Ridings of the Shire of Waranga, and as a Bank Holiday at Ballan, Blackwood, Egerton, Gordon, Katamatite, and Murchison;

TUESDAY, THE 3RD, AND FRIDAY, THE 6TH DAYS OF MARCH NEXT,  
to be observed as Bank Holidays at Corryong;

TUESDAY, THE 10TH, AND THURSDAY, THE 12TH DAYS OF MARCH NEXT,  
to be observed as Bank Holidays at Lancefield;

WEDNESDAY, THE 11TH DAY OF MARCH NEXT,  
to be observed as a Public Holiday within the Borough of Maryborough and the Shire of Tullaroop, and as a Bank Holiday at Maryborough and Natimuk;

THURSDAY, THE 12TH DAY OF MARCH NEXT,  
to be observed as a Public Holiday within the Shire of Romsey;

FRIDAY, THE 13TH DAY OF MARCH NEXT,  
to be observed as a Public Holiday and Bank Holiday at Beechworth;

to be observed as a Bank Holiday at Bacchus Marsh, Benalla, Birregurra, and Heathcote;

to be observed as a Bank Holiday at Traralgon;

SATURDAY, THE 21ST DAY OF MARCH NEXT,  
to be observed as a Public Holiday and Bank Holiday within the Shire of Bright.
