### PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

\*\*WHEREAS\*\* by the Constitution Statute it was amongst other things enacted that the provisions of the Act of the fourteenth year of Her Majesty, chapter fity-nine, and of the Act of the fifth and sixth years of Her Majesty, chapter seventy-six, assent to Bills, and the reservation of Bills for the signification of Her Majesty's pleasure thereon, and the instructions to be concapply to Bills to be passed by the Legislative Council and Assembly constituted under the Constitution Act of Victoria and the now reciting Statute, and by any other legislative body or bodies which may at any time hereafter be substituted for the present Legislative Council and Assembly: And whereas the Bill hereinafter mentioned was reserved for the signification of Her Majesty's pleasure thereon: And whereas the Bill hereinafter mentioned was reserved for the signification of Her Majesty's pleasure thereon: And whereas by an Order of the Queen in Council made on the twentieth day of March, One Majesty's pleasure thereon are a copy whereof is hereto appended, Her Majesty has been pleased to assent to the said Bill: Now therefore I, the Governor of Victoria, in pursuance of the provisions of the aforesaid Acts, do by this my Proclamation signify that the Bill intituled

"An Act to Amend the Law relating to Marriage,"

"AN ACT TO AMEND THE LAW RELATING TO MARRIAGE,"

which was reserved for the signification of Her Majesty's pleasure thereon upon the twentieth day of December, in the year One thousand eight hundred and ninety, has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same.

Whereas by an Act passed in the fifth and sixth years of Her Majesty's reign, entitled An Act for the Government of New South Wales and Van Diemen's Land, it is amongst other things enacted that no Bill which shall be reserved for the signification of Her Majesty pleasure thereon shall have any force or authority within the Colony of New South Wales until the Governor of the said Colony shall signify, either by speech or message to the Legislative Council of the said Colony on Proclamation as therein aforesaid, that such Bill has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same:

And whereas by another Act passed in the thirteenth and fourteenth years of Her Majesty's reign, entitled An Act for the better Government of Her Majesty's Australian Colonies, it was provided, among other things, that the provisions of the said former Act concerning the reservation of Bills for the signification of Her Majesty's pleasure thereon should apply to and be in force in the Colony of Victoria:

And whereas the said provisions were maintained in force, as regards Bills passed by the Legislative Council and Legislative Assembly of the said Colony, by a subsequent Act passed in the eighteenth and nineteenth years of the reign of Her said Majesty, for the Colony of Victoria, to establish a Constitution in and for the Colony of Victoria:

And whereas on the twentieth of December last, the Governor of the said Colony of Victoria reserved a certain Bill, passed by the Legislative Council and Legislative Assembly of the said Colony, entitled An Act to amend the Law relating to Marriage, for the signification of Her Majesty's pleasure thereon:

And whereas the said Bill so reserved as aforesaid has been laid before Her Majesty in Council, and it is expedient that the said Bill should be assented to by Her Majesty:

Now therefore Her Majesty, in pursuance of the said Acts, and in exercise of the powers thereby reserved to Her Majesty as aforesaid, doth by this present Order, by and with the advice of Her Majesty's Privy Council, declare Her assent of the said Bill.

FURTHER PROROGUING PARLIAMENT AND FIXING THE TIME FOR HOLDING THE THIRD SESSION OF THE FOURTEENTH PARLIAMENT.

#### PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

WHEREAS by The Constitution Act it was amongst other things enacted that it should be lawful for the Governor to fix such places within Victoria and, subject to the limitation therein contained, such times for holding the first and every other Session of the Council and Assembly, and to vary and alter the same respectively in such manner as he might think fit; and also from time to time to prorogue the said Council and Assembly, and to dissolve the said Assembly, by Proclamation or otherwise, whonever he should deem it expedient: And whereas the said Council and Assembly, called "The Parliament of Victoria," stand prorogued until Saturday, the thirtieth day of May instant, and it is expedient further to prorogue the same, and to fix the time for holding the next Session thereof: Now therefore I, the Governor of Victoria, in exercise of the power conferred by the said Act, do by this my Proclamation further prorogue the said Prilament of Victoria from Saturday, the thritieth day of June aforesaid, as the time for the commencement and holding of the next Session of the said Council and Assembly, called the Parliament of Victoria, for the despatch of business, at the hour of Two o'clock in the afternoon, in the Parliament Houses, situate in Parliament-place, Spring-street, in the City of Melbourne: And the Honorable the Members of the Legislative Assembly are hereby required to give their attendance at the said time and place accordingly.
